Subject: Evaluating Schemes

Since last few years, the Mahatma Gandhi State Institute of Public Administration (MGSIPA), Punjab, Chandigarh has developed a team of dedicated faculty and consultants on its roll, for carrying out research, consultancy and evaluation studies. Apart from the faculty, the institute has a pool of resource persons consisting of eminent persons, serving and retired officers of the Government, technical experts and academicians of national repute. MGSIPA has developed appropriate capacity to evaluate government policies, programmes and schemes.

2. It is understood that various Ministries and Departments of Government of India and various agencies functioning therein are implementing a series of programmes, schemes and public policies. An important aspect of all these activities is a robust system of concurrent as well as end-programme evaluation of such policies, programmes and schemes so that suitable corrective steps could be undertaken during the implementation phase and/or in subsequent modifications.

3. MGSIPA is consistently undertaking evaluation of projects and programmes. Recently, it has also been assigned the evaluation of the implementation of the Punjab Right to Services Act, 2011 by DAR&PG, GOI. Ministry of Home affairs through BPR&D has asked MGSIPA to prepare Pre-Promotional Training Modules for all the police personnel (Head Constable to DSP) of all the States.
