Subject: Implementation of 7th Central Pay Commission - Revision of Pension of Pre-1.1.2016 Pensioner/Family Pensioners etc in pursuance to DP&PW OM 38/37/2016-P&PW(A) dated 12th May 2017 and 6th July 2017 and Ministry of Finance (Deptt.of Expenditure) OM No.1(13)/EV/2017 dated 23rd May, 2017 and CPAO's OM dated 06.06.2017 - regarding.

Sir,

Reference is invited to the above OMs regarding revision of pension of pre-2016 pensioners/family pensioners under 7th CPC with effect from 01.01.2016 in respect of Central Civil Pensioners / family pensioners who retired/died prior to 01.01.2016 by notionally fixation their pay in the pay matrix recommended by the 7th CPC in the level corresponding to the pay in the pay scale / pay band and grade pay at which they retired / died. In this regard, Central Pension Accounting Office (CPAO) has provided the relevant data/cases of live pensioners (total number of 7560 pensioners/family pensioners) pertaining to Central Water Commission (CWC) and same data (Hard copy as well as soft copy) has been forwarded to E-IV Section, CWC for further necessary action as per the prescribed procedure/instructions contained in above OMs.

For settlement of expeditious revisions of pension cases, requesting you to issue necessary instructions at your level to all concerned Head of Offices/Division/DDO to take action to revise the pension cases of retirees who had worked under their administrative control, based on the orders mentioned above after due verification of their relevant records and submit to PAO(CWC) on priority basis for issuing the revise pension authority as per 7th CPC. Secondly, flash the news at CWC portal for pensioner/family pensioner to submit their additional information i.e. (i) Adhaar No (ii) PAN No. (iii) Phone No (iv) Email ID to concerned Head of Offices/Division/DDO for incorporating these information in revision of pension case/authority.
