I am directed to say that for the purpose of securing compliance with the implementation of the decisions and directions of the Narmada Water Disputes Tribunal (NWDT), the Government of India have, inter-alia, established Narmada Control Authority (NCA) with an autonomous entity under this Ministry. The NCA is presently functioning with headquarters at Indore.

2. The post of Executive Member in NCA has fallen vacant consequent on the completion of tenure of its present incumbent. The post of Executive Member in the NCA carries the pay scale of Rs. 67000 – 79000. It is proposed to fill up this post by appointment on deputation (including short term contract) on foreign service from amongst officers working under the Central Government/ State Governments/ Union Territory Administrations/Recognized Research -Institutions/Semi Government/ Autonomous/ Statutory Organizations, other than the participating States of Gujarat, Madhya Pradesh, Maharashtra and Rajasthan, and fulfilling the eligibility criteria as given at Annexure-I. The job description and duties of the post of Executive Member in NCA is given at Annexure-II.

3. The selected officer will be treated as deputation on foreign service and his pay will be regulated in accordance with the provisions incorporated in the Department of Personnel and Training O.Ms. No.6/8/2009-Estt. (Pay-II) dated 17.6.2010 and 1st March, 2011 as amended from time to time, or any subsequent order which may be issued by the Government in this regard.

As per Narmada Water Scheme, each independent Member of NCA shall be a full time Member and be appointed for a term not exceeding five years.

ANNEXURE-I

ELIGIBILITY CRITERIA FOR APPOINTMENT TO THE POST OF EXECUTIVE MEMBER IN NARMADA CONTROL AUTHORITY, INDORE ON DEPUTATION BASIS

Officers under the Central/ State Governments/ Union Territories/ Recognized Research Institutions/ Semi Government/ Autonomous/ Statutory Organizations including officers of Narmada Control Authority:-

- a) i) holding equivalent post (Higher Administrative Grade) on a regular basis in the parent cadre/ department; OR
- ii) holding post of Chief Engineer or equivalent post (Senior Administrative Grade) in the Pay Band (PB-4) of Rs.37400-67000 and Grade Pay of Rs.10,000/- (or equivalent) with minimum 3 years of regular service in the parent cadre/department; OR
- iii) Officers with minimum of 25 years of regular service in Group 'A' posts or equivalent posts in the service out of which at least 1 year regular service should be in the Senior Administrative Grade, i.e., Chief Engineer or equivalent post in the Pay Band (PB-4) of Rs.37400-67000 and Grade Pay of Rs.10,000/- (or equivalent) in the parent cadre/department;

AND

- b) The officer should possess the following qualifications and experiences :-

Essential

- i) Degree in Civil/Electrical/Mechanical Engineering or equivalent from a recognized University.
- ii) The officer should have minimum of overall experience of 5 years in planning, formulation/execution of large, major and multipurpose river valley projects in the irrigation/power sector and also adequate administrative acumen.

Desirable

Experience in dealing with Inter-State issues.

Note 1: The appointment by deputation (including short term contract) would be for a tenure not exceeding five years or till the date of retirement on superannuation, whichever is earlier.

Provided that, in case of appointment on Deputation, the date of superannuation will be as applicable in the lending organization.

Note 2: The period of deputation (including short term contract) including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/ department of the Central Government shall ordinarily not exceed 5 years. The maximum age limit for appointment by deputation (including short term contract) shall not exceed 58 years as on the closing date of receipt of application.

Note 3: The officer should be from other than the beneficiary States, viz., Gujarat, Maharashtra, Madhya Pradesh and Rajasthan.

Note 4: Officers of the rank Chief Engineer or equivalent post (Senior Administrative Grade) in the Pay Band (PB-4) of Rs.37400-67000 and Grade Pay of Rs.10,000/- (or equivalent) with minimum 3 years of regular service OR with minimum of 25 years of regular service in Group 'A' posts or equivalent posts out of which at least 1 year regular service should be in the Senior Administrative Grade, i.e., Chief Engineer or equivalent post in the Pay Band (PB-4) of Rs.37400-67000 and Grade Pay of Rs.10,000/- (or equivalent) and possessing the above mentioned qualifications and experience in the NCA shall be considered for appointment to the post of Executive Member in NCA and in case found fit, the post shall be deemed to have been filled up by promotion.

Note 5: For the purpose of computing minimum qualifying service for promotion, the service rendered on a regular basis by an officer prior to 1.1.2006/the date from which the revised pay structure based on the 6th CPC recommendations has been extended, shall be deemed to be service rendered in the corresponding grade pay/pay scale extended based on the recommendations of the Commission. For purposes of appointment on deputation/absorption basis, the service rendered on a regular basis by an officer prior to 1.1.2006/ the date from which the revised pay structure based on the 6th CPC recommendations has been extended, shall be deemed to be service rendered in the corresponding grade pay/pay scale extended based on the recommendations of the Commission except where there has been merger of more than one pre-revised scale of pay into one grade with a common grade pay/pay scale, and where this benefit will extend only for the post(s) for which that grade pay/pay scale is the normal replacement grade without any upgradation.

Annexure-II

Job description and duties of the post of Executive Member in Narmada Control Authority (NCA)

Executive Member, NCA is one of the four full time independent Member of the NCA constituted under section 6A of Inter State Water Disputes Act to implement the decisions of Narmada Water Disputes Tribunal (NWDT). He is the Head of Department for the Secretariat of the NCA. He is assisted by other three independent Members, viz. Member (Civil), Member (Environment & Rehabilitation), Member (Power) and also by Secretary, NCA for conducting the affairs of NCA as per decisions of NWDT award, directions of Hon'ble Supreme Court & High Courts and directions of Central Government, etc. He is overall in-charge of the administrative works of the NCA under the general supervision and control of Chairman, NCA, and Secretary to the Government of India, Ministry of Water Resources. He is the Chairman of the Hydromet Sub-Group of NCA which is responsible for Hydrometeorological data network, Chairman of Narmada Main Canal Sub Committee, which is responsible for the phasing and co-ordination of construction of Sardar Sarovar Canals and Chairman of Sardar Sarovar Reservoir Regulation Committee of NCA, which is responsible for preparing the working table for the operation of Sardar Sarovar Reservoir and ensuring regulated release of water by Madhya Pradesh. He also heads the Permanent Standing Committee of Sardar Sarovar Construction Advisory Committee. He is the Member of Resettlement and Rehabilitation Sub-Group and Environment Sub-Group of NCA and also a Member of Sardar Sarovar Construction Advisory Committee.


