**OFFICE ORDER**

On the recommendation of the Screening Committee for upgradation under the Scheme of "Modified Assured Career Progression Scheme" the Chairman, Central Water Commission has been pleased to grant IInd financial upgradation under MACPS in PB-2 of Rs. 9300-34,800/- with the grade pay of Rs. 4,800/- to the Assistant Director-II/Sub Divisional Engineers of Central Water Commission as per Annexure-I and IIIrd financial upgradation under MACPS in PB-3 of 15,600 – 39,100/- with the grade pay of Rs. 6,600/- to the Assistant Director-II/Sub Divisional Engineers of Central Water Commission as per Annexure-II, in terms of DOPT OM No. 35034/3/2008-Estt.(D), dated 19.5.2009.

2. The above upgradation is further subject to the following conditions and in terms of DOPT OM No.35034/3/2008-Estt.(D), dated 19.5.2009: -

- i) His/Her pay in the higher grade shall be fixed under the provision of FR 22(1)(a)(1) to get his pay fixed in the higher post/grade pay either from the date of his promotion/upgradation or from the date of his next increment viz., 1<sup>st</sup> July of the year. The pay and the date of increment would be fixed in accordance with clarification No.2 of Department of Expenditure's OM No.1/1/2008-IC, dated 13.9.2008 and there shall be no further fixation of pay, at the time of regular promotion if it is in the same grade pay as granted under MACP Scheme.
- ii) He/She is also entitled to exercise option for choosing date of fixation within one month from the date of issue of this order, as per rules.
- iii) There shall not be any change of designation on the upgradation and the incumbent shall retain his/her old designation.
- iv) The financial upgradation shall not confer any privileges related to higher status and he/she continue to be governed by status of the post, which he/she is now holding.
- v) The above upgradation shall not have any relevance to the seniority position, which shall remain as in the post, which he/she is now holding.
- vi) The individual while accepting the above up-gradation shall be deemed to have his/her unqualified acceptance for regular promotion on occurrence of vacancy subsequently. In case, he/she refuses to accept the higher post on regular promotion subsequently, he/she shall be subject to normal debarment for regular promotion as prescribed in the general instructions in this regard.
- vii) The financial upgradation is subject to audit verification and recovery, if any, at any stage.


