- ii) With 5 years' regular service in posts in the scale of Rs. 15600-39100 with Grade pay of Rs. 5400 (PB-3) or equivalent, or
- iii) With 6 years' regular service in posts in the scale of Rs. 9300-34800 with Grade pay of Rs. 4800 (PB-2) or equivalent, or
- iv) With 8 years' regular service in posts in the scale of Rs. 9300-34800 with Grade pay of Rs. 4600 (PB-2) or equivalent; and
- b) Possessing the following educational and other qualifications:-
- Degree in Electronics/Electrical Engineering with Radio Communication as a special subject/Degree in Telecommunication Engineering of a recognised University or equivalent.
- 5 years experience in design, installation, operation and maintenance of various telemetring equipment.

Desirable:

Knowledge and experience of satellite communication system including familiarity with Sensors.

Note 1: Qualifications are relaxable at the discretion of the Union Public Service Commission in case of candidates otherwise well qualified.

Note 2: The qualifications(s) regarding experience is/are relaxable at the discretion of the Union Public Service Commission in case of candidates belonging to Scheduled Caste and Scheduled Tribes, if at any stage of selection, the Union Public Service Commission is of the opinion that sufficient number of candidates from these communities possessing the requisite experience are not likely to be available to fill up the posts reserved for them.

Note 3: The Departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation (including short termo contract). Similarly deputationists will not be eiligble for consideration for appointment by promotion.

- Period of deputation (including short term contract) including period of deputation in another ex-cadre post held immediately preceding this the same or some other organization/department of the appointment in Government shall ordinarily not exceed 4 years. The maximum appointment on deputation (including short term contract) shall be not exceeding 56 years as on the closing date for receipt of applications).
- The pay of the officers selected will be regularized in accordance with the DOPT 3. OM No.2/29/91-Estt.(Pay-II) dated 05.01.1994 as amended from time to time.
- It is requested that application in duplicate in the enclosed prescribed Proforma alongwith:-
 - Complete upto date APAR Dossier.
 - ii) Vigilance Clearance Certificate.
 - No Penalty Statement and Integrity Certificate in respect of interested and iii) eligible officers, who can be spared immediately in the event of their selection, may be forwarded to this Commission within 60 days from the date of issue of this Circular. It may not be possible to consider the applications received after the prescribed time limit or otherwise found incomplete.
