**Office Order**

**Subject:** Exercise of powers in respect of contingent expenditure under Schedule - V of DFPR 1978

In continuation to CWC office order no. 4/2/2009-O&M/621 dated 12<sup>th</sup> October 2010 and office order no. 4/2/2009-O&M/654 dated 29<sup>th</sup> October 2010 vide which powers in respect of contingent expenditure under Schedule - V of DFPR 1978 were authorised to various officers of CWC; Chairman, CWC in exercise of powers vested in him as HoD under Rule 13(3) of Delegation of Financial Powers Rules 1978; further authorises Secretary, CWC; Director (Admn.), Director (PCP) and Director (Training) financial powers upto ₹ 50,000/- in each case in respect of non recurring contingent expenditure for the works being dealt in their units.


