CIRCULAR

Subject: Nomination of officers/staff for training comises to be conducted by NWA, CWC, Pune and other offices of CWC.

With the approval of the Chairman, CWC, it has been decided that

- 1. All field Chief Engineers may send the nomination(s) of officers/staff of their organiations for the training courses to be organized by NWA, CWC, Pune directly to NWA, CWC, Pune. The nominations of the field Chief Engineers for any training course have however to be approved by the concerned Member.
- 2. For the officers/ staff posted at CWC Headquarters, the nominations as approved by the Member concerned in respect of the wings will be communicated to NWA by the concerned coordination directorate under intimation to Director (Training). In case of officers/staff of HRM organisation, nominations as approved by Chief Engineer (HRM) will be communicated to NWA by Director (Training).
- Traning Dte with the approval of Chairman, CWC, prepares a training calendar every year, for the programmes to be organized by CWC, for which different course coordinators are nominated. Field Chief Enginers may send the nominations of the officers/staff under their control directly to the course coordinator under intimation to the Director (Training).
- Field Chief Engineers may continue to approve the nominations for the training courses of Central Water Commission under their jurisdiction.
- 5. Final list of the participants to any training/course conducted at NWA, Pune/field offices should invariably be sent by the Chief Engineer, NWA/course coordinators to Director (Training) for record etc.
- Above guidelines will not be applicable in case of Induction Training programmes for newly recruited and newly promoted ADs, Mid Career Programmes and Orientation Programmes for newly promoted Assistant Directors-IIs. In these cases, nominations will be made by the Headquarter itself.
- 7. This supersedes the CWC circular No. 13/4/2007-Trg/3608 dt. 10.09.2007.
