NOTICE

Subject: 46th Departmental Examination for Engineering Officers of Central Water Commission.

1. It is proposed to hold the 46th Departmental Examination for Engineering Officers of the Central Water Commission sometime in the month of October, 2011. The Centre for the examination will be New Delhi but if sufficient number of candidates are available, the examination may be held at other Centres also, such as Hyderabad / Bangalore / Nagpur / Shillong / NWA, Pune etc. Candidates may, therefore, give their option for the centre nearest to their working place in the application form. The same would be considered, however, the centres could be changed by the Commission depending upon centres finally selected. The venue and dates of examination will be intimated in due course.

2. As per the Central Water Engineering (Group-A) Service Rules, officers in the grade of Assistant Director/Assistant Executive Engineer are not eligible for promotion to the grade of Deputy Director/EE unless they pass the examination within four years of their regular appointment to the grade of AD/AEE and in not more than four chances.

3. In case officers in the grade of AD/AEE could not qualify in the Departmental Examination within the prescribed period of four years and in not more than four chances, **they would no longer be eligible to appear at this or in any subsequent departmental examination. Such officers will have to apply, separately for extension of time through proper channel.** In case extension of time is sought on the ground of exigencies of service, the Director/SE concerned shall recommend the same. In case extension of time is sought on medical grounds, it should be supported by a proper Medical certificate.

4. As the Departmental Examination is obligatory for officers in the grade of Assistant Director/AEE, they will be entitled to draw TA/DA under SR 130 and their absence from duty will be regulated under provisions of the Government of India Order No. 5 below FR9(6)(b).


5. Officers in the grade of EAD/AE are also eligible to appear in the Departmental examination. If they pass the examination they will not be required to pass the same after promotion to the grade of AD/AEE. The limitation of four years will not, however, apply in their case so long they serve in the grade of EAD/AE.

6. The officers have the option to write answers in English or in Hindi.

7. Application for admission to the Examination in the prescribed Performa (enclosed) through proper channel, approved at the level of Director/SE concerned, complete in all respects, should reach Estt.I Section, CWC, New Delhi **ON OR BEFORE 30th AUGUST 2011**. Candidates are requested to fill up all the columns properly, failing which the application may be rejected.
