MINUTES OF THE 13TH MEETING OF THE EDITORIAL BOARD OF CWC

The 13th meeting of the Editorial Board of CWC was held under the Chairmanship of Chief Engineer (HRM), CWC & Editor-in-Chief of Editorial Board on 09.10.2019 at 3.00 pm in his chamber to finalise design & content of “Water Resources at a Glance-2020”.
