The tenderers uploading the tender shall upload the scanned copy of A/C payee Demand Draft (non refundable) drawn on any scheduled bank in favour of the Executive Engineer, Lower Brahmaputra Division, CWC, Jalpaiguri payable at Jalpaiguri for Rs. 500/- (Rupees Five Hundred only) towards the cost of tender document at the time of submission.
