### **AUCTION NOTICE**

Late Bid after specified date & time will not be considered.

The items described in **Annexure-I** are lying in the office of the Central Water Commission, Jammu under LCSD, Jal Ayog Bhawan Rajinder Nagar Phase-I, Bantalab, Jammu-181123 CWC, Jammu and can be inspected on any working day between **10:30 hrs to 16:00 hrs up to 03.02.2020** except on public holidays.

6. The items shall be disposed off "As and where is" basis. The highest bid for the auctioned item will be accepted subject to realization of full reserved value. Bid will be evaluated on consolidated rates.
7. No picking, choosing, sorting, welding, cutting or breaking of goods or materials sold will be permitted.
8. If any foreign materials are found to be mixed in the lot, other than the items included in the action catalogue and acceptance letter /sale order, the seller reserves the right to remove them at the time of delivery.


