

TERMS AND CONDITIONS:

- 1. Interested bidders should deposit EMD amount of Rs.1000/-(Rupees One Thousand Only) in Demand Draft (DD) drawn in favor of Executive Engineer, Hydrology Division, Central Water Commission, Chennai payable at any nationalized bank at Chennai. Ouotations without EMD will be rejected.
