
### AUCTION NOTICE

The Deputy Director, River Data Compilation-1 Directorate, Central Water Commission, New Delhi invites sealed quotations on behalf of the President of India, for auction of "Disposal of old and unserviceable T&P material" Annexure-I to be made by the undersigned as per the Schedule enclosed and terms and conditions as below:

1. The sealed quotation should be dropped in the O/o of Deputy Director, RDC-1 Directorate, CWC, Ground Floor, Wing 5, West Block-2, R.K. Puram, New Delhi on or before 27.09.2021 at 15:00 Hrs and will be opened on the same day at 15:30 Hrs. Intending bidders may be present at the time of opening of auction bid.
2. The Listed materials will be available for inspection sale "As is where is Basis" and the interested parties can inspected listed materials during any working days between 15.30 Hrs to 17.00 Hrs up to 24.09.2021 in the office premises of the Deputy Director, River Data Compilation-I Directorate, CWC, West Block-2, Wing-5, Ground Floor, R.K. Puram, New Delhi.
3. Every bidder has to attached with bid of earnest money amounting to Rs. 500/- (Rupees Five hundred only) in the form of FDR/ Demand Draft/Pay order in the favour of Deputy Director, RD Dte, CWC, New Delhi. Without earnest money the bid shall be invalid & disqualified. The Agency shall have past experience in disposal of unserviceable, old goods and shall have a valid PAN/TIN/GST registration with Government.
4. The earnest money will be refunded back to all the bidders except the two highest bidders after completion of the auction. The successful bidder has to lift/remove the materials from the office premises within 2 days of making full payment. In case of failure in depositing the full money and non-lifting of the material within the stipulated period, earnest money will stand forfeited and the offer shall be extended to the next highest bidder.
5. The bidder shall quote rate for every items. Bids which will not include all items of Annexure-I will be summarily rejected.
6. The Director (RDD-1) reserves the right to accept or reject any or all the bidder without assigning any reason thereof.
7. The bidder shall submit bid on its letter head with seal and address in the format given at Annexure-I.
