

Sealed quotations are hereby invited on behalf of President of India by the Executive Engineer, Middle Ganga Division III, Central Water Commission, Varanasi for the disposal of unserviceable items as per list attached (Annexure-A) on 'AS IS WHERE IS' basis. The terms and conditions are given below:-

TERMS AND CONDITIONS:

1. The interested party should submit their quotation (in the Performa enclosed) to the undersigned in sealed cover. The outer cover should be super-scribed with the word "QUOTATION FOR UNSERVICEABLE ARTICLES due on 07-06-2019. The Quotation should be addressed to the Executive Engineer, Middle Ganga Division III, Central Water Commission, Varanasi and should be dropped in the tender box kept in the office on or before 11.00 hours of 07-06-2019. This Office shall not be responsible for any kind of delay. No quotation shall be accepted after the due date and time.
2. Earnest Money of Rs. 500/- (five hundred Only) must be enclosed along with the quotation in the form of an A/C Payee DD/ Banker's cheque from a scheduled bank in favour of Executive Engineer, Middle Ganga Division III, Central Water Commission, Varanasi.
2. Quotations should be signed by quotationer or a person duly authorized on his behalf. A copy of such authority should be enclosed along with the quotation.
3. Quotation forms are not transferable.
5. Quotation received without Earnest Money will be summarily rejected.
6. Quotations will be opened on 07-06-2019 at 11.30 A.M. If the date of opening of quotations happens to be holiday then the quotations shall be opened on the next working day at the same time.
7. Quotationers can inspect the unserviceable articles during office hours in Division Office of Middle Ganga Division III, Varanasi between 11.00 A.M to 4.00 PM. To ascertain the conditions of unserviceable articles and satisfy them selves before submitting their offer by the date and time specified above.
8. Overwriting or alternations will disqualify the quotation unless these are legible attested by quotationers.
9. Rate should be kept valid for acceptance for at least 30 days from the date of opening of the quotation.
10. It will be presumed that the quotationers before submitting the offer have read carefully all the terms and conditions and accepted the same in full. Deviations from the terms and conditions as given are not permitted. Any such conditional quotation is liable to be rejected and no alterations shall be allowed after the quotation is submitted. No counter terms and condition shall be accepted.

11. Right to include any other conditions or modify it is reserved by the Executive Engineer, Central Water Commission, Middle Ganga Division III, Varanasi
12. Quotationer will be deemed to have been on the clear understanding that they have satisfied themselves fully in regard to the conditions, quality and quantity of unserviceable items proposed to be auctioned.
13. The successful quotationer will be required to make full payment of quoted value Within two days. The successful quotationer will have to lift the unserviceable items within **Seven days** after depositing the full quoted amount. The successful quotationer failing to lift the material within the above stipulated period, shall have to pay store rent @10% of tendered value per week. The office will not be responsible for any loss or damage of the Unserviceable articles.
14. The purchaser will not be entitled to resell any or all-unservicable items while it is lying within the premises of Middle Ganga Division III, Varanasi and no delivery would be affected by any person or persons other than the purchaser/purchasers whose name/names are mentioned in the delivery order.
15. Loading, handling, labour and transportation shall be the whole responsibility of the purchaser at his own cost.
16. Loading and lifting of the auctioned goods shall be done by the purchaser only during the prescribed working hours of the office. No deliveries shall be affected during Sunday or Holiday.
17. The Executive Engineer, Middle Ganga Division III, Central Water Commission, Varanasi reserve the right accept or reject any or all offer/quotation either in full or in part without assigning any reason .
18. The Successful quotationer shall be responsible for any damage that may be done to the premises while removing the goods by him. Central Water Commission, Middle Ganga Division III, Varanasi may at his own options ask to make good such damages and buyer shall have to pay for the same on demand.
