AUCTION NOTICE

The Sub Divisional Engineer, Damanganga Sub Division, CWC, Silvassa invites sealed quotations on behalf of the President of India, for the Departmental auction of old & unserviceable T&P articles "**As and where is basis**". The detailed list of materials is enclosed in **Annexure-I**.

Terms & Conditions:-

1. The amount quoted should be written both in figure as well as in words.
2. Every Bidder has to quote the rate for the lot of full set & not for part thereof.
3. The sealed quotations should reach the office of the Sub Divisional Engineer, Damanganga Sub Division, Central water commission, opposite Police Line, Dadra & Nagar Haveli, Silvassa (Dadra & Nagar Haveli) on or before **15:00 hrs of 10/07/2019**, which will be opened on the same day **(10/07/2019) at 15:30 hrs**. Late Bid after specified date & time will not be considered.
4. The items described in **Annexure I** are lying in the office of the Central Water Commission, Daman under Daman Ganga Sub Division, Central water commission, opp. Police Line, Dadra Nagar haveli, Silvassa and can be inspected on any working day between 10:30 hrs to 16:00 hrs up to 09/07/2017 except on public holidays.
5. The items shall be disposed off "As and where is" basis. The highest bid for the auctioned item will be accepted subject to realization of full reserved value. Bid will be evaluated on consolidated rates.
6. The bidder shall be required to deposit a sum of Rs.500.00 (Rs. Five hundred only) as Earnest Money in the form of cash/DD of a scheduled Bank issued in favor of the Executive Engineer, Tapi Division, CWC, Surat payable at Surat. Only those bidders, who deposited the earnest money, shall be entitled to auction bid.
7. The earnest money of the unsuccessful bidder shall be returned after opening of the quotations and completion of bid formalities.
8. On payment of the full quoted value, the successful bidder shall collect the auctioned item within 3 days from the date of issue of letter of acceptance. If the bidder fails to remove the auctioned items he /she shall have to pay Rs. 100.00 (Rupees one hundred only) per day towards watch and ward charges. After 15 days, the Sub Divisional Engineer, Damanganga Sub Division, Silvassa (Dadra Nagar haveli) shall be free to dispose off the items at his direction by Public Auction.

9. The department shall not be responsible for any loss or damage to the items on account of theft, (pilferage) fire or any other calamity, once the letter of acceptance is issued to the successful bidder.
10. Central Water Commission will not be responsible for postal delay.
11. The auctioned items are to be lifted within 5 days of the issue of letter of offer on making full payment thereof; otherwise the earnest money deposited shall be forfeited. In case of failure of the successful bidder to deposit the balance amount stated as per of Para 8 above, the EMD deposited by the bidder shall be forfeited in full.
12. Sub Divisional Engineer, Damanganga Sub Division, Central water commission, Silvassa reserves the right to accept or reject all or any of the quotations without assigning any reasons. In case, if the highest offer does not cover the reserve price, the auction will not be conducted.
13. Any dispute arising out of this auction, the decision of the Sub Divisional Engineer, Damanganga Sub Division, Central Water Commission Silvassa shall be final and binding.
14. Any other rules of CPWD codes & its amendment as applicable will be binding for this auction.
