To 1600 hrs. at office of Executive Engineer Planning & Investigation Division, Central Water Commission, Quarter No. 1061-64, Type V, NH IV, NIT, Faridabad, Haryana -121001".
- No registration, transfer, road tax etc. In respect of the vehicle shall be payable by the Department.
- 3. Bidders must have valid GST Registration, PAN etc.
- 4. The bidder must deposit Rs. 5000.00(Rupees Five Thousand Only) as EMD in a separate sealed envelope in the form of A/C Payee Bank Draft in the favour of "Executive Engineer, P&I Division, CWC, Faridabad". Without earnest money the bid shall be invalid & disqualified.
- EMD of unsuccessful Bidder will be returned & The EMD of successful Bidder will be adjusted in bidding amount.
- 6. The sealed quotations should be sent to the "Executive Engineer Planning & Investigation Division, Central Water Commission, Quarter No. 1061-64, Type V, NH IV, NIT, Faridabad, Haryana -121001" on or before 12.02.2019 up to 15:00 hours and will be opened on the same day at 15.30 Hrs. Intending bidders may present at the time of opening of auction bid.

7. The cover/Envelope must be duly super scribed "Mahindra & Mahindra Jeep DL3CJ-6452(Diesel)"

8. The delivery of the auctioned vehicle is to be taken within 20 days on the issue of letter of offer after making full payment thereof; otherwise the earnest money deposited will stand forfeited.

 The undersigned may extend the period on justified and genuine grounds for 5 days on payment of demurrage charge of Rs. 100/- per day i.e. viable from the date of acceptance of the offer by the bidder.

10. GST as applicable will be charged extra from successful bidder.

11. The undersigned will not entertain any claim for damage done by the way of theft, pilferage, fire or any other unforeseen calamity after realising full payment against the sale of auctioned vehicle.

12. The quotation for the work/supply shall remain open for a period of **30 days** from the date of opening of quotations. The Government shall, without prejudice to any other right or remedy, be at liberty to forfeit 50% of the earnest money if any quotationer withdraws his quotation before that date or makes any modification in the terms and conditions of the quotation which are not acceptable to the department, and to forfeit the whole of the earnest money if the quotationer, whose quotation is accepted, fails to deposit the whole bidding amount within 10 days of issue of letter of acceptance of auction.
