2. The materials will be kept open for inspection in the O/o the Executive Engineer, LKD, CWC, Hyderabad on all working days from 27-04-2019 to 03-05-2019 between 10.00 AM to 5.00 PM.
3. The exact amount in words as well as in figures shall be mentioned in the quotation.
4. Alterations/corrections/over writings if any on the quotation shall be attested, without which the quotations would be summarily rejected.
5. The successful bidder after issue of acceptance letter shall deposit the amount towards bid amount within 10 days, by a Demand Draft(drawn in favour of Executive Engineer, Lower Krishna Division, CWC, Hyderabad) or by cash in the office of the Executive Engineer, LKD, CWC, Hyderabad.
6. The bidder shall remove the articles at his own cost and expenses within three days after full payment of the accepted bid amount from the time of communication to that effect.
