TERMS & CONDITIONS:-

1. The bids should be submitted in sealed cover/Envelope super-scribed “ **Bids for Disposal of old & unserviceable T&P articles of Sabarmati Sub Division due on 23.01.2017 time 3.00 PM**”.
2. The sealed bid should be dropped in the tender box placed in the office of the Sub Divisional Engineer behind Swami Narayan Temple, Narayanghat, Sahibaug, Ahmedabad on or before 23.01.2017 by 3.00 PM and will be opened on the same day at 3.30 PM in the office of the the Sub Divisional Engineer behind Swami Narayan Temple, Narayanghat, Shahibaug, Ahmedabad. Intending bidders may be present at the time of opening of Bids.
3. The rates/ amount shall be quoted in figures & words separately for each item/ lot as mentioned in Annexure -I. **Bids will be evaluated on consolidated rates.** Item wise evaluation will not be done. Taxes & other levies, freight if any, will have to be borne by the bidder.
4. CWC will not entertain any claim for damage done by way of theft, pilferage, fire or any other unforeseen calamity after realizing full payment against the sale of unserviceable items.
5. Every bidder has to deposit Earnest Money Deposit (EMD) in cash/ Demand Draft in favour of EE, Mahi Division, CWC, Gandhinagar amounting to Rs 1600/- (Rupees one thousand six hundred only), The cash should be deposited to the cashier of Mahi Division, CWC, Gandhinagar and the copy of the money receipt should be attached along with the quotation.
