**CIRCULAR**

Sub: **INTER-MINISTRY BADMINTON TOURNAMENT 2022-23.**

On the occasion of 75 years of Independence of India, Government of India is celebrating **AZADI KA AMRIT MAHOTSAV**. The objective of the Mahotsav is to enhance interaction and promote mutual understanding between people of different States and Union Territories by conducting activities in the field of language and culture.

2. To commemorate the glorious history of Indian people and culture, Central Civil Services Cultural & Sports Board (CCSCSB) is organising Inter-Ministry Badminton Tournament 2022-23 from **26.12.22 to 30.12.22 & 02.01.23 to 06.01.23** ( 10 working days except Saturday & Sunday) at **AIIMS GYM KHANA, New Delhi**. The last date of entry is **16<sup>th</sup> December, 2022 (Friday)**. Individual draws of main & veteran events will be held at AIIMS Gymkhana prior two days schedule of respective event at 1 PM sharp. It is, therefore, requested that all the managers of participating teams must present at the time of draws.

3. The entry should be sent in the enclosed prescribed form (**Annexure-I**) duly signed by the Welfare Officer of the Ministry concerned to the office of the CCSCSB, DoPT, Room No. 361, 'B Wing' 3<sup>rd</sup> Floor, Lok Nayak Bhavan, Khan Market, New Delhi- 110 003. **No entries will be accepted after the due date i.e. 16.12.2022**. Tournament will start with Men's Singles & Doubles (qualifying) events and their draws will be displayed at the venue (AIIMS Gymkhana) on **23.12.2022 (Friday) after 2 PM**.

4. The competition will be held in the following 19 events with restriction of entries from each Ministries/Departments. **One Player can participate in maximum 03 events only except Team Championship event:**

5. Entry Fee for the Team Championship is Rs. 300/-, Rs. 75/- for Singles and Rs. 150/- for Doubles events, which may be deposited in Board's Account through online/NEFT mode only. Board's Bank details are as under:

6. The Men Singles & Doubles (Qualifying) events will be open to new players/beginners only. The players who have represented the State or Central Secretariat Team in the All India Civil Services Badminton Tournament or have already qualified the Qualifying Event in the previous years need not participate in the qualifying events of the tournament. Players reaching up to Quarter Finals in the Men Singles & Doubles (Qualifying Events) will get automatic entry in the main event of Open Men Singles/Doubles. Matches for **Third Place** for all the above mentioned events (except Qualifying Event) will be held between the losers of Semi Finalist.


7. All the players should reach the venue for their matches well in time as mentioned in the Draw/Time Schedule displayed at the venue, otherwise walkover rule will strictly apply against him/her and no further request will be entertained in this regards. Time scheduled of the above events will also be available at the website of our Ministry i.e. ([https://dopt.gov.in/about-us/wings-or-division-in-dopt\(welfare-divisions\)](https://dopt.gov.in/about-us/wings-or-division-in-dopt(welfare-divisions))) from 22.12.2022.

8. **Winners & Runners-up of both Men & Women Team Championship Events will also be awarded cash price of Rs. 10,000/- & Rs. 7000/- respectively.**

9. The eligibility/non-eligibility conditions for participation in the Inter-Ministry Tournament have already been circulated to all the Ministries (Persons working in Corporation, Public Sector, Autonomous Bodies/Public Sector Banks/Undertakings (Like FCA, DTC, LIC, ESIC, CBSE etc.) will not be eligible to participate in the Inter-Ministry/AICS Tournament, even though administratively controlled by the Central Ministries). However, rules & regulations governing the eligibility conditions for the participation in the Inter-Ministry Tournament are available on the website of the Department of Personnel & Training ([https://dopt.gov.in/about-us/wings-or-division-in-dopt\(welfare-divisions\)](https://dopt.gov.in/about-us/wings-or-division-in-dopt(welfare-divisions))).

10. The general instructions as per SOP/ Guidelines of COVID-19 issued by Central/State Govt., are to be strictly followed by all players and supporting staff during the competition. If it is found that the general instructions are not followed by any player/ official in the tournament he/she shall be liable to be debarred from the tournament.

**OFFICE MEMORANDUM**

**Subject : Procedure to be followed by employees of Central Water Commission while participating in various sports activities conducted by Central Civil Services Cultural & Sports Board (CCSCSB) under DOP&T.**

In the recent past, it has come to notice that an employee of Central Water Commission, who had already been deployed for Election Duty had applied for Special Casual Leave for participating in sports activities during that period, which has resulted in an embarrassing situation. To avoid any such untoward eventuality and that the important duties such as Election Duty, CBI duty or any other important items of work allotted by Controlling officer are not adversely affected, the following procedure is to be adhered to while the concerned employee, who has been nominated by CCSCSB or any other body under DOP&T or otherwise to participate in any sports activity, cultural activity etc :-

- i. "No Objection Certificate" from his controlling officer in which he is performing his duty. In that No Objection, it should be clearly indicated by the controlling officer that he has not been nominated for any mandatory duties like Election Duty, CBI duty or otherwise and the work of that concerned section/directorate is not being hampered if the said employee remains absent during the period in which he is participating in any sports related activities;
- ii. After the concerned controlling officer forwards the application, it will be routed to Sports Secretary, CWC who will ensure that the concerned official/officers (players) will maintain the discipline and punctuality of players by taking regular attendance from the Coach/Training/Practice Camp. Erring employees will be debarred from representing Central Water Commission, if it is found that the player remains absent from training/office without intimating Central Water Commission or giving valid reason to in-charge/Manager/Captain/Sports Secretary, his practice orders will be cancelled immediately and appropriate disciplinary action will be taken against him. Therefore, Sports Secretary, CWC should give an Undertaking in this regard to CWC before the concerned player/official proceeds for participating in any sports activity.
- (iii) Further reasonable time should be given to Estt-IX Section of CWC for issuing office order etc. after adhering to the procedure as indicated in
