So far, China has maintained that its dams do not restrict the flow of water towards India as they are based on run-of-the river principle.

China's 13th five-year-plan has proposed significant hydropower expansion along rivers that also originate in the Tibetan plateau: Although the plan does not mention any river specifically, it is anticipated that the new dams are envisaged along the Yarlung Tsangpo, Lancang (Mekong) and

Nu (Salween), all originating in the Tibetan plateau.

Analysts say that aware of the downstream impact of dams along trans-boundary rivers, the plan document underscored the need to "scientifically develop and harness international rivers" and "deepen cooperation with other riparian countries/along the rivers".

In March, Minister of State for water resources Sanwar Lal Jat issued a statement expressing India's concerns regarding the impact of dams constructed by China.

India and China have set up an expert-level mechanism on trans-border rivers. In 2013, New Delhi and Beijing signed a memorandum of understanding on trans-border rivers, under which China has been supplying data to India on water flows.

'Centre has to play bigger role in resolving water disputes'

NEW DELHI, SEPTEMBER 30

KARNATAKA CHIEF Minister Siddaramaiah Friday said the Centre needed to play a "greater and more proactive" role on water-related issues, especially when it came to resolving interstate disputes.

But he stopped short of supporting suggestions that the subject of water needed to be moved to the Concurrent list from the State list, where it is now. "I have not given adequate thought to these kind of suggestions," he said.

As the Supreme Court continued to remain unmoved to his state's plea on release of Cauvery river waters to Tamil Nadu, Siddaramaiah suggested interstate sharing of waters should be dealt with through a "clear national policy" and not by courts.

"I think the Centre should frame a separate national policy to deal exclusively with sharing of waters and inter-state disputes. I believe the Centre has a much greater and proactive role to play in resolving such disputes. Otherwise, situations like the one we are faced with will continue and people will suffer," he told *The Indian Express*.

The Centre did convene a meeting of Karnataka and Tamil Nadu Thursday, on the directions of the Supreme Court, but no breakthrough could be achieved.

Siddaramaiah said Karnataka had no intention of denying Tamil Nadu its share of water.

"We have been sharing Cauvery waters for several years. We have always released water, whatever is due. But come and look at our reservoirs, we do not have any water to release at this time. The fact is that there has not been enough rain in the catchment areas this year and that is not hidden from anyone. We are not hoarding water. The only thing we are trying to ensure is that our people are not deprived of drinking water," he said.

He said Karnataka had been repeatedly asking for an expert body to come and assess the water situation in the state, but even

the Supreme Court had remained unconvinced till now on this proposal. "Let the experts come and decide whether what we are saying is correct or not," he said.

He hinted that Karnataka could have been inclined to accept the decision of the Supreme Court-mandated Supervisory Committee on Cauvery, which had asked the state to release 3,000 cusec of water throughout the day from September 21 to September 30. "But that order (of the committee) was changed the next day by the Supreme Court, and doubled to 6,000 cusecs. We did not have that much water to release," he said.

Siddaramaiah said the current deadlock could slowly defuse once Tamil Nadu starts receiving rain through the north-east monsoon, but such disputes between other states were likely to continue.

'That is why I want the central government to quickly initiate a dialogue with all the states towards framing a national policy on water (disputes). I have had a conversation with Umaji (Water Resources Minister Uma Bharati) on this. I have also written a letter to the Prime Minister and sought an appointment. A national policy, according to me, is the only solution," he said.

After SC rap, Siddaramaiah calls all-party meeting today

KARNATAKA CHIEF Minister Siddaramaiah has called for an all-party meeting on Saturday to discuss the Supreme Court directive to the state, asking it to obey its order to release 6,000 cusecs of water from the Cauvery to Tamil Nadu for three days.

Siddaramaiah has called for a meeting of leaders of both houses of the state legislature, MPs, central ministers representing the state and ministers from the Cauvery basin to discuss the water issue.

At an all-party meeting conducted earlier this week, the government had received mixed suggestions on releasing water to Tamil Nadu, with some saying that Karnataka could comply with the court's September 20 ruling as storage in Cauvery basin has improved from 27 TMC feet to 31 TMC feet following rainfall in catchment areas.

Ex-PM Gowda goes on indefinite hunger strike

WATER POLITICS BJP, JD(S) throw weight behind Siddaramaiah, all-party meet takes unanimous decision not to release water to TN

BENGALURU: Former prime minister HD Deve Gowda began an indefinite hunger strike on Saturday seeking justice for Karnataka in the ongoing row with Tamil Nadu over release of Cauvery water.

The 83-year-old Janata Dal (Secular) supremo is sitting on fast near the Mahatma Gandhi statue next to Vidhana Soudha, the state secretariat.

Gowda's sudden decision comes in the backdrop of the Supreme Court order on Friday, asking Karnataka to release 6,000 cusecs of Cauvery water till October 6 to Tamil Nadu and the Centre to constitute the Cauvery Water Management Board.

"We want justice. Drinking water is essential for humans to survive," said Gowda, a former chief minister.

Asserting that he would continue his protest till Karnataka gets justice from the Union government, Gowda said he still has confidence in the prime minister that the issue will be resolved.

Home Minister G Parameshwara said the former prime minister had always fought for the state's interests and added, "I hope it (the hunger strike) will open the eyes of the judiciary."

He said the Attorney General agreeing in the Supreme Court to the formation of the Cauvery Water Management Board also showed that "it (Union government) is also against us".

Karnataka also decided to move the Supreme Court seeking a review of its order directing the state to release Cauvery water to Tamil Nadu.

OPPOSITION BACKS SIDDARAMAIAH

Meanwhile, Opposition parties in Karnataka asked the Siddaramaiah government not to release water to Tamil Nadu and to oppose the formation of the Cauvery Water Management Board.

BJP and JD(S) leaders said they told the government to stick to the resolution passed by both the Houses of state legislature on September 23 that water should be used only for drinking purpose, and not be spared for any other use.

Soon after the all-party meet, that lasted for more than three-hours, chief minister Siddaramaiah went into a huddle with the Council of Ministers which would take a call on the

Supreme Court directive.

Supreme Court order at any cost as it is unimplementable. The House (legislature) decision should be upheld. Government should stick to the decision," Opposition BJP leader in the Assembly Jagadish Shettar said.

At present, the municipal corporation has a sewage production of 28.8 MLD. There are two sewage treatment plants in the city with total capacity of 18 MLD.

Solid waste management

Appearing for the Central Pollution Control Board (CPCB), Additional Solicitor General Pinky Anand said at a time when the Central government is going full throttle to clean up the Ganga, municipal bodies across the country too should pro-actively come forward to meet the desired goal in a time-bound manner.

On the issue of solid

waste management, the Mirzapur municipality told the green court that a unit of the Uttar Pradesh Jal Nigam had entered into an agreement with a Gurgaon-based firm in 2011.

However, it had became difficult for the Mirzapur municipality to handle solid waste due to delays on part of the contractors.

"They were left with no other option than to dispose of solid waste through the old conventional method, that is, by digging a pit and then covering it. The pit is more than two km away from the banks of the river," the affidavit further stated.

The civic body also stated in the affidavit that the Uttar Pradesh Jal Nigam is required to render services for sewerage to State government and local bodies.

Now, relentless rain, flash floods wreak havoc in Marathwada

PUNE: Heavy downpour for the past 48 hours has caused flash floods in at least four districts of Marathwada in Maharashtra, throwing the traffic awry and spurring disaster response teams to rush to the area.

Relentless rain in Latur, Osmanabad, Beed and Solapur districts led to overflowing dams in the region opening their sluice gates on Sunday.

In Osmanabad, four gates of the Sina Kolegaon dam were opened after the danger mark had been crossed, while the earth-fill Chandani dam was reported to be overflowing. The Terna dam, sited in the same district, was reportedly overflowing for the first time since 2010.

Eleven gates of the Majalgaon dam in Beed district were opened to drain out the excess water.

According to reports, four people were stranded in a village in Osmanabad's Lohara Taluk. Units of the National Disaster Response Force (NDRF) rescued 11

people trapped in Latur's Mawalgaon village, said sources. Since Saturday evening, NDRF jawans have succeeded in rescuing more than 45 persons cut off in villages in Latur and Nanded districts.

The raging flood waters threw public transport out of gear, disrupting communication and rendering many highways ineffectual for commute.

Most of the roads in the region became totally cut-off after 2 p.m., with the waters rendering the Latur-Tuljapur

road unusable for traffic. This has caused severe inconvenience to devotees travelling to the Tulja Devishrine in Osmanabad.

Highway traffic hit

Massive traffic snarls were witnessed along the length of the National Highway 211 connecting Aurangabad district with Solapur.

The floods have ravaged crops and battered livestock in some parts of Solapur district, said reports, although the extent of damage is yet to be ascertained.

Siddaramaiah's Snub To SC Not 1st Case Of Defiance By A CM

efiance of the Supreme Court's orders have always invited stinging punishment. Sahara group chief Subrata Roy will testify to that. He spent more than two years in jail and yet is not safe from the wrath of law. Last week, he was in real danger of being dragged back to prison just because his counsel made some intemperate arguments to test the SC's patience.

Again last week, the Justice Lodha committee complained to the SC that the Board of Control for Cricket in India (BCCI) was impeding and defying implementation of reforms ordered by the apex court. Asking the BCCI to fall in line, the SC issued a "we will set you right" warning.

But last week also saw Karnataka repeatedly flouting the SC's orders for release of Cauvery water to Tamil Nadu. Three times in the past one month, the state disobeyed the SC's orders. The political class came together and the assembly passed a resolution restraining the government from releasing water.

The SC had no option but to reiterate its orders not withstanding the assembly resolut on. CM Siddaramaiah told e SC in clear terms that gin the "will of the people of ırnataka", he would disey the court's orders.

In a democracy, rule of law maintained only when the plator faces reprisal of law

swiftly and unwaveringly. For a commoner, the wrath of law has always been swift but when it comes to a mighty state or a chief minister, the SC has always been a little lenient.

It is not the first time that Karnataka has disobeyed SC orders. In 2002, the SC had issued contempt notice to then chief minister S M Krishna for disobeying its October 4, 2002 order for release of 9,000 cusecs of water into Mettur reservoir. The contempt proceedings gathered dust.

LEGALLY SPEAKING

After six years, the SC disposed of the contempt proceedings taking into account Krishna's unconditional apology for the disobedience filed through senior advocate Fali S Nariman, who continues to be the counsel for Karnataka in the Cauvery dispute.

Is Siddaramaiah drawing inspiration from the past? Difficult to say but the SC faces a , real dilemma. If it hauls up the CM for contempt, it would help his popularity soar. And there is no guarantee of his successor implementing the SC's orders. As regards Siddaramaiah, he would not mind facing the wrath of law to

emerge a martyra few months ahead of assembly elections.

If the court does not take action, then it could encourage other states to defy its orders hiding behind the "will of the people". And at present, it takes virtually nothing to whip up public hysteria.

In 1992, then UP chief minister Kalyan Singh had given an undertaking to the SC to maintain status quo at the disputed Ram Janmabhumi-Babri masjid site. It was flagrantly violated and the structure was razed to the ground. The SC convicted him for contempt of court.

In Mohd Aslam vs Union of India [1994 (6) SCC 442], the SC said, "It is unhappy that a leader of a political party and chief minister has to be convicted of an offence of contempt of court. But it has to be done to uphold the majesty of law. We convict him of the offence of contempt of court. Since the contempt raises larger issues which affect the very foundation of the secular fabric of our nation, we also sentence him to a token imprisonment of one day. We also sentence him to pay a fine of Rs 2,000." Is that the wrath of law - one day's imprisonment or a fine of Rs 2,000?

Importantly, the SC had

said, "Respect for law and its institutions is the only assurance that can hold a pluralist nation together. Any attempt to achieve solutions to controversies, however ideologically and emotionally surcharged, not on the basis of law and through judicial institutions, but on the strength of numbers will subvert the fundamental values of our chosen political organisation. It will demolish public faith in the accepted institutions constitutional and weaken people's resolve to solve issues by peaceful means. It will destroy respect for rule of law and the authority of courts, and seek to place individual authority and strength of numbers above the wisdom of law."

Contrast this to a very recent example in the US. No less than Alabama Supreme Court chief justice Roy S Moore was suspended because he had ordered junior judges to defy an order of the US Supreme Court which validated same-sex marriage in June last year. That is what is called the wrath of law which operates on the basis of the maxim "you be ever so high, the law is above you".

Unfortunately in India, the wrath of law has always remained inversely proportional to the position and popularity of an individual. The higher he stands, lesser the chance of him facing the wrong end of the judicial stick. It will be interesting to watch how the 'wrath of law'story unfolds in the SC.

Country gets first normal rains in 3 yrs

Deficit Continues In Punjab, Haryana, West UP


New Delhi: For the first time in three years, the country received normal rainfall in the monsoon season, which ended on Friday with an overall shortfall of 3% — within the normal range of +/-4% but less than what the India Meteorological Department (IMD) had forecast.

Despite the IMD prediction of an "above normal" monsoon not materialising, good rains in the crucial July-early August period boosted kharif sowing. Thereafter, bountiful showers in central India and Telangana also ended successive years of drought in these regions.

This was a welcome change from the drought years, when the deficit was 12% (2014) and 14% (2015).

The granary of the north—Punjab, Haryana and western UP— had to contend with another year of deficit rains. Punjab and Haryana ended with deficits of 28% and 27%, respectively, while western UP had a shortfall of 17%. Among the four regions, monsoon was above the long period average in just central India (+6%).

Of the 36 meteorological subdivisions, monsoon was excess or normal in 27 and deficient in nine. However,



201 districts (36%) recorded deficient monsoon.

Much of the shortfall can be traced to a period of low rain from August 10 to mid-September. "Conditions in the Indian Ocean became unfavourable around that time," said D Sivananda Pai, IMD's lead monsoon forecaster.

WATER STORAGE IN MAJOR RESERVOIRS IMPROVES

STATESMAN NEWS SERVICE

New Delhi, 30 September

The water storage situation in major water reservoirs has improved significantly this year, almost 22 % more than last year, revealed the Central Water Commission live storage status.

The Commission said the storage of 91 major water points this year is 122 % of the storage of the corresponding period last year. However, it is still three per cent less than the average storage of past ten years.

"The total storage capacity of these 91 reservoirs is 157.799 BCM which is about 62% of the total storage capacity of 253.388 BCM which is estimated to have been created in the country," the Commission said.

The northern region, which includes Himachal Pradesh, Punjab and Rajasthan, has seen little change in its storage status, eastern, western, southern and central regions registered a significant improvement as compared to last year's storage status.

Storage status of eastern region increased from 74 % to 86%, and in western region it increased from 62 % to 80%, the Commission stated. In centralrRegion storage status improved from 72% to 91% and in southern region from 34 % to 52%.





प्रिटीआई, पेइचिंग : पाकिस्तान के कब्जे वाले कश्मीर (PoK) स्थित आतंकी ठिकानों पर भारत के 'सर्जिकल स्ट्राइक' के बाद चीन के तेवर कुछ 'विरोधी' से दिख रहे हैं। उसने तिब्बत में ब्रह्मपुत्र नदी की एक सहायक नदी का पानी रोक दिया है। साथ ही, जैश-ए-मोहम्मद के सरगना मसूद अजहर को संयुक्त राष्ट्र से आतंकी घोषित किए जाने से बचा लिया है।

चीन ने तिब्बत में यारलुंग जेंगबो नाम से जानी जाने वाली ब्रह्मपुत्र की एक सहायक नदी पर हाइड्रो प्रॉजेक्ट लगाया है। यह प्रॉजेक्ट तिब्बत के जाइगस में हैं, जहां से ब्रह्मपुत्र नदी अरुणाचल प्रदेश में बहते हुए दाखिल होती है। भारत के लिए यह चिंता की बात है क्योंकि इससे भारत और बांग्लादेश समेत कई देशों में ब्रह्मपुत्र के बहाव पर असर पड़ सकता है। इसके अलावा चीन ने मसूद अजहर को UN से आतंकवादी घोषित करवाने के भारत के प्रयास पर लगाए अपने 'वीटो' की मियाद बढ़ा दी है। चीन ने फिर आपित नहीं की होती तो यह प्रस्ताव खुद ही पास हो जाता।

चीन ने ये काम ऐसे समय में किए हैं, जब उड़ी हमले के बाद भारत ने पाक से सिंधु जल समझौते के तहत होने वाली बैठक रद्द कर दी थी। भारत ने यह फैसला पाक पर दबाव बनाने के लिए कियां था। ऐसे में चीन के इस खैए को पाक के सपोर्ट में खड़े होने की आशंका के तौर पर देखा जा रहा है। इससे पहले चीन ने भारत-पाक को आपसी बातचीत से मामला सुलझाने को कहा था। हालांकि रूस और अमेरिका समेत कई देशों ने तटस्थ रहने की लाइन चुनकर भारत को मौन समर्थन दिया है।



India got 3% less rain than normal: IMD

NEW DELHI: India has ended up with 3 per cent less rain than normal during the monsoon months of June to September.

This is the first time since 2011 that the department was not able to forecast the overall 'sign' of the monsoon—meaning that it expected heavy rain but ended up with less than normal. In 2014 and 2015, the India Meteorological Department (IMD) could not anticipate the severity of the droughts but had indicated that monsoon would be below normal.

In 2011, the IMD said India would get below normal (95% of the average) rain, but the country ended up with 2 per cent more rain than normal.

"I am not much worried that we couldn't get the trend right because all [monsoon] models in the world had expected a La Nina to form during the end of the monsoon," K.J. Ramesh, Director-General of the IMD, told The Hindu.

"Moreover there have been no reports of moisture stress from any region."

Mr. Ramesh added that through the monsoon months, there were indications that East and Northwest India would see rain deficits, but the delayed La Nina greatly affected the rains in South India, which has so far seen an 8 per cent deficit.

Deficient rain over South India led to riots and violence in Karnataka and Tamil Nadu over the sharing of Cauvery waters. The IMD is expected to release a formal report on the monsoon's performance on Monday.

Good sowing

The activation phase of La Nina — a weather phenomenon that is the converse of the El Nino and brings good rains to India — was supposed to boost rainl in September. However the near normal rains have so far been "well distributed", Mr. Ramesh said, and had contributed to good kharif sowing.

NEW DELHI: The Supreme Court pulled up the Karnataka government on Friday for its defiant stand on the Cauvery water sharing issue, directing it to release 6,000 cusecs of water to Tamil Nadu from October 1 to 6.

"Karnataka shall not be bent upon to take an obstinate stand of defiance as one does not know when wrath of the law will fall upon them," a bench of justice Dipak Misra and justice UU Lalit said.

"Karnataka is flouting order and creating situation in which majesty of law is dented," the SC said, and directed the Centre to constitute the Cauvery Water Management Board (CWMB) by October 4.

Senior officials in the water resources ministry said they have already started the process to constitute the board. "The process is on. Once the board is constituted, it will decide on the quantum of water to be released. The order of the board will be binding on the two states," an official said.

The court ordered all the stakeholders-Karnataka, Tamil Nadu, Kerala and Pudduchery-toname, by Saturday 4 pm, their representatives to the board which would be chaired by the Union water minister Uma Bharti.

The bench reminded Karnataka Bharti had said.

that it is bound by Article 144 of the Constitution and "aid in compliance" of the order of the SC.

On Tuesday, the court had asked Karnataka to release Cauvery water in the next three days despite the unanimous assembly resolution to use the water only for drinking. Karnataka decided on Wednesday to defer the release of 6,000 cusecs of Cauvery water to Tamil Nadu till Thursday.

In its Tuesday order, the SC had directed the Centre to constitute within four weeks the CWMB as directed by the Cauvery Water Disputes Tribunal (CWDT).

On Friday, it asked the Centre to set up the board by October 4.

The court had earlier asked the Union water ministry to facilitate a meeting between representatives of the two states after Karnataka refused to release the water following the apex court's direction.

However, after chairing a threehour meeting, Bharti said she was "disappointed" as a "solution outside court could not be achieved".

"Tamil Nadu did not agree to Karnataka's proposal that a central team of experts visits the Cauvery river basin to assess ground realities, including the quantum of water stored in reservoirs, drinking water available and crop situation, before a decision is taken to release water,"

Warming to breach 2°C limit by 2050

lobal average temperature could rise to two degrees Celsius above the norm — the point at which many scientists believe climate change will become dangerous — as early as 2050, a group of experts has warned.

In a report called "The Truth About Climate Change", they said many people seemed to think of global warming as "abstract, distant and even controversial". But the planet is now heating up "much faster" than anticipated, said Professor Sir Robert Watson, a former chair of the Intergovernmental Panel on Climate Change and one of the authors of the report. If their analysis is correct, the majority of people alive today will experience what it is like to live on a dangerously overheated planet.

At the Paris climate summit last year, world leaders agreed to try to limit global warming to 1.5 degrees celsius above pre-industrial levels as possible, amid concerns the 2 degrees celsius target may not be safe enough. But in the same year the level of warming reached 1 degree celsius after a 0.15 degree celsius

rise in just three years.


Droughts, floods, wildfires and storms are all set to increase as the world warms, threatening crops and causing the extinction of species. The new report warned the 1.5 degrees celsius target had "almost certainly already been missed". Even if all the pledges to cut emissions are fulfilled, the average temperature is set to reach that level in the early 2030s and then 2 degrees celsius by 2050, they said.

The report said an extra 0.5 degree celsius of warming was expected to take place because of greenhouse gases that have been emitted due to the slow response of the ocean and atmosphere. The experts called for drastic changes to the way the world produces and uses energy with a switch to electric cars among steps that should be taken quickly. THE INDEPENDENT

Brand Hyderabad takes hit

Rain drains out IT hub's pretensions of being a modern city

image of Hyderabad as an international information technology hub has suffered a dent with the week-long torrential rains exposing the chinks in the municipal administration and haphazard urban planning.

Crater-filled and waterlogged roads, inundated colonies, clogged storm water drains and nightmarish traffic snarls brought the city to a virtual standstill, forcing the government to declare holidays for educational institutions and to urge the IT companies to opt for work from home. For nearly one week, starting from September 21, the city received heavy downpour, nearly 23 times the daily average rainfall in monsoon, triggered by a depression over the Bay of Bengal.

"We received 16 cm of rain on a single day on September 21 as against 32-40 cm throughout the year," said P Saroja, the deputy commissioner of the Hyderabad Municipal Corporation.

Ironically, the upmarket colonies in the close vicinity of the city's IT hub in Gachibowli, Nizampet and Kukatpally were flooded, causing hardship to the residents. The office-goers had a harrowing time, navigating the potholes, waterlogged roads and massive traffic jams.

The two-year-old Telangana Rashtra Samiti (TRS) government has attributed the chaotic situation to the failure of the previous governments in checking the illegal encroachments on the lake beds and nullahs, or storm water drains.

"There are 28,000 encroachments on nullahs in Hyderabad and some of them even in government complexes and we need about Rs 11,000 crore over the next three-four years to rectify the situation," Chief Minister K Chandrasekhar Rao said.

"We will demolish all those structures to prevent flooding in future. From now on, we will not allow a single illegal construction to come up in the city," he said amidst growing public criticism over handling of the flood situation.

Special teams of municipal

officials, assisted by the police, have already pulled down over 650 such structures. The Greater Hyderabad MC has also announced a cash reward of Rs 10,000 to persons who provide information on unauthorised constructions.

"All these years, the municipal authorities looked the other way in the face of indiscriminate encroachments of lake beds and storm water drains. In fact, the illegal colonies were given power and water connections. There is a nexus between unscrupulous builders, encroachers and officials," said noted environmentalist K Purushotham Reddy.

Of the 390 km-length of nullahs in the city, 173 km of them are directly connected to Musi river. But, illegal structures are completely obstructing the flow of water through these drains.



The Bench ordered that the three States — Kerala, Tamil Nadu, Karnataka — and the Union Territory of Puducherry involved in the water dispute should send

Ordering Karnataka to release 6,000 cusecs of water to Tamil Nadu till October 6, the Supreme Court observed: "We are granting this opportunity as the last chance...we are passing this order despite the resolution by the joint House of the State Legislature of Karnataka."

Karnataka has ignored four consecutive orders passed by the SC in September to release water.

The court slammed the State for "flouting its orders and creating a situation by which the majesty of law dented."

BHUBANESWAR, 01 OCT: Normal life in seven southern Odisha districts was affected due to a 12-hour strike called by the ruling BJD protesting the national project status to Polavaram project in Andhra Pradesh.



The inflow into the Tungabhadra reservoir near Hosapete in Ballari district went up fol-


lowing rains in the catchment areas.

Karnataka seeks review of SC order on Cauvery

NEW DELHI: Karnataka on Saturday sought an urgent review of the Supreme Court orders to set up the Cauvery Management Board (CMB), saying the directions amounted to judicial legislation. Also, it violated the National Water Policy of 2012 which gives Karnataka's requirement for drinking water first priority over Tamil Nadu's need for water to irrigate its farm land.

The review petition, filed in the Supreme Court a day after the court directed the Centre to set up the CMB by October 4, contends that the judicial orders consecutively passed on September 20, 27 and 30 to release Cauvery water and form the CMB had gravely prejudiced the Karnataka people's right to life.

For one, Karnataka said its civil appeal against the 2007 final order of the Cauvery Water Disputes Tribunal was still pending consideration the Supreme Court. Secondly, the September orders contravened a decision of the Supreme Court on December 3, 2013, to put on hold the formation of the CMB till the civil appeal was decided. In 2013, the Supreme Court had refused Tamil Nadu's plea to set up the CMB. Karnataka argued that the constitution of the CMB was a legislative function and was a "miscarriage of justice."

Heavy rains in September resulted in a record rise in groundwater levels in the city. The average groundwater level for Hyderabad recorded this September is 5.18 metres below ground level (mbgl). Last September, it was 9.12 mbgl and in August it was 9.76 mbgl.

Rains raise water level in Cauvery basin dams

Showers may continue in Mandya, Mysuru

BENGALURU: Signs of getting rains in the Cauvery basin have renewed with parts of Mandya district receiving showers on Thursday. The water level in the Cauvery basin reservoirs too has gone up, though not significantly.

Parts of Mandya, Ramanagaram and Mysuru districts received rains. Weather forecast by the Karnataka State Natural Disaster Monitoring Centre (KSNMDC) is that these districts may continue to get rains on Thursday night and Friday. This would help in increased baseline water flow to the Mettur dam in Tamil Nadu, they said.

The maximum rainfall recorded in Mandya district was at Nagamangala (46.5 mm), while it was Mayaganahalli which recorded the highest (21.5 mm) in Ramanagaram district. Rain was scattered in Mandya district. Intermittent rains are expect-

ed in Mysuru for the next couple of days. Kodagu started receiving rains on Thursday evening. The highest rainfall (14.5 mm) was recored at Bettadahalli in Somwarpet taluk.

Sources in the KSNMDC said that it is normal to get rains during the withdrawal phase of the south-west monsoon.

The combined water level in the four Cauvery basin dams in the state was 32.08 tmcft as on Thursday evening. It was 31.29 tmcft on Wednesday. On September 23, when the Karnataka legislature passed a resolution not to further release water to Tamil Nadu, the combined water level in the four dams was 27.6 tmcft.

The districts in the Cauvery delta region in Tamil Nadu are receiving good rains. Thiruvannamalai, on an average, received rainfall up to 90 mm, while Thiruvallur received 80 mm rain, the sources pointed out. The north-west monsoon is yet to begin in Tamil Nadu. **DH News Service**

No breakthrough in Cauvery talks

NEW DELHI: A meeting chaired by Union Water Resources Minister Uma Bharti on the Cauvery impasse on Thursday failed to achieve a breakthrough in resolving the differences between Karnataka and Tamil Nadu over sharing the river water.

Tamil Nadu refused to accept Karnataka's suggestion that an expert committee should be sent to the river basin to assess the ground realities on the availability of water.

Instead, it demanded the release of water in accordance with the Supreme Court and the Cauvery Water Disputes Tribunal final orders.

Emerging from the meeting, Bharti said: "There was a request from the Karnataka government to our ministry to form an expert committee to assess the availability of water in the Cauvery basin. The Karnataka Chief Minister (Siddaramaiah) pressed for it. Tamil Nadu could not give its consent to the proposal."

Bharti, who headed the meeting on a directive issued by the Supreme Court, said ultimately a solution could not be achieved outside the court.

The issues raised by both the states have been noted down and they will be intimated to the court, she added. The apex court will take up the matter

Depleting storage in Mettur dam worries farmers

salem: With the Karnataka government refusing to release Cauvery water citing poor storage in all its dams despite Supreme Court direction, the depleting water position in Mettur dam has emerged as a matter of serious concern for both the farming community and the official machinery of Tami Nadu.

In the last 10 days since water was released from the Mettur dam on September 20 for commencing farm operations in the delta districts,

the water level in the dam has gone down by seven feet (from 87.68 feet to 80.49 feet on Thursday) and the storage level by 10 tmc (from 50.39 tmc to 42.447 tmc).

Usually, about 10 tmc of water is allowed for dead storage and drinking water purpose.

The balance available for farm operations is just 32 tmc as of now.

Assuming that there is no improvement in the realisation of water at the Mettur dam in the near future, the storage with the present discharge of 12,000 cusecs is ex-

pected to last only till the third week of October, Public Works Department sources said.

The dam has been real-

ising less than 1,000 cusecs of water for the past five days. The inflow into the dam on Friday was 738 cusecs.

The sources said that the Mettur dam should have realised water to the tune of 120.666 tmc from June 1 till the third week of September. But, it so far has realised only about 50 tmc, owing to the failure of monsoon in the catchment areas of the river.

Usually, water is released from July 12 to January 28 for raising paddy under the kuruvai and samba seasons every year.

The Tamil Nadu government ordered the release of water from Mettur dam after a delay of more than three months, when its level had reached 87 feet, pinning hopes on the Supreme Court and also on the setting of the monsoon. The hopes of the Tamil Nadu government and the farmers were dashed with the Karnataka government closing down the sluices of both Krishnagaraja Sagar and Kabini reservoirs in mid-September, citing non-availability of even for drinking purpose.

Rain boosts storage at reservoirs

CHENNAI: The city, which received its heaviest rainfall on a single day in September over the past decade on Wednesday, recorded its alltime high rainfall of 167.4 mm for the month on September 12, 1996.

Officials of the Meteorolo-Department said gical Uthiramerur in Kancheepuram district and Tambaram received 110 mm of rain on Wednesday night. It is the characteristic of thunderstorms to bring heavy rain during a short period.

Chennai's two main reservoirs in Red Hills and Chembarambakkam also received copious inflow. Heavy showers has helped sustain the combined storage of 2,042 million cubic feet on Thursday, enough to supply drinking water to the city for two more months.

The same weather trend is likely to continue as the department has forcast heavy rainfall in one or two places

predicts that the day temperature might stay close to the normal of 33 degree Celsius till Saturday in Chennai.

Defict bridged

The intermittent showers have bridged the deficit for Chennai, which has recorded 403.9 mm against its average

of 426.5 mm since June 1. The existing five per cent deficit in rainfall is considered normal. However, southwest monsoon rainfall over the State has seen a deficit of 23 per cent. Officials noted the shortfall may be compensated as there are still more than 10 days for the monsoon to withdraw.

Cauvery row: Gowda on hunger strike, seeks 'justice' for K'taka

BENGALURU, 1 OCT: Former Prime Minister H D Deve Gowda today began an "indefinite" hunger strike, seeking "justice" for Karnataka in the ongoing row with Tamil Nadu over release of Cauvery water.

The 83-year-old Janata Dal (Secular) supremo is sitting on fast near the Mahatma Gandhi statue next to Vidhana Soudha, the state secretariat here.

Gowda's sudden decision comes in the backdrop of the Supreme Court order yesterday, asking Karnataka to release 6,000 cusecs of Cauvery water till 6 October to Tamil Nadu and the Centre to constitute the Cauvery Water Management Board.

"We want justice. Drinking water is essential for humans to survive," Gowda told reporters here as he launched the hunger strike.

Asserting that he would con-

tinue his protest till Karnataka gets justice from the Union government, Gowda said he still has "confidence" in the Prime Minister that the issue will be resolved.

Gowda said he would not be attending the all-party meet

called by chief minister Siddaramaia later today to chalk out the next course of action in the light of the apex court order, which came as a huge setback to the state.

Home Minister G Parameshwara, who visited Gowda, said the former Prime Minister had always fought for the state's interests and added, "I hope it (the hunger strike) will open the eyes of the judiciary."

Mr Parameshwara said the Attorney General agreeing in the Supreme Court to the formation of the Cauvery Water Management Board also showed that "it (Union government) is also against us".

Taking Karnataka to task for its repeated "defiance"by flouting its orders, the apex court had yesterday asked it to release 6,000 cusecs water from tomorrow till 6 October to Tamil Nadu, warning "no one would know when the wrath of the law" would fall on it.

A bench of Justices Dipak Misra and U U Lalit had also directed the Centre to constitute the Cauvery Water ManagementBoard by 4 October.

Siddaramaiah is also holding a Council of Ministers meeting after the all-party meet.

"We repeat at the cost of repetition that we are passing this order despite the resolution passed by the Joint Houses of State Legislature of the State of Karnataka... We are sure that Karnataka, being part of the federal structure of this country, will rise to the occasion and not show any kind of deviancy and follow the direction till the report on the ground reality is made available to this court," it said.

The court further asked the Union government to set up by October 4 the Cauvery Management Board, which will make assessment of ground realities in the river basin areas and report back to the court by October 6.

Meanwhile, Attorney General Mukul Rohatgi informed the bench about the impasse, and said no breakthrough could be achieved in the meeting chaired by the Water Resources Minister and attended by the Karnataka chief minister and the Tamil Nadu

PWD minister.

Rohatgi agreed to the court's suggestion to constitute the Cauvery Management Board, as directed by the Cauvery Water Dispute Tribunal, by October 4. The bench directed Karnataka, Tamil Nadu, Puducherry and Kerala to nominate their members to the board by Saturday.

On his part, Tamil Nadu's counsel, senior advocate Shekhar Naphade, said, "We are not saying yes or not to any order of the court. We have been treated shabbily. Any order passed by the court is not going to be obeyed by Karnataka."

Karnataka's counsel, senior lawyer Fali S
Nariman, also apprised the bench of his communication with Chief Minister S
Siddaramaiah wherein the jurist has impressed upon the state to honour the court order and release the water. In response to Siddaramaiah's inability to do so, Nariman said he would not be able to make any submission on behalf of the state in the court.

At this, the bench said, "We must appreciate the stand taken by Nariman. This behoves the officer (all lawyers are treated as such) of the court in light of the tradition of the bar." The court will hear the case next on October 6.

Karnataka files review plea in SC, calls House session again

ON A day the Karnataka government moved a review petition in Supreme Court, seeking review of the court's order that asks the state to release Cauvery river water to Tamil Nadu, the Congress government in Bengaluru decided Saturday to convene another special session of the legislature Monday to decide the issue.

In the review petition, the Karnataka government reasoned that storage at its four reservoirs is insufficient to meet even drinking water requirements of Bengaluru city and towns.

It contended that the court passed the order even though Chief Minister S Siddaramaiah

has pleaded the impossibility of complying with the court's direction, as the situation is "beyond its control, and there is no intention to disobey the order".

The state also maintained that the court has erred in directing constitution of the Cauvery Management Board, as the issue been challenged under civil appeal. On an application by Tamil

Nadu, a three-judge bench had on December 3, 2013 said that the issue can wait and would be heard along with the civil appeal.

The Supreme Court had asked states in the Cauvery basin to nominate members for the Cauvery Management Board to be created by the Centre by October 4.

The court had also warned that Karnataka would have to face the wrath of the law if it continued to defy the court's orders.

"In the light of the resolution passed by the state legislature on September 23 against the release of water to Tamil Nadu until storage for drinking water improves in Cauvery reservoirs in Karnataka, and in the light of opposition leaders advising us to stick by the resolution not to release water, we have decided to convene a special session of the

legislature on Monday," Siddaramaiah said late Saturday after a cabinet meeting.

He said the special session is being convened because many leaders from the Cauvery basin had demanded release of water for farmers in the Cauvery basin in Karnataka during an all-party meeting held Saturday evening.

"As far as the release of water from the Cauvery reservoirs is concerned, we are going back to the legislature," Siddaramaiah said. "We had deferred the release of water in the Cabinet meeting on September 28. We will take the sanction of the legislature on this issue again. We have not wilfully defied the orders of Supreme Court. The decision to defer release of water was based on the resolution of the legislature."



Warming to breach 2°C limit by 2050

lobal average temperature could rise to two degrees Celsius above the norm — the point at which many scientists believe climate change will become dangerous — as early as 2050, a group of experts has warned.

In a report called "The Truth About Climate Change", they said many people seemed to think of global warming as "abstract, distant and even controversial". But the planet is now heating up "much faster" than anticipated, said Professor Sir Robert Watson, a former chair of the Intergovernmental Panel on Climate Change and one of the authors of the report. If their analysis is correct, the majority of people alive today will experience what it is like to live on a dangerously overheated planet.

At the Paris climate summit last year, world leaders agreed to try to limit global warming to 1.5 degrees celsius above pre-industrial levels as possible, amid concerns the 2 degrees celsius target may not be safe enough. But in the same year the level of warming reached 1 degree celsius after a 0.15 degree celsius

rise in just three years.

Droughts, floods, wildfires and storms are all set to increase as the world warms, threatening crops and causing the extinction of species. The new report warned the 1.5 degrees celsius target had "almost certainly already been missed". Even if all the pledges to cut emissions are fulfilled, the average temperature is set to reach that level in the early 2030s and then 2 degrees celsius by 2050, they said.

The report said an extra 0.5 degree celsius of warming was expected to take place because of greenhouse gases that have been emitted due to the slow response of the ocean and atmosphere. The experts called for drastic changes to the way the world produces and uses energy with a switch to electric cars among steps that should be taken quickly. THE INDEPENDENT

Met predicts rain on Tuesday

New Delhi: There is strong likelihood of rain in the capital and its neighbouring regions on Tuesday.

The Met department said that the showers may continue for two to three days. While the rain is expected to reduce humidity, it is feared that it may lead to an increase in mosquito breeding.

"Multiple spells of light rain are likely in Delhi/NCR from Tuesday to Friday. This is mainly due to an upper air cyclonic circulation over south Chhattisgarh and adjoining Vidarbha, which is affecting the weather system from west Rajasthan to west Madhya Pradesh. Also, a western disturbance is likely to affect northwest India from Wednesday," said a senior Met official.

On Saturday, the maximum and minimum temperatures in Delhi were recorded at 27 degrees Celsius and 36 degrees Celsius respectively. The rain predicted for next week will lead to a slight dip in temperature, the official added. "This is not good news. Rain

may cause another spurt in cases of mosquito-borne diseases," said Dr Rommel Tickoo, senior consultant, internal medicine at Max Hospital, Saket.

Dr K K Aggarwal, president-elect of Indian Medical Association said organisers of Ramlila and Durga Puja pandals should take extra care to ensure there is no stagnation of water. "The efforts of the

state government and corporations, which took up fogging and awareness initiatives, has led to a significant reduction of 15%-20% in dengue and chikungunya cases. We cannot afford to get slack now," Dr Aggarwal said.

This year, more than 5,000 people have been affected by dengue, chikungunya and malaria in city. Corporations claim six people have died due to malaria and four others have succumbed to dengue this season. Individual hospitals have, however, reported more than 30 deaths due to the mosquito-borne diseases.

SC orders Karnataka to release 5.7. 6,000 cusecs per day for six days

New Delhi, 30 September

Reiterating its order to shun its stance of continued defiance and 'fall in line'. the Supreme Court today directed the Karnataka government to release 6,000 cusecs of Cauvery river water every day to Tamil Nadu for six days, starting 1 October.

The apex court also directed the Centre to constitute the Cauvery Management Board by 4 October, and told Karnataka, Tamil Nadu, Kerala and Puducherry to inform the Central government of their nominees by 4 p m tomorrow.

The apex court said soon after it is set up, the CMB would visit the spot for an assessment of the ground situation and report back to it. A bench of Justices Dipak Misra and Uday Umesh Lalit expressed its displeasure over the continued defiance of its last three orders by Chief Minister Siddaramaiah's government in Karnataka.

The bench said, "The State of Karnataka should not be bent upon maintaining an obstinate stand of defiance."

The top court by its orders on 5, 12, 20 and 27 September had asked Karnataka to release water to Tamil Nadu. Except for first two orders which were partially complied with, the last two were met with total defiance.

Telling the Karnataka government that it was its "last chance" to fall in line, the bench said: "We are granting this opportunity as a last chance. We are passing this order despite assembly resolution," which practically said no release of water to Tamil Nadu.

"The State of Karnataka should not be bent upon maintaining a stand of defiance, where the wrath of law fall on them," it said in its order.

Without saying so, the court clearly implied that Karnataka was inching towards trouble. Justice Mishra told senior counsel Shekhar Naphade, appearing for Tamil Nadu, that they

"understand your anguish".

Naphade had told the court that: "We are not saying anything. We have been shabbily treated. There is nothing that the State of Tamil Nadu wants to place before the court. We are not saying anything."

At the outset of the hearing, Attorney General Mukul Rohatgi apprised the court of the meeting that Union Water Resources Minister Uma Bhatrti had with Karnataka Chief Minister Siddaramaiah and Tamil Nadu's PWD Minister Edappadi K Palanisamy in pursuance to the court's 27 September order to convene a meeting of the Chief Ministers to break the impasse.

He said at the end, the "the ball is back in the court" as during the meeting, Karnataka expressed its helplessness in releasing the water citing its problem of drinking water and standing crops, while Tamil Nadu stuck to its position that Karnataka had to fall in line and comply with the court's order on releasing Cauvery water.

CAUVERY ROW: K'TAKA TO HOLD ALL-PARTY MEET

Bengaluru,30 September

The government has convened an all-party meet here tomorrow to discuss the situation arising out of the Supreme Court's order to release 6000 cusecs of water daily to Tamil Nadu till 6 October. Besides, the apex court has urged the Centre to set up Cauvery Water Management Board at the earliest.

Both the issues will be discussed at the all-party meeting considering that the SC's order needs to be treated as a "fait accompli."

Earlier, such meetings had seen how there was unanimity over the non-release of water to the neighbouring state considering the distressed situation faced by Karnataka as the dams in the Cauvery basin were at a new low.

This apart, the government had got the much-needed backing from the law makers.

During a specially convened Assembly session this month, the state Legislature passed a unanimous resolution giving priority to meeting the drinking water needs of the IT Capital and the Cauvery basin region over the release to neighbouring Tamil Nadu.

Under the circumstances, despite its difficult situation, the Siddaramiah government cannot take a call on its own on obeying the court's order now. It has to once again seek the support of the Opposition, however, unimplementable it may find the direction.

Accordingly, the Siddaramiah government finds itself in a *Catch 22* situation considering that its



own lawyers have frowned over the government's decision against the release of water to Tamil Nadu, to go by available reports.

Importantly, the apex court is also not likely to take kindly to its orders being ignored repeatedly.

To cap it all, Siddaramiah did not get the much expected relief from the central government as the meeting with the Union water resources minister two ago did not yield anything.

Above all, the special

leave petition on the Cauvery water tribunal award is coming up before the apex court next month.

The Karnataka government would not want to go against the Supreme Court by continuing to go against its orders.

To that extent, the next few days will be crucial for the Siddaramiah government.

The only hope appears to be the encouraging spells of rains in parts of the catchment areas that the state has received in recent days.

This could help raise the water levels in its dams. More significantly though, the state would be banking on a good winter monsoon in Tamil Nadu in October. If that happens, all the immediate tensions may ease, at least for the time being.



Cauvery: K'taka moves SC, Opp hardens stand



NEW DELHI/BENGALURU, 1 OCT: The Karnataka government today moved the Supreme Court seeking a review of its order directing the state to release Cauvery water to Tamil Nadu even as it faced strident calls from Opposition parties not to release the water "at any cost". The Karnataka government filed a review petition in the apex court against its three recent orders on Cauvery water release to Tamil Nadu and direction for constitution of Cauvery Water Management Board by Centre saying it would cause "undue hardship" to the state.

In the petition, it said that "grave miscarriage of justice" has been caused to it pursuant to three orders of the apex court dated September 20, 27 and

September 30, by which it directed the state to release 6,000 cusecs of water till October 6 and constitution of board by Centre till October 4.

It said that apex court has "committed an error" in directing the Centre to constitute Cauvery Management Board, without considering the fact that three judges of apex court has held in 2013 that direction to constitute the board "can wait and may be heard along with the Civil Appeal".

"The court has not taken the cognizance of the fact that the constitution of the Cauvery Management Board, being Legislative in character, depends upon the authority exercising the power as well as the nature of the function and obligation arising from the Legislation", it said in the review plea. The plea said further water release orders from the reservoirs of Karnataka would "cause irreparable injury" to the state.



After drought, it's děluge: massive crop loss in Marathwada

BEED, PUNE, OCTOBER 2

WITH RAIN refusing to relent in the last two days, Marathwada, which is facing unprecedented flood-like situation, has suffered massive crop damage. According to initial official estimates, crop worth over Rs 500 crore has been damaged in at least three districts of Latur, Beed and Osmanabad, which had been under a severe grip of drought till recently for the fourth consecutive year.

In all the three districts, soyabean is the major crop, followed

by cotton, tur and moong. In Latur, crop on over 4 lakh hectares — sowing had been done on over 6 lakh hectares has been damaged. "Soyabean crop has suffered complete damage on 4 lakh hectares," said an agriculture official in Latur. Officials in the department put the loss at over Rs 300 crore. Manjara dam, the lifeline of Latur that had hit rock-bottom, is now 100 per cent full. All major rivers in the district are overflowing at present.

Nana Barde, a farmer and sarpanch of Masurdi village in Ausa taluka that was among the worst affected by drought in

Latur, said, "Over 400 farmer families, which had sown soyabean, tur, urad, til on 1,000 hectares of land have lost all the crop... For four years, we had severe drought and now this tragedy."

Beed District Collector Naval Kishore Ram said soyabean crop on 2 lakh hectares had been damaged. "Our initial estimation is that the crop worth around Rs 200 crore must have been damaged. But it is difficult to give out the exact figure," said Ram.

For the last couple of days, the officials claimed, the district administration had been busy rescuing people trapped in flood waters. "Scores of villagers, especially those living close to rivers, have been rescued in the last couple of days," said Ram.

Osmanabad district seems to be worst affected in Marathwada. District Collector Prashant Narnaware said his administration had been hard-pressed to bring the situation under control as all major dams were overflowing and rivers were in spate. According to initial estimates, Narnaware said, crop spread over close to 3 lakh hectares had been damaged. Sowing had been done on 3.5 lakh hectares. "But these are initial estimates... We estimate that the loss could be up to Rs 250 crore," he said.

Nanded Collector Suresh Kakani said crop loss in the district had been reported along the overflowing rivers. "Last night, we rescued 22 people near Limboti dam after there was discharge of water."

Both Ram and Narnaware said farmers should not worry as their crop had been insured. "We will carry out proper assessment and ensure that each and every farmer gets the insurance benefit," said Ram. Narnaware said the Kharif crop might have been lost but this rain would benefit the Rabi crop.

After a couple of days' lull, the pounding started rain

Marathwada from Friday. In the last two days, Latur, Beed and Osmanabad have received maximum rainfall.

All three districts, which were once worst hit by drought, have recorded over 100 per cent rainfall so far, with Beed receiving maximum 125 per cent rain.

In the last 24 hours, Latur has received 69.75 mm rain, followed by Beed (50.64 mm), Osmanabad (41.69 mm), Nanded (32.31 mm), Hingoli (38 mm), and Parbhani (29.9 mm).

Collectively, all eight districts in Marathwada have received annual average rainfall of 107 per cent.

Panel seeks more time to assess damage to Yamuna



NEW DELHI: The seven-member principal committee, headed by Water Resources Secretary Shashi Shekhar, has told the National Green Tribunal (NGT) that the tentative cost of rejuvenating the Yamuna riverbed — damaged due to a cultural extravaganza organised by the Art of Living foundation — can be calculated only after November as the area is still inundated by floodwaters.

The committee, set up by the green panel and comprising senior scientists from National Environmental Engineering Research Institute, IIT-D and other agencies, was given the task of conducting a survey to determine the cost of restoration and engage any specialised agencies for the purpose.

The NGT has put the matter up for consideration on October 7.

An NGT bench headed by Justice Jawad Rahim said: "We see the letter from Mr. Shekhar dated September 9, wherein he has mentioned that the task of conducting survey for determining the cost of restoration to the en-

vironment, ecology and biodiversity could not be completed due to non-favourable conditions."

'Completely destroyed'

Earlier, the panel had said that the 'World Cultural Festival' extravaganza, held in March this year, had "completely destroyed" the riverbed.

Sri Sri Ravishankar's Art

of Living had termed the NGT expert panel report as "unscientific and illogical" and sought a fresh probe by an "unbiased" panel.

The Art of Living foundation had to ultimately deposit Rs.4.75 crore as "environment compensation" with the Delhi Development Authority as directed by the NGT for damaging Yamuna's biodiversity.
