# CAUVERY WATER ROW: SC TO HEAR KARNATAKA'S PLEA TODAY

NEW DELHI: On Sunday, the Supreme Court agreed to conduct an early hearing on Monday on Karnataka's application seeking a direction to reduce the quantum of water to be released from Cauvery river to Tamil Nadu from 15,000 cusecs to 1,000 cusecs.

The Supreme Court's decision to hear the plea, filed late on Saturday evening, came after it was mentioned before the court's registry which consulted Chief

Justice TS Thakur.

In its plea, Karnataka has sought modification of the apex court's September 5 order for release of 15,000 cusecs of water for 10 days as immediate relief to Tamil Nadu farmers.

Karnataka's advocate V N Raghupathy said that the matter was mentioned before the registry on Sunday and it would be heard on Monday at 10.30 am.

Karnataka's decision to move the Supreme Court comes ahead of the Cauvery Supervisory Committee's meeting on Monday to decide on the quantum of the river's water to be released to Tamil Nadu and other states.

The application has sought that instead of 10 days, the apex court should restrict the release of water to only 6 as the state itself was facing a distress situation due to a massive agitation which was causing a loss of ₹500 crore per day to Karnataka.

In the plea, Karnataka has said there was "huge public pressure" and the state police, with great difficulty, have been able to prevent attempts to damage public property.

"Even the minimum arrangement mentioned by your lordships has caused distress and havoc in the entire southern part of Karnataka, paralysing civil life. The agitation of farmers has been that their dry crop is equalled with that of the farmers in Tamil Nadu. Tamil Nadu's need for the rice crop consumes more than twice the water which is needed for light crops in Karnataka," the



## BJD plans rallies against Polavaram 🗓

Janata Dal (BJD) on Sunday announced to stage massive demonstrations against execution of the Polavaram multi-purpose irrigation project by the Centre and Andhra Pradesh governments even as the matter was pending before the Supreme Court.

The project would submerge 15 revenue villages and 10 habitats, displacing 6,818 villagers, mostly tribals, from their ancestral land, senior BJD leader Surya Narayan Patro said addressing a press conference here on Sunday.

The project would also snatch livelihood from tribals, said Mr. Patro.

Although the Odisha government had time and again drawn the attention of the Centre for reconsideration of the project in view of adverse impact on tribals, the State's plea was never given due emphasis, he said.

Moreover, permission from the Union Ministry of Tribal Affairs is a prerequisite for any project that affects vast tribal population, but in case of Polavaram, the project executing authority never felt necessary to do so before going ahead with the project, said the BJD leader.

The BJD demanded that the permission granted by the MoTA on April 17, 2007, should be scrapped and the height of the embankment be

brought down.

"Since Independence, Odisha has been constantly ignored by the successive central governments. Polavaram is another project in which the Centre has overlooked our interests. When the matter is pending before the apex court, the Centre has taken biased stand and extending its unwavering support to the project," said Mr. Patro.

The party has decided to stage a massive demonstra-

tion before Raj Bhawan here on September 14 and similar demonstrations would be held in seven southern Odisha districts on the same day.

The State government said it would wait for the direction of the Supreme Court to conduct public hearing for construction of protective embankments along river Sabari and Sileru as part of Indira Sagar Polavaram project to avoid submergence even though the Centre had been insisting to do so.

The Odisha Government, through the State Pollution Control Board, has already conveyed to the Ministry of Environment and Forest and Climate Change that it would not hold public hearing for the controversial Polavaram project.

The Centre has been asking the Odisha government to expedite conducting public hearing as Andhra Pradesh has been requesting the Ministry to do so.

## Both cheer, anger among Mandya farmers

JOHNSONTA

MANDYA, SEPTEMBER 9

AROUND 3 PM on Friday, Prakash Gowda, a farmer in Doddamalagoda village near Mandya town, was busy supervising the release of Cauvery water into his 1.5-acre paddy farm. All round him, farmers were doing the same — checking the water channels into their fields.

With Karnataka releasing Cauvery water to both Tamil Nadu and the Cauvery delta farmers in Mysore and Mandya regions, the water, released on Thursday from KRS dam some 50 km away, reached the farms in Doddamalagoda Friday afternoon.

"I was taking part in a protest over release of water to Tamil

Nadu when I heard KRS water had reached our farms. I reached here immediately...the crop has sprouted and it now needs ample water," said a beaming Prakash Gowda.

Barely 10 km away, the water

channels from the Cauvery are all dry and farmers are fuming in villages such as Hitnahalli in Malavalli taluk of Mandya.

"It takes about three days for water to reach our village. We left our land fallow this year because we had learnt there could be a shortage of water. And it is too late now (for cultivation)...we have to look at other sources of income," said Nanjunde Gowda.

At Mikere village near Mandya, Rudrappa, 52, standing guard at his 2-acre paddy field filled with water, said, "After releasing water to Tamil Nadu they (government) are now saying they will give water to locals farmers. Had they said this earlier, more farmers would have cultivated their land this monsoon season."

#### CM writes to PM

Bengaluru: Karnataka CM Siddaramaiah wrote to Prime Minister Narendra Modi Friday and sought his intervention. He asked Modi to convene a meeting of the chief ministers of the two states to resolve a dispute over sharing Cauvery water, which has come to a boil on account of water shortage in the river's catchment areas due to deficit rains.

## Monsoon retreats in its last leg, rainfall deficit 16%

Reservoir situation improves, barring Karnataka, TN

NEW DELHI, SEPTEMBER 11

After raining havoc over many parts mid-way through the season, the four-month Southwest Monsoon seems to have retreated in its last leg.

During the week ending September 8, the country registered an overall 16 per cent deficiency, fuelled by 50 per cent shortfall in northwest, 38 per cent in central parts and 30 per cent in south where, incidentally, two states — Karnataka and Tamil Nadu — are locked in a bitter water war, the underlying cause of which, many feel, is continuing monsoon deficiency.

The IMD expects June to September rains to pick up over many parts of central and adjoining north peninsular India from September 12, though whether it will make up the deep shortfall in some parts, including Karnataka, remains to be seen.

#### Reservoir levels in North

The six reservoirs in Himachal Pradesh, Punjab and Rajasthan currently have a live storage of 14,24 BCM -79 per cent of their total storage capacity. The storage during corresponding period of last year was 90 per cent and average storage of past 10 years in the same period was 81 per cent. In other words, levels in the current year are all right but they are less than corresponding period of last year and also less than average storage during the past 10 years

Northwest, which has done comparatively better this season with a two-per cent surplus to date, may also see light rainfall over many parts from September 12 onwards, says the IMD.

Though a better monsoon this year has improved levels of the 91 major reservoirs of India, those in the southern region are still not as good as the average storage of past 10 years during the corresponding period.

The southern region has 31 reservoirs under the Central Commission Water Andhra Pradesh, Telangana,

Karnataka, Kerala and Tamil Nadu. Currently, they are 44 per cent full of their total live storage capacity.

This is an improvement over last year when the storage was 32 per cent, however, it is far less than the average storage of past 10 years during the corresponding period, which is 72 per cent of the live storage capacity.

In other words, better rains this year have improved water levels in parched southern parts but the situation is not as good as it should have been had the rains been well distributed.



## Evolve Cauvery distress formula

The unresolved dispute over sharing of Cauvery river waters with the neighbouring Tamil Nadu has once again come to haunt Karnataka. With the failure of monsoon this year, Karnataka was already reeling under a severe water crisis and a heavy demand on its scarce reserves was the last thing it wanted. But, with the Supreme Court directing the state to release 15,000 cusecs of water per day over the next 10 days (around 13 TMCft or thousand million cubic feet), Karnataka has begun complying with the order "with a heavy heart, despite severe distress and hardship" being faced by the state. Karnataka has done well to honour the judicial order. The decision, however, has caused a lot of heartburn among farmers in the Cauvery basin, who had been told last week that water supply to their standing crops on 20,000 acres was being temporarily suspended to conserve water for drinking purposes. The state government has since reversed this decision. Emotions are running high and the road traffic between Bengaluru and Mysuru has been disrupted by angry farmers. The state government has appealed for calm, which should be heeded and there should be no room for violence.

The crux of the problem is that the Cauvery Water Disputes Tribunal which took 16 years to come up with its final award in 2007, failed to evolve a 'distress formula' to be adopted during years of water shortage.



When there is bountiful rainfall. nobody complains and in fact, a lot of fresh water drains out into the sea, as it happened in 2014. Karnataka has faced one of the worst droughts this season and KRS. the main reservoir, has only 17.86 TMCft as against its full capacity of 47 TMCft with bleak prospects of any additional inflow until next June. As Cauvery is also the main source of drinking water for a population of around 130 lakh in Bengaluru, Mysuru and other urban pockets in the region, the state may be forced to adopt curtailed supplies to tide over the situation.

Now that the Supreme Court is

seized of the matter, it should go beyond issuing interim orders. The Tribunal had asked the parties to the dispute to share the deficiency on a pro rata basis, but did not offer a concrete formula. A time has come for the apex court to settle this issue to the satisfaction of all concerned. The court should ask the Central Water Commission, which has all the technical expertise, to come up with a formula taking into account the water status in various reservoirs in the Cauvery basin, and pronounce a judicial order binding on all the states. That, hopefully, will remove some of the uncertainties.

As per indications, all the four riparian states are separately planning to challenge the verdict in the Supreme Court.

Maharashtra and Karnataka had moved the Tribunal stating that it should allot water to the two Telugu states only from allotment made to united AP, and should not drag them into the fresh distribution plea since everything had been decided

by the Tribunal in 2013.

Almost two and a half years later, on Thursday, all the four state governments and the Centre concluded their replies, counters and arguments before the Tribunal.

Now the question before the Tribunal whose verdict is considered equal to a Supreme Court judgement, is whether Section 89 of AP Reorganisation Act will apply to two or four states.

According to sources, if it decides it is confined to the two Telugu states, both states will challenge it in the apex court. In case the Tribunal states that it is applicable to four states and orders for a review of water allocation, Karnataka and Maharashtra will approach the apex court.

## UVULLIYIL to work out water sharing xx

### Permanent formula soon to tide over crises

Ajith Athrady

**NEW DELHI, DHNS: With in**ter-state disputes over sharing of river waters on the rise, the Centre is working on a permanent distress sharing formula to tide over failure of rainfall or low storage in reservoirs.

Union Water Resources Secretary Shashi Shekhar, in his recent presentation to officials of the Prime Minister's Office on water and related issues, stressed the need for a distress sharing formula in the event of low water storage in dams.

A comprehensive distress sharing formula taking into account rainfall, storage in reservoirs, drinking water needs, ry, had suggested adopting a ground water table in river basin areas and cropping pattern, besides diversion of water by upper riparian states, is being prepared by the Ministry of Water Resources, a senior official of the Ministry told *DH*.

There is no distress sharing formula at present among states at loggerheads over sharing of water, but in crisis situations the Central Water Commission recommends sharing of available water among the

states in dispute. "Instead of an ad hoc formula, the government wants permanent solutions based on scientific data," said the official, adding that if required the relevant Act will be amended. If permanent distress sharing formula exists, needless litigation over sharing of water in crises could be avoided, the official noted.

"In a good rainfall year, there is no problem. Problems arise when there is deficient rainfall. We must be ready to tackle the situation when there is failure of rainfall," he said...

The Cauvery Water Dispute Tribunal (CWDT), in its final award on sharing Cauvery river water among Karnataka, Kerala, Tamil Nadu and Puducherscientific method for collection of data of water, including rainfall in the catchment areas of rivers. Though the CWDT had said riparian states should share the water proportionately in distress years, it did not issue any guidelines for distress sharing. The draft National Water Framework Bill prepared by Ministry of Water Resources emphasises on resolving water disputes at an early stage through negotiations.

# File review petition for 96 tmcft of water, says Karunanidhi

chennal: DMK leader M. Karunanidhi on Saturday urged Chief Minister Jayala-lithaa to file a review petition in the Supreme Court seeking a direction to Karnataka to release 96 tmcft of Cauvery water and for the formation of the Cauvery Management Board and Cauvery Water Regulation Committee within a timeframe.

"There is no point in relying on the Cauvery Monitoring Committee as it has

no legal powers to put pressure on State governments. In Chief Minister Jayalalithaa's words it is a 'toothless tiger'," he said and called upon the Chief Minister to adopt a transparent approach on the issue.

Mr. Karunanidhi said the State government should not fully accept the direction of the Supreme Court to Karnataka to release 13 tmcft of water and should file a review petition as Karnataka also would file a review petition in the Supreme Court.

He pointed out that Karnataka Chief Minister had convened an all-party meeting to discuss the issue and led a delegation to meet Prime Minister Narendra Modi to present the case of his State.

"He also held an urgent meeting of the State Cabinet and shared information with the media. But in Tamil Nadu one has to wonder whether a government is in place at all. The farmers are keenly watching the next move of the State government," he said.

### Karnataka seeks change in SC order

KRISHNADAS RAJAGOPAL

NEW DELHI: Succumbing to political pressure and the wave of public protests, the Karnataka government on Saturday filed a plea to modify a Supreme Court order directing it to share Cauvery water with distressed neighbour Tamil Nadu.

In a move depicting its urgency, the Karnataka government's legal team knocked on the door of the Supreme Court 'Judicial Registrar's home around 10.30 p.m. and handed over its modification application to the official.

The plea, for an urgent hearing in the matter, will be placed before Chief Justice of India T.S. Thakur, who in all likelihood would refer it to a Bench led by Justice Dipak Misra.

#### Interim order

It was Justice Misra's Bench which had on September 5 passed the interim order for release of 15,000 cusecs of Cauvery water to Tamil Nadu.

Karnataka lawyers went the extra mile to have the petition heard urgently because the Supreme Court is on leave on both September 13 and 14.

The application said that 66,000 cusecs of water had already been released to Tamil Nadu as a goodwill gesture from September 5 till September 10.

It said the water is for storage purpose in Tamil Nadu while Karnataka is reeling under a drinking water crisis. The application said the order had caused great distress to the public and ordinary farmers of Karnataka was in a turmoil.

## Karnataka seeks change in SC order

It said the samba region of Tamil Nadu had sufficient supply of ground water for cultivation.

The apex court had ordered Karnataka to release 15,000 cusecs of Cauvery water for a period of 10 days to the State to feed its parched agricultural lands in the "interests of justice."

The decision to direct Karnataka to part with 15,000 cusecs of water for the stipulated period came shortly after the apex court had urged it to embrace the principle of "live and let live." It had advised Karnataka to take steps to release Cauvery water to distressed Tamil Nadu to help the latter continue to "exist as an entity."

The court noted that Tamil Nadu had suffered deficit for three straight months in June, July and August this year.

apex court's intervention to release 50.052 tmcft of Cauvery water from Karnataka's reservoirs. It had accused Karnataka of diverting precious river water meant to be a lifesaver for Tamil Nadu farmers during distress years for undeclared projects in violation of the final orders of the Cauvery Water Disputes Tribunal in 2007.

The application said the State had not even received the 10 daily/monthly releases of Cauvery water for the months from June 1 to August 19, 2016, causing a cumulative shortfall of 50.052 tmcft at Biligundlu.

## K'taka hopes for relief as Cauvery panel meets

#### TN Too Requests Committee To Ensure It Gets Its Share Of Water

Bengaluru / Mandya: The Karnataka government is working overtime to script a fool proof legal strategy to help it get a good deal when the Cauvery supervisory committee meets on Monday to decide the quantum of water to be released to Tamil Nadu.

"We cannot afford to make any mistake this time. We'll apprise the supervisory committee headed by waresources secretary Shashi Shekhar about the distress situation in the state and strongly convince it about our inability to release water," a senior irrigation department official said.

The meeting in New Delhi will be attended by the chief secretaries of Karnataka, Tamil Nadu, Kerala, Puducherry and officials of the Central Water Commission.

While Tamil Nadu has requested the committee to ensure it gets its share of water in accordance with the Cauvery Water Dispute Tribunal (CWDT) order, Karnataka has

made a plea to the committee to modify the order in the backdrop of falling storage levels in its four reservoirs in the Cauvery basin. Though there was no official statement from the government on its strategy, pressure has been mounting on the Siddaramaiah government, especially in the backdrop of the recent Supreme Court directive to release 15,000 cusecs of water for ten days to Tamil Nadu.

The Siddarammaiah government came under fire for voluntarily telling the apex court it would release 10,000 cusecs of water to Tamil Nadu. Kannada organisations, which called for a Karnataka bandh on September 9, have given a call for a rail bandh on September 15 while the opposition BJP has started blaming chief minister Siddaramaiah for botching up the state's strategy in the row.

After touring Mandya district, BJP state president B S Yeddyurappa said: "It was nothing but sheer negligence on the part of the state government and the battery of advo-

## Mandya farmers try to storm KRS reservoir

Karnataka bandh peaceful; Mysuru comes to a halt; people stranded in Bengaluru airport

Mandya district, the epicentre of the Cauvery agitation in Karnataka, saw protests intensifying on Friday when the State observed a bandh called by many Kannada organisations and farmers' unions. The situation reached a flashpoint when the police burst teargas shells and resorted to lathi-charge near the Krishnaraja Sagar (KRS) to disperse a large number of farmers who attempted to lay siege to the reservoir. A few farmers even tried to plunge into the Cauvery elsewhere in the district, but were rescued.

Tension gripped the area around the KRS for a while when police took many protesters into custody. They were, however, released later.

#### **RAF** deployed

The police had put up barricades besides deploying Rapid Action Force personnel and the civil police, anticipating protests around the KRS. The protesters attempted to break the police security to enter the premises of the reservoir. The police burst a few rounds of teargas shells to scare away the protesters.

The entire district was shut for the fourth consecutive day on Friday. The district has been seeing continued protests since the Supreme Court directed Karnataka to release Cauvery water to Tamil Nadu on Monday. Traffic was completely blocked on the Bengaluru-Mysuru National Highway on Friday too. The protesters, however, did not stop the movement of ambulances, sugarcane lorries and bullock carts.

#### Bandh impact

The entire Mysuru district came to a grinding halt and bore the full impact of the bandh. The bandh, which was by and large peaceful, evoked total support from business establishments, chamber of commerce and industry, and hotel and restaurant owners' association, among others.

At the Kempegowda International Airport in Bengaluru, parking lots and pick-up and drop-off lanes were unusually empty, in stark contrast to the waiting area, which was bustling with people. Though the airport functioned on Friday, the absence of transport saw hundreds of people stranded with no way to get to the city.

For Kai Aunze from Germany, his first visit to Bengaluru entailed a long wait at the airport. Scheduled to

start an internship with a private company at Electronics City, he had arrived around 8 a.m. to find the taxi stand empty. "We have been trying to find a hotel nearby to stay. But, we can't find one," he said, visibly tired. Similarly, Thupten Gelek, a Tibetan monk heading towards Bylakuppe, attempted to engage a taxi, in vain.

For those who managed to find a cab driver brave enough to ferry passengers, albeit for a premium, there were multiple hurdles along the way. Hari Prasad, who works at a hotel, had arrived from Vishakapatnam by flight. He managed to find a driver willing to drive him and others to Old Airport Road for Rs. 700 each. The driver decided to take the "back route" through Devanahalli towards Old Madras Road. However, there were multiple road blocks by activists that saw Mr. Prasad being stranded in rural Bengaluru. It was only after the police dispersed the protestors, that they were able to take another circuitous route to the city.

#### Vehicle pile-up

To add to the chaos, many travellers anticipated problems in getting to the airport and ended up arriving hours before their scheduled flight. Traffic police said there was a vehicular pile-up for kilometres between 4 a.m. and 6 a.m.

Even though their flight to Riyadh was to take off on Friday afternoon, M. Pradeep and his friends arrived at the airport from Kozhikode at 7 p.m. on Thursday.

"We thought we would rather wait at the airport through the night than take the chance of missing our flight," he said.

## Monsoon retreats III its last leg, rainfall deficit 16% Reservoir situation improves, barring Karnataka, TN

NEW DELHI, SEPTEMBER 11

After raining havoc over many parts mid-way through the season, the four-month Southwest Monsoon seems to have retreated in its last leg.

During the week ending September 8, the country registered an overall 16 per cent deficiency, fuelled by 50 per cent shortfall in northwest, 38 per cent in central parts and 30 per cent in south where, incidentally, two states — Karnataka and Tamil Nadu — are locked in a bitter water war, the underlying cause of which, many feel, is continuing monsoon deficiency.

The IMD expects June to September rains to pick up over many parts of central and adjoining north peninsular India from September 12, though whether it will make up the deep shortfall in some parts, including Karnataka, remains to be seen.

#### Reservoir levels in North

The six reservoirs in Himachal Pradesh, Punjab and Rejasthan currently have a live storage of 14.24 BCM -79 per cent of their total storage capacity. The storage during corresponding period of last year was 90 per cent and average storage of past 10 years in the same period was 81 per cent. In other words, levels in the current year are all right but they are less than corresponding period of last year and also less than average storage during the past 10 years

comparatively better this season with a two-per cent surplus to date, may also see light rainfall over many parts from September 12 onwards, says the IMD.

Though a better monsoon this year has improved levels of the 91 major reservoirs of India, those in the southern region are still not as good as the average storage of past 10 years during the corresponding period.

The southern region has 31 reservoirs under the Central Commission Water Andhra Pradesh, Telangana,

Northwest, which has done Karnataka, Kerala and Tamil Nadu. Currently, they are 44 per cent full of their total live storage capacity.

This is an improvement over last year when the storage was 32 per cent, however, it is far less than the average storage of past 10 years during the corresponding period, which is 72 per cent of the live storage capacity.

In other words, better rains this year have improved water levels in parched southern parts but the situation is not as good as it should have been had the rains been well distributed.

The application filed late last evening has also sought modification of the apex court's 5 September order in which it directed release of 15,000 cusecs of water for 10 days as an immediate relief to Tamil Nadu farmers.

Karnataka's decision to move the Supreme Court comes even as the Cauvery Supervisory Committee is meeting here tomorrow to decide on the quantum of the river's water to be released to Tamil Nadu and other states.

Karnataka has stated that there has been huge public pressure and the state police, with great difficulty, have been able to prevent attempts to damage public property.

The application states Athat "Even the minimum arrangement mentioned by your lordship has caused distress and havoc in the entire southern part of Karnataka, paralysing civil life. The agitation of farmers has been that their dry crop is equalled with that of the farmers in Tamil Nadu. Tamil Nadu's need for the rice crop consumes more than twice the water which is needed for light crops in Karnataka," the application said.

The application has stated that people, particularly farmers have been squatting on the roads and streets, affecting the IT industry in Bengaluru which earns revenue as income tax, service tax, and foreign exchange of USD 60 billion to the country.

BENGALURU: Many dead cat fish were seen floating on the done. The lake is full of sewage polluted Varthur Lake, in East Bengaluru on Wednesday.

Experts point out that this was an sign that the lake is beyond repair now. But officials said they were unaware of the fish kill.

Jagadish Reddy Nagappa, a resident of Varthur said he fish. He said the matter will be found dead catfish floating on investigated immediately. the lake during his morning walk on Wednesday. The government gives funds to develop the lake. Pollution should be managed by the Karnataka State Pollution Control Board. So far, we have not taken up any development work. We have told the Bangalore Water Supply and Sewerage Board that unless sewage entry into the lake is DH News Service

stopped, no restoration can be and not even 10% of it is fresh water," he said.

G Vidyasagar, CEO, Karnataka Lake Conservation and Development Authority said he too was unaware of the issue. He also expressed shock over the presence of the banned cat-

Prof TV Ramachandra from the Centre of Ecological Sciences, IISc, who studied the lake, said this was a sign that the lake had crossed its threshold. Catfish can survive even in harsh environment since they come out of the water, breathe in, and go back into the water.

"The level of dissolved oxygen in the lake was zero in some places and 2.5 in other places, against the normal value of five. The macrophytes have covered most of the lake leading to fish kill," he said.

KSPCB officials who visited the lake said that there was no oxygen left in the lake. Since it rained two days ago, the dead fish came floating to the surface. A thorough investigation and sample analysis will be undertaken.

BENGALURU: Most parts of Karnataka, especially Bengaluru and Mysuru, shut down on Friday in response to the State-wide bandh called in protest against the Supreme Court order to release Cauvery water to Tamil Nadu.

While arterial roads in Bengaluru were blocked with burning tyres by activists, there were no major incidents of violence, and the bandh was largely peaceful across the State.

A large group of protesters had to be dispersed with force and tear-gas shells when they attempted to storm into the KRS reservoir premises in Mandya district, from where Cauvery water is being released to Tamil Nadu.

With buses, autos and cabs off the road, and even the Bengaluru Metro service coming to a standstill, hundreds of these coming in or going out of the city by air and rail had to face severe difficulties.

The Kempegowda International Airport resembled a crowded bus terminus as hundreds of passengers waited for long hours either before or after their flights. Even those with late evening flights had

## Cheap data can usher in green revolution 2.0

## Govt Programmes Aiding Farm Output Will Help Only If Farmers Can Access Such Info On Mobiles

New Delhi: Prospects of cheap internet data might have taken political overtones with politicians getting into the 'atta' (wheat flour) verses 'data' debate, but availability of cheap and fast data has the potential to increase farm productivity and farmers' incomes.

India's space agency Isro's ongoing programme of predicting site suitability for a particular crop, cropping intensity, early-season crop forecasting, soil texture, moisture as well as agricultural water management will show desired results only when farmers can access these information on their smart phones.

"The country's space ag-

ency can even assess if a particular crop can be planted in a particular site. But dissemination of such information to each and every farmer in the country remains a big challenge. The government's initiatives through Digital India programme will help, provided farmers can afford internet data on their mobile phones and access those vital inputs," said an official involved in the programme.

Thoughalot of such information is being shared through various 'krishi vigyan kendras' (agriculture science centres) across the country, farmers still don't get fast and accurate farm and cropspecific solutions to their problems on the ground.

they can send farm pictures, including of weeds and infected portion of crop fields, to scientists and get quick solutions on their phones.

Crop science division of global crop protection and seed giant Bayer AG has started testing its digital tool in India. The idea behind 'digital farming' is to help farmers identify pests, diseases and weeds down to the square metre of their farms and provide them with solutions to enhance yield and farm profitability.

The company last week demonstrated its 'digital farming' tool during the 'Future of Farming Dialogue 2016' in Leverkusen, Germany. Responding to **TOI**'s question on how such tools would work in India where a majority of

farmers have small landholdings, head of Bayer's crop science division Liam Condon said a lot of testing was going on to find out the rights solution for them. Condon said the testing was being done in India to find out how mobile-phone technology could combine with the outreach programme and how it could be used in smart and simple ways to help the company solve problems of farmers.

During the Farming Dialogue, experts explained that digitalisation could give farmers timely field-level information for selecting right inputs, including fertiliser or crop protection dose, determining the ideal time for crop protection steps and recognising plant stress factors at an early stage.

केंद्रीय जल संसाधन मंत्रालय शशिशेखर की अध्यक्षता में होने वाली इस बैठक में कावेरी बेसिन में इस साल बारिश की कमी, जलाशयों में उपलब्ध पानी की मात्रा, पेयजल की जरूरतों व फसलों की सिंचाई के लिए आवश्यक पानी की मात्रा के आंकड़ों का विश्लेषण किया जाएगा। जलसंकट के हालात को ध्यान में रखकर कावेरी नदी के तटीय राज्यों की जरूरतों के मुताबिक इपलब्ध पानी का बंटवारा किया जाएगा।

अमेरिकी अंतरिक्ष एजेंसी नासा ने सैटेलाइट तस्वीरों के जरिए दावा किया है कि इस साल बिहार में आई बाद अब तक की सबसे भयंकर बाढ़ों में से एक है। नासा ने राज्य के बाढ़ प्रभावित क्षेत्रों का नक्शा जारी किया है।

रिपोर्ट में बताया गया है कि सबसे खराब हाल 15 अगस्त से 1 सितंबर के बीच रहे। इस दौरान गंगा और उसकी सहायक नदियों ने आसपास के इलाकों को अपनी चपेट में ले लिया। विशेषज्ञों के मुताबिक बाढ़ आने का एक कारण


नदी के किनारे जमी गाद का होना भी है। नदी के साथ जो जो रेत और मिट्टी बहकर आती है उनसे नदियों का जल स्तर बढ़ जाता है और बहाव में रुकावट आती है। हालांकि नासा का कहना है कि इस साल 'ला नीना' ज्यादा सक्रिय

एशिया में 'ला नीना' का सीधा असर मानसून पर पड़ता है। 2010 में ला नीना के कारण ही बिहार में भयंकर बाढ़ आई थी।

### प्रतिम कोर्ट के आदेशों का पालन करेगी कावेरी समिति

नई दिल्ली, (भाषा): न्यायास्य के निर्देश पर कावेरी निगरानी समिति तमिलनाडु और अन्य राज्यों को छोड़े जाने वाले नदी जल की मात्रा तय करने के दौरान कावरी जल विवाद न्यायाधिकस्म (सीडक्यूडीटी) के अंतिम आदेश वार्य अधिकारी ने यह जानकारी दी है। केंद्रीय जल संसाधन सचिव शशि शेखर की अगुवाई वाली समिति तमिलनाडु और अन्य राज्यों को छोड़े जाने वाले कावेरी के पानी की मात्रा तय करने के लिए कल बैठक करेगी। वरिष्ठ अधिकारी का बयान ऐसे समय में आया है जब कर्नाटक ने समिति द्वारा अपना आदेश जारी करने से पहले कावेरी बेसिन की हकीकत का पता लगाने के लिए केंद्र से एक विशेषज्ञ समिति भेजने का अनुरोध किया है। अधिकारी ने कहा-हम एक निरीक्षण टीम नहीं भेज सकते क्योंकि वह उच्चतम न्यायालय के आदेश का हिस्सा नहीं है। यह स्पष्ट तौर पर कहा गया है कि समिति को कावेरी जल विवाद न्यायाधिकरण की भाषा का अक्षरशः पालन करना होगा। समिति उच्चतम न्यायालय के आदेश का पूर्णतः पालन करेगी।पांच सितंबर को अपने अंतरिम आदेश में शीर्ष अदालत ने कर्नाटक से तमिलनाडु को अगले दस दिनों तक रोजाना कावेरी का 15000 क्यूसेक पानी देने को कहा था, जिसके बाद कर्नाटक के कई हिस्सों में प्रदर्शन शुरू हो गया।

अदालत ने तिमलनाडु को भी न्यायाधिकरण के फैसले के मुताबिक कावेरी का पानी छोड़े जाने के लिए तीन दिन के अंदर निगरानी समिति से संपर्क करने को कहा था।
