# Plea in SC seeks action against fringe elements

LEGAL CORRESPONDENT

NEW DELHI: The Supreme Court on Wednesday agreed to urgently hear a petition seeking a judicial direction to the governments of Karnataka and Tamil Nadu to "control" and act against the fringe elements which orchestrated violence in both States following the apex court order to release Cauvery water.

#### Infringement of rights

A Bench led by Chief Justice of India T.S. Thakur scheduled the petition for hearing on Thursday after advocate N. Rajaraman, appearing for P. Sivakumar, a resident of Kanyakumari district in Tamil Nadu, said widespread destruction of public and private properties had led to the infringement of fundamental rights to life and movement in the two States.

Petition asks court to direct the States to act against outfits that "incited parochial sentiments"

The petition has arraigned the Union Home Ministry, State Home Ministries of Karnataka and Tamil Nadu, Police Commissioners and the Chief Election Commissioner as respondent parties.

The plea has sought the apex court to direct them to take measures to prevent escalation of violence.

#### Direction sought

The petitioner wanted the court to direct the two States to "act" against parties like Kannada Rakshana Vedike, Kannada Chaluvali Vatal Paksha and Tamizhaga Vaazhvurimai Katchi for "inciting regional parochial sentiments."



## Karnataka leaders review damage

BENGALURU: Two days after violence brought many parts of standstill, Karnataka to a Siddara-Minister Chief maiah, who had sought a meeting with Prime Minister Narendra Modi over the Cauvery issue, said he was still awaiting an appointment.

#### 'Awaiting appointment'

"The Prime Minister has not given me an appointment yet," said Mr. Siddaramaiah, who had written to Mr. Modi seeking his intervention to resolve the water dispute between Karnataka and Tamil Nadu. He said water storage in Karnataka's reservoirs was poor and it could not afford to release any more water.

Home Minister G. Parameshwara reviewed the persons die, a few shops redamage to the city, while the mained open. Despite police

At Hegganahalli, where Monday's violence saw two persons die, a few shops reasking them to keep the shutters down for a few hours, shopkeepers said they could not afford to absorb any more losses. The Mysuru Road, too, saw the slow opening of stores near the Satellite Bus Stand. In other

parts, business was as usual, with traffic jams being reported in most major junctions.

Mr. Parameshwara conducted an inspection of the riot-hit spots, including Hegganahalli. He interacted with the residents of Jai Bheema Nagar where stone pelting affected the livelihood of residents, and at the private bus depot in Hoskerehalli where 39 buses were torched or damaged.

In the wake of a call from a few Kannada outfits for a "rail roko" on Thursday, police said they had taken steps to ensure that trains ran normally.

## No early hearing on canal row: SC

HANSI-BUTANA Apex court to take up case on November 7

NEW DELHI, SEPTEMBER 14 The Supreme Court today rejected Haryana's plea for an early hearing of its dispute with Punjab and Rajasthan over the 109km Hansi-Butana canal and made it clear that the case would be listed in due course.

A Bench comprising Chief Justice TS Thakur and Justice AM Khanwilkar said there was no need for an out-of-turn hearing as already there was unrest in Karnakata on the dispute over sharing Cauvery river water with neighbouring Tamil Nadu.

The law and order situation cropped up in Tamil Nadu following SC's order last week directing Karnataka to release 15,000 cusecs of water for Tamil Nadu, which was subse-12,000 cusecs a day till hearing as the evidence

In April 2014, Haryana had pleaded for using the canal under eight conditions, including a strict watch by a retired SC Judge/Chief Justice as well

as the Bhakra Beas Management Board (BBMB), to meet the drinking water and irrigation needs of its

drought-prone areas.

Haryana had said it was also ready to take its share of water only after Punjab and Rajasthan got their due from the Bhakra Main Line (BML) and this would allay apprehensions over possible misuse of the canal for drawing excess

water from BML. Rejecting the proposal, Punjab said this was nothing but old wine in a new bottle and the plea had considered and been rejected by various SC Benches.

## Apex court order harsh on state, but will obey it: Siddu


**BENGALURU: Chief Minister** Siddaramaiah on Tuesday said the State has to obey the Supreme Court order to release Cauvery water to Tamil Nadu though injustice has been rendered to Karnataka.

He said that Karnataka has always faced injustice in the Cauvery issue and the same is continuing. Karnataka had obeyed the Supreme Court order to release water in 1995, 2002 and 2012-13.

"At no point of time any government in the state had defied the court order," he stressed. indirectly saying that he was doing what his predecessors had done in the time of crisis.

Siddaramaiah was addressing the media along with Home Minister G Parameshwara after the meeting of council of ministers and a meeting of senior Congress leaders here.

The Supreme Court on Monday ordered the state to release 12,000 cusecs of Cauvery water every day to Tamil Nadu until September 20, modifying its previous order that the state has to release 15,000 cusecs until September 16. As per the court's interim—and in the federal system, it is order, an additional 18.000 cusecs of water has to be released to Tamil Nadu. This takes the total quantum of water to be released to 1.68 lakh cusecs from the earlier 1.50 lakh cusecs. Direction to release 18,000 cusecs of addition-

al water is a big blow to Karnataka, he said.

The chief minister said the court order is harsh on the state and it is difficult to follow it. But under the Constitution difficult to set aside a court order. "We have come to the conclusion after lengthy debates both at the council of ministers meeting and a meeting of the party leaders. We have to execute the judicial order," he said.

Arguing that the court's in-

terim order of Tuesday is not final on the water sharing issue, Siddaramaiah said that Karnataka's special leave petition would be heard by the Apex Court on October 18.

The petition has challenged the final order of the Cauvery Water Dispute Tribunal, issued in February 2007 on water sharing among the riparian states.

Siddaramaiah reiterated that his government would ensure drinking water to Ben-

## Cauvery basin to get real-time water flow monitoring system

NEW DELHI: The Union Ministry of Water Resources is working to instal modern technology to monitor water data in the Cauvery basin areas within one year to end the dispute on the availability of water in the states.

Union Water Resources Secretary Shashi Shekhar, who chaired Cauvery Supervisory Committee on Monday, said that all the four basin states -- Karnataka, Tamil Nadu, Puducherry and Kerala -- will share the cost of installing the equipment proportionally.

The equipment, which will be installed at different points in Cauvery basin areas of all the four states, will collect the data including rainfall in basin states, inflow into reservoirs, outflow from reservoirs, release of water to irrigation canals and drawing of water for drinking purposes.

The data centre will be under the direct control of the Central Water Commission which will in turn report to the Cauvery Supervisory Committee. However, all data collected will be shared among all the states on a real-time basis.

tablish the inflow to reservoirs. The final order of the Cauvery Water Dispute Tribunal is nataka stated that poor rainbased on inflow," Shashi Shekhar said.

Once the installation of new technology is completed, the

Supervisory Committee will take a decision on release of water by upper riparian states to lower riparian states as well as irrigation canals.

The Supervisory Committee will regulate the release of water till the Cauvery Management Board or any other equivalent authority set up as per the Cauvery Water Dispute Tribunal, said an official from the ministry.

At the Supervisory Committee meeting held on Monday, which was attended by chief secretaries of all the riparian states, Central Water Commission officials made a presentation about the proposed mechanism to be adopted for monitoring the water situation in the basin area.

#### 'New mechanism'

"The new mechanism will also help check whether any states illegally withdrew water from reservoirs," said the official.

At the Supervisory Committee meeting, Tamil Nadu officials are learnt to have expressed concern over the "unauthorised" withdrawal of water by Karnataka.

However, Karnataka countered this, saying that they never withdrew water illegally "The network will help es- and said depleting levels of its reservoirs due to the release of water to Tamil Nadu. Karfall in the basin areas was also a reason for low storage in reservoirs.

## Monsoon may withdraw soon

**NEW DELHI:** Southwest Monsoon could start withdrawing in the next 3-4 days, the India Meteorological Department (IMD) on Tuesday said even as the overall rainfall deficiency increased to 5%.

"Conditions are becoming favourable for withdrawal of Southwest Monsoon from some parts of West Rajasthan during next 3-4 days," the IMD said.

#### Advanced withdrawal

The normal withdrawal of monsoon from West Rajasthan is September 1. Interestingly, it is also the frontiers where monsoon reaches last and withdraws first.

Cessation of rainfall activity over the area for continuous 5 days, establishment of anticyclone in the lower troposphere and considerable reduction in moisture content are the three major factors that determine the withdrawal of the seasonal rainfall.

Meanwhile, the overall monsoon deficiency has reached to around 5%. From June 1 to September 13, the country as a whole has recorded 759.9 mm of rainfall as against 802 mm of precipitation, which is the normal level. The monsoon deficiency has reached to 13% in east and northeast India while the deficiency has reached up to 12% in southern peninsula.

Situation is better in Northwest India where the deficiency is just 2%.

#### Rain in coastal AP, Telangana

Heavy rains triggered by a low pressure trough around north coastal Andhra Pradesh and Odisha lashed the coastal districts and parts of Telangana, including Hyderabad, on Tuesday, reports DHNS from Hyderabad.

Overflowing streams in catchment areas have left several low-lying areas inundated, bringing normal life to a halt. PTI



## Did local media add fuel to Cauvery fire?



TV channels are in the dock over the large-scale violence that swept India's IT capital over the Cauvery water dispute earlier this week, with critics alleging they fed mob hysteria for better TRPs.

One popular Kannada channel went to the extent of hailing arsonists as 'brave Kannada activists'. Some others magnified the violence as 'justified acts of defiance' against a court ruling that deprived Karnataka of its rightful share of Cauvery waters.

"Iam aghast," lamented Girish Nikam, a news anchor with Rajya Sabha TV. "They have stopped doing journalism and have become agent provocateurs."

The tone of the TV anchors got shriller as violence escalated.

They began to describe the physical assaults as "beaten to pulp", "mauled", "hammered" and "thrashed". Some of them added fuel by claiming that Kannadigas attacked in Tamil Nadu were denied treatment in hospitals.

Dr Niranjan Vanalli, profes-

sor of Journalism and Mass Communication at the University of Mysore, says many of the channels took an overtly simplistic and macho tone without realising the serious implications of their coverage. "Why are media persons acting like they are the judiciary?" But sanity was in short supply at the peak of the violence and several TV anchors got carried away.

"This happens every time Jayalalithaa comes to power. What have we done to her that she troubles our farmers so much? She has forgotten she was born in Karnataka and Mysore royals had provided shelter to her and her mother," one news anchor railed.

Media experts say the competitive jingoism on TV channels began after a Tamil engineering student was beaten up for allegedly mocking Kannadiga actors on social media. The footage was broadcast on loop and one channel claimed the attackers were 'justifiably enraged'. Passions rose soon after and hours later, a Kannadiga-owned hotel was petrol-bombed in Chennai.



According to IMD, the southwest monsoon has been active over Uttarakhand, Bihar, Vidharbha region and Chhattisgarh. Heavy rains occurred at isolated places over Bihar, Nagaland, Manipur, Mizoram and Tripura.

Bihar received light to moderate rain at most places in the northwest, northeast and southwest parts, with Patna recording 133.8 mm rain since last night, paralysing normal life and several areas of the city

# Karnataka CM decides to release water to safeguard state's case

Bengaluru: Karnataka chief minister Siddaramaiah on Tuesday announced the state would abide by the Supreme Court directive to release 12,000 cusecs of Cauvery water per day to Tamil Nadu until September 20.

"Though is very difficult for us to follow the Supreme Court order, we cannot violate or reject it. We are bound by the constitutional framework, and will have to abide by the SC order issued on September 12. We will have to release water to Tamil Nadu," Siddaramaiah told reporters here after a cabinet meeting convened to discuss the repercussions of the SC order and Monday's violence in Bengaluru.

Siddaramaiah, a Mysuru native, was personally not in favour of releasing water given the distress situation in the Cauvery catchment area. A few of his cabinet colleagues suggested the government violate the SC order and score brownie points in the politically volatile Old Mysuru region. Kannada organizations and farmers' groups have been putting pressure Siddaramaiah against releasing water. But he chose not to defy the SC

order, which mandates Karnataka to release an extra 18,0000 cusecs.

"Not releasing water as per the SC directive will not augur well for the government as well as the state. If the Siddaramaiah government were to defy the SC, it can be hauled up for contempt of court. Even Article 356 of the Constitution can be invoked to dismiss the government. This apart, Karnataka cannot be labelled a rogue upper riparian state in the run-up to the final hearing on October 18 of the special leave petition challenging the Cauvery Water Disputes Tribunal Award of 2007," said a source.

Siddaramaiah appealed to the people not to resort to violence, and said the state will hone its legal strategy and present a strong case when Cauvery Supervisory Committee meets on September 19 and when the SC takes up the issue again on September 20.

The CM maintained that injustice has been meted to the state since the beginning of the Cauvery dispute. "The orders the Supreme Court passed on September 5 and 12 have not gone in our favour. However, we still have confidence in the judiciary and our team will continue the legal battle."


# SC rebukes Karnataka, alters order on water release to TN

NEW DELHI: Karnataka on Monday suffered a major setback with the Supreme Court castigating it over "disturbing and totally deprecable" language used in its plea to raise issues of agitation and law and order problem to seek modification of the order for releasing Cauvery river water to Tamil Nadu.

Though the apex court modified its September 5 order by reducing the quantum of per day release of water from 15,000 to 12,000 cusecs, it extended the number of days of giving water to Tamil Nadu from September 5 to 15 upto September 20. Thus, the order would make Karnataka end up releasing more water.

Observing that the people cannot become a law unto themselves, the court directed the inhabitants of both Tamil Nadu and Karnataka to be-

have properly and maintain law and order.

Taking up an urgent plea by Karnataka on a day of vacation, a bench of Justices Dipak Misra and U U Lalit minced no words in pulling up Karnataka, saying, "Law and order situation can't be the ground for modifi-

cation or keeping in abeyance an order of the court."

"Citizens cannot become law unto themselves. When a court of law passes an order, it is duty of the citizens to obey the same. If there is a grievance, they are obligated under the law to take legal remedy," the bench said. "Order of the court has to be complied by all the concerned. It is obligation of the executive to see that the order is complied in letter and spirit. Concept of deviancy has no room and disobedience no space," the bench said. "Agitation on spontaneity or galvanised by any kind of catalyst component can never form the foundation for seeking modification of the order," it said.

Appearing for Karnataka, senior advocate F S Nariman expressed regret over the affidavit on behalf of the state and sought direction to keep the September 5 order in abeyance. He submitted that Karnataka has so far released 84,168 cusecs of water, despite facing enormous problems, including shortage of drinking water and law and order situation.

Karnataka would not be able to sustain its drinking water needs, he said, pointing out that Tamil Nadu faced no agony as contended earlier by it since only 1,250 cusecs of wa-

ter was drawn from the Mettur reservoir since September 5 when Karnataka started releasing water. Nariman said there is a mismatch between the demand and use of water by Tamil Nadu.

Senior advocate Shekhar Naphade, representing Tamil Nadu, contended there is an attempt to deny what is due to the state. The Cauvery Water Disputes Tribunal award is clear, if there is a deficit, it has to be proportionate but they (Karnataka) want to appropriate water unilaterally, he stated. Naphade submitted Karnataka did not supply the water due to Tamil Nadu for the months of June, July and August.

The bench, which put the matter for further consideration on September 20, concurred with the contention of Tamil Nadu that the law and order situation cannot be a ground for seeking modification of the court's order or keeping it in abeyance.

# Monsoon may withdraw in four days, says IMD

NEW DELHI: The southwest monsoon could start withdrawing in three or four days, the India Meteorological Department (IMD) said on Tuesday. The overall rainfall deficiency has, however, increased to 5 per cent.

"Conditions are becoming favourable for withdrawal of southwest monsoon from some parts of western Rajasthan during next 3-4 days," the IMD said.

The normal date of with-drawal from the region is September 1. Interestingly, it is also the frontiers where monsoon reaches last and withdraws first. Cessation of rainfall activity over the area for continuous five days is a major factor that determine the withdrawal of the monsoon. — PTI
