# Thunderstorm activity likely till September 20

Sudden dip in day temperature in Cuddalore, Tiruttani and Vellore

SPECIAL CORRESPONDENT

With the State set to receive moderate rain for three more days, residents can look forward to more pleasant days. An upper air cyclonic circulation is expected to trigger thunderstorm activity till September 20, according to meteorologists.

Rainfall on Sunday provided a break from sultry weather in many places. Thanjavur recorded the highest volume of rainfall – 11 cm – during the 24 hours ending 8.30 a.m. on Monday followed by Poonamallee with 7 cm.

Several places such as Chennai, Cuddalore, Tiruttani and Vellore saw a sudden dip in the day temperature due to overnight showers.

In Chennai, the weather stations in Nungambakkam and Meenambakkam recorded a maximum temperature of 30.5 degrees Celsius on Monday as overcast sky acted as a heat shield.

Officials of the Meteorological Department said the upper air cyclonic circulation over central Bay of Bengal may further develop into a low pressure area by Tuesday.

Director General of Meteorology, Chennai, said this weather system was expected to aid developing of thunderstorm activity for the next three days. Moderate rain is likely in many places across the State, particularly in interior and north Tamil Nadu. There is a chance for isolated heavy rainfall too.

"We are monitoring the weather system that indicates to become a depression and move towards north Andhra Pradesh and south Odisha coast," he said.

Though September is described to be second summer, the last few days were relatively warm due to clear sky condition in Chennai. The city will have a generally cloudy sky for two days and experience few spells of light to moderate rain.

Fishermen have been warned against venturing into the sea for three days as gusty winds are likely along and off the Tamil Nadu and Puducherry coasts.

Meanwhile, residents of a few localities in Anna Nagar Western Extension complained of waterlogging because of missing link in stormwater drain network.

K. Dharmalingam, a resident of East Main Road, said the colony was inundated on Monday with water flowing from the SWD that had not been connected to the nearest waterway.

## Soon, Energy Projects may Undergo Green Checks

KEEPING TABS Govt-approved auditors will do random compliance monitoring of environment clearance conditions at mines, power plants etc

New Delhi: The government plans to make projects such as power plants, mines and oil and gas exploration ventures and expansion initiatives subject to checks by independent auditors to ensure they are complying with environmental conditions and prevent the kind of public protests that erupted in Tamil Nadu over the Vedanta group's copper unit earlier this year.

The government-approved auditors will conduct randomised. third-party compliance monitoring of environment clearance conditions, according to a draft notification of environment ministry. This will be effected by the environment ministry introducing a new rule in Environment Impact Assessment Notification of 2006, which will allow it to empanel agencies for carrying out such studies.

"Notwithstanding the above provisions, the ministry will empanel government institutions of national repute for carrying out compliance monitoring of environment clearance conditions of projects and activities," according to the proposed rule, under paragraph 10 on Post-Environmental Clearance Monitoring.

"The compliance monitoring will be done inter-alia against the baseline information available in the Environmental Impact Assessment report, Environmental Management Plan appraised by EAC (Environmental Audit Committee), terms and conditions of the environmental clearance as well as other provisions as may be specified by the ministry from time to time.

Any project categorised as A, B1 or B2-graded thus as per industry and size of project - requires environmental clearance. Based

on recommendations of expert committees at central, state and district levels, prior clearance is given along with stipulations on environmental mitigation measures. Every firm or project proponent is required to file sixmonthly compliance reports.

There are currently no safegu-

ards to check whether these environmental clearance conditions are being adhered to on ground.

"These environmental compliance measures are vital as they mitigate or minimise adverse environmental impact of the project and activities," a senior environment ministry official told ET.

### Capital's Fuel Price Advantage over Noida, Ghaziabad Evaporates



New Delhi: Delhi's filling stations may no more be the preferred destination for drivers from Noida and Ghaziabad as the recent oil surge has eroded the Capital's price advantage. A

price difference of ₹3-4 per litre had encouraged drivers for years to fill up at Delhi's pumps. But tax rates in Uttar Pradesh and Delhi have become nearly equal. Delhi's petrol prices have surpassed that of Noida and Ghaziabad. On Tuesday, a litre of petrol cost ₹81.82 in Noida. ₹81.69 in Ghaziabad, and ₹82.16 in Delhi, Diesel rates were ₹74.10 per litre in Noida. ₹73.96 in Ghaziabad and ₹73.87 in Delhi. sanueevchoudhary

"Be it a small mining project or a nuclear power plant, mitigation measures need to be followed."

The new rule also comes after sharp criticism by the Comptroller and Auditor General (CAG) last year of India's environment clearance processes. CAG had audited projects cleared between Ja-

nuary 2011 and December 2015 and pointed out that despite clear environmental violations not a single project had been penalised. It had recommended that the environment ministry should consider third-party evaluations once projects, including expansion plans, get off the ground.

## Sagarmala stuck slow lane

Only one in five projects completed since FY16

ess than a fifth of the ambitious Sagarmala project has been completed since it was launched three-and-a-half years back, revealed a Right to Information (RTI) query.

When the Union Cabinet approved it on March 25, 2015, it envisaged projects worth ₹8.7 trillion that would connect 600 ports. The 80-odd projects completed till now are already valued at ₹140 billion. Another 212 projects worth ₹2.5 trillion are still under way. The National Perspective Plan of Sagarmala envisions the potential to save around ₹210-270 billion through coastal shipping of 230-280 million tonnes per annum of key commodities such as coal, cement, fertilisers, iron and steel, food grains, and POL (petroleum, oil and lubricants) by 2025.

The Ministry of Shipping has spent ₹7.73 billion since 2015-16 (FY16) for the Sagarmala projects. Another ₹1.3 trillion has been spent to provide railway and road connectivity to the ports.

There are 12 major ports in India: Kandla, Mumbai, Jawaharlal Nehru Port Trust, Mormugao, New Mangalore, Ennore, V O Chennal Cochin. Visakhapatnam, Chidambaranar, Paradip, and Kolkata (including Haldia). The project has also identified 1,208 islands for development.

Ports handle 90 per cent of the country's export-import cargo by volume and 70 per cent by value. Gujarat caters to 25-30 per cent of the cargo traffic. Connecting coastal areas to ports was planned as proximity brings down logis-

The Sagarmala project is being funded by the government through various ministries and agencies as well as private sources.

The scheme also aims to provide access to new regions and enhanced connectivity with main economic centres and beyond through expansion of railways, inland waterways, coastal, and road services.

Sagarmala also supports port-led development through appropriate policy and institutional interventions, port infrastructure enhancement, including modernisation, and setting up of new ports, and efficient evacuation to and division."

The scheme focuses on industrialisation in the proximity of the ports and development of community living. Projects promoting coastal tourism and cruise tourism are also part of the Sagarmala programme.

The government intends to increase the share of coastal shipping in domestic cargo movement, currently only 7 per cent. Better infrastructure for coastal shipping in terms of handling facilities will decongest railway and road networks, besides ensuring cost competitiveness and effective multi-modal transportation solution.

However, the shipping ministry did not answer the RTI query on land acquisition issues that port projects are facing. Its answer was: "Information sought for is not available with the Sagarmala

# A flying start for drones

India's new regulation for the use of Unmanned Aerial Vehicles that opens the door for foreign players could be a boon for developing the capabilities of local players

o finally, the much-awaited drone policy has been put into place. With this, the so far dormant segment has now opened up a whole new world of opportunities as well as challenges.

Opportunities because it opens up doors to different segments that offer a variety of applications which were hitherto unthinkable. Challenges are because the policy brings in intense competition for domestic firms as it uncovers the market to global drone makers and providers. It also requires them to burn cash in the short term to meet new technological requirements such as integrating features like obstacle avoidance and barometers, among others.

But as a whole, most of the local startups operating in the space believe that India's new regulation for the use of Ummanned Aerial Vehicles (UAVs), popularly known as drones, is expected to provide a big impetus to the sector.

"Even though India already had a drone ecosystem, it has had to do only with the government — either defence or large infrastructure projects. But now, there's going to be a need to improve the scope of application. This will bring in a lot of competition for us,

whether for good or bad," says Pradeep Palelli, founder of Hyderabad-based drone maker, Thanos Technologies.

Like any other fast-emerging sector, be it ecommerce, ride-hailing, Artificial Intelligence or blockchain, Indian firms will need to make their products globally competitive if they want to win here. So far, a lot of innovation has happened in India's drone ecosystem, but it runs the risk of being done in a silo, not on par with what the rest of the world has to offer.

Palelli says this isn't the case in certain scenarios, such as agricultural uses of drones, in which Thanos plays a large role. In terms of specifications, Palelli says while the drones that Thanos builds might not be offering the best applications when compared with that of the leading drones in this space, they are nevertheless quite close. The reason, he says, is Thanos often ends up using imported components due to a lack of a manufacturing ecosystem in India, meaning the company uses some of the same parts that their competitors do.

However, what Indian drone companies have really excelled in is doing design in-house. Several aviation experts have now started drone companies, and are pushing the boundaries of what these machines can do, making them comparable to any global offering. Kota Harinarayana, a former DRDO scientist who led the designing of India's Light Combat Aircraft (Tejas), also believes in the power of drones and has, together with a few colleagues, started General Aeronautics, a

drone startup that is incubated out of the Indian Institute of Science (IISc) in Bengaluru.

General Aeronautics has even done some of the design work for a high-lift-capable unmanned helicopter, but says, owing to the expense of building a prototype (£100-150 million) it has not actualby got to it just yet. However, with the policy in place, Harinarayana and his partners expect that it won't be too much of a hassle to raise the funds now for taking up the project.

"We have done some design work, but these vehicles would cost £100-150 million each to make, which a startup like ours can't afford. But we are looking for someone to fund us," said Harinarayana.

One of the main reasons domestic drone startups have been working largely under the radar so far is the lack of investment into the space. Investors have been wary of backing players in a sector that did not have any clarity on the regulation front. The few players who did get some bit of financial backing, are largely in the defence and surveillance space.

But this is changing quickly. In the time since the drone policy came out, Vipul Singh, co-founder and director of Aarav Unmanned Systems, a drone startup, says investors he had spoken to in the past have started reaching out to the company, seeking their plans to raise money.

'We couldn't raise investments because they

were not clear in which direction the market was going. Now, the overall perception of investors has changed in the last one week; it was immediate. Even globally, it is now known that India has an ecosystem and there's a clear-cut regulation for drones here, "said Singh, an aerospace engineer who co-founded

Aaraw with two others in 2013.
The drone policy experts say is heavy on regulation, since there's a huge safety and security implication, but doesn't necessarily stifle innovation or the possibility of new use cases. For example, while drones won't be allowed to discharge or drop any objects, an exception has been made for their use in agriculture where they could possibly be used to spray pesticides or other chemicals.

Moreover, for a company to think of new ways to use drones, the policy sets a viable framework for them to disclose this and once approved they will be able to carry out work freely.

Far-fetched ideas such as drone taxis, delivery drones for e-commerce or even medical use might not have been given the greenlight yet, but experts and players in the industry say that the new policy is a stepping stone for an explosion of private sector industries to adopt and come up with new ways of using drones.

### COERCIVE CHARITY

Kerala government's attempt to force employees to contribute for flood rehab contrasts with voluntary spirit seen during relief

HESE ARE TRYING times for Kerala as it struggles to recover from the devastating floods that drowned large parts of the state in August. The government estimated the economic loss due to the floods at over Rs 20,000 crore: Much of the infrastructure in the flood-affected districts will need to be rebuilt and standing crops in thousands of hectares have been destroyed. A massive voluntary effort involving thousands of ordinary citizens had boosted the state's rescue operations during the floods and limited the loss of lives to about 300. A similar collective public action has facilitated the raising of funds and collection of material for the rehabilitation of flood victims and rebuilding of public infrastructure as well as private assets including houses. It is in this context that Kerala Chief Minister Pinarayi Vijayan backed a proposal from some quarters in the civil society that salaried employees voluntarily contribute a month's salary to the chief minister's relief fund to enable resource mobilisation for rebuilding Kerala. However, the proposal, as it took the shape of a government order, has assumed coercive features. On Monday, the Kerala High Court, hearing a petition against Travancore Devaswom Board, observed that the "salary challenge" has lost its voluntary spirit and seems to be becoming an act of money-grab.

While the court has stayed the action of Malabar and Travancore devaswom boards to make salary contributions to flood relief compulsory, the state government could do well to rethink its proposal. The government order had clarified that contributions were not mandatory, but it also insisted that employees reluctant to contribute should inform the government in writing. This attempt to create a paper trail of an employee's reluctance has shades of moral shaming and hence should be deemed a coercive act. Floods did not make a distinction between government and non-government employees. A large number of Kerala's five lakh plus state employees were affected as overflowing rivers and crumbling hills wreaked havoc on homesteads and livelihoods. Not many of them are so well-paid or rich enough to afford to let go of a month's salary, even if spread over 10 months as the chief minister indicated, for flood rehabilitation even if they wish.

In fact, forcing people to cough up cash could kill the spirit of voluntary action that has so far driven the relief and rehabilitation efforts in the state. The move may also affect consumer spending: Retail trade in the state has already taken a hit after the floods washed away the Onam shopping season. Surely, the state government can think of more inventive evenues for resource mobilisation than unfairly squeeze a captive workforce.



### Blending subsidy with investment

Union Finance Minister

Speaking at the launch of a book, 'Supporting Indian Farms the Smart Way', he said with the formalisation of economy, the "government would have adequate resources to spend on different sectors, including the agriculture sector."

"There is lot of formalisation of economy taking place in several other sectors... We can see visible results, and it is leading to additional resources in the hands of the government. I don't think this process will now be reversed," he said.

Important areas which required investment include

physical infrastructure, social sector and farm sector, he said.

"I do see a point in blending subsidy support with the investment because to have a model which sustains indefinitely only on subsidy will not be a sustainable model. Investments will make farm sector self-sufficient. With much lesser subsidies, a self-sufficient farmer may be able to serve the cause of agriculture much better."

Over the last two years of normal monsoons and record harvests, prices of several commodities have crashed, hurting many farmers. The government has ramped up procurement of pulses and oilseeds in an effort to ensure that more farmers receive the minimum support price (MSP) for these crops even as the

market rates fall, but that has led to a shortage of storage capacity.

"We are holding 44 lakh tonnes of pulses, 57 lakh tonnes including oilseeds," S.K. Verma, executive director of the National Agricultural Cooperative Marketing Federation of India (NAFED), said. "In States like Rajasthan, Maharashtra, Gujarat and Madhya Pradesh, there is no space left in

the godowns." Warehouse capacity is making some States consider the new Central scheme to pay oilseed farmers the cash differential between MSP and market prices. A ministry official told *The Hindu* that Madhya Pradesh and Gujarat have expressed interest in opting for the scheme, which was approved by the Union Cabinet as part of a wider ₹15,053 crore procurement policy.

## Monsoons claimed 264 lives in Himachal this year, says CM

SHIMLA, 18 SEPTEMBER CT 19

Himachal Pradesh has suffered losses to the tune of ₹1217 crore due to excessive rains, flash floods and cloud bursts in Monsoons this year, which claimed 264 lives, including 199 deaths due to road accidents caused by damaged roads.

Disclosing this at a meeting to review the Monsoon related losses from 1 July to 17 September in 2018, chief minister Jai Ram Thakur said as many as 33 cloud bursts ad 391 landslides took place in the state, which resulted in huge losses in Himachal.

He said ₹ 229.64 crore have been released for restoration and repair of damaged infrastructure.

The CM said that Public Works Department suffered maximum losses of ₹735 crore due to rains in form of damages to roads, bridges, breast walls, retaining walls etc.

He said that it has been observed that although maximum damages were due to heavy rains but unplanned



dumping of debris was also another cause of damages to the roads.

He said that proper dumping sites must be identified and it must be ensured that the debris was disposed off in the marked and identified places. He said that effective cross drainage and side drainage facilities should be maintained to ensure proper drainage system.

Thakur said that Irrigation and Public Health Department also suffered losses of Rs 328.78 crore.

Several major, medium and minor drinking water supply and irrigation schemes had been damaged due to landslides and heavyrains. The

agriculture and horticulture sectors also suffered a loss of ₹88.81 crore while power sector suffered a loss to the tune of ₹24.50 crore.

He said that one company of NDRF had been positioned at Nurpur in Kangra district besides daily monitoring of water level in major rivers was also being ensured. For the first time, landslide sensors were installed at Kotrupi and Aut in Mandi for early warning of landslides to avoid any untoward incidents.

The CM said that state government would soon submit memorandum of losses and damages to the Government of India for financial assistance.

Apart from this, we have to conduct biodiversity surveys and patrolling. This is not possible without proper equipment and infrastructure."

Krunesh Garg said: "The expenditure listed by the Wildlife Department, including release of fish seed, boats and binoculars, must be explained... The rejuvenation project needs to be reviewed."

Kahan Singh Pannu, the then PPCB chief, in his orders dated May 24 had pointed out lapses on part of Chadha Sugar Industries and ordered that the mill be sealed. A case was filed against the mill and a fine of ₹5 crore slapped as "environmental compensation", which the PPCB claimed was the highest ever in the state. The orders said the fine would be "utilised for conservation and restoration" of Beas' ecology.
