Ravi flows into Pak as Centre reviews water treaty

– ---Solution lies in Shahpur Kandi dam, but project hangs in balance due to objections by J&K govt

Department engineers have
showed their concern over

the flow of the Ravi waters to Pakistan downstream Madhopur Headworks in Pathankot district.

They want that the work on the Shahpur Kandi dam project be resumed to stop the flow of water to Pakistan, besides bringing more area under irrigation in Jammu region and enhancing the irrigation capacity in Punjab.

The Ravi water was to be pooled at the proposed balanc-

ing reservoir by raising the dam with an estimated cost of Rs 800 crore at Shahpur Kandi, about 11 km downstream the Ranjit Sagar dam.

Half of this reservoir was to be made in Punjab territory and the other part in Jammu and Kashmir. The land for the project was acquired years ago and the Centre was to fund 90 per cent of the project. However, following objections by the J&K Gov-

ernment, the work was suspended two years ago.

Consequently, whenever excess water is released from the Ranjit Sagar dam in the Ravi, especially during summer months, a good amount of water flows to Pakistan via Madhopur Headworks in the absence of a balancing reservoir at Shahpur Kandi.

Dr GS Dhillon, former chief engineer, Irrigation Department, said: "The bal-

ancing reservoir should have been completed even before the Ranjit Sagar dam."

In summer, when the demand for power goes up, all hydro-power units installed at the Ranjit Sagar dam are made operational. To operate turbines about 15,000 cusecs of water has to be released. Of this, 12,000 cusecs is released into the Upper Bari Doab Canal and Madhopur-Beas Link

Canals at Madhopur Headworks and the remaining flows to Pakistan.

The J&K Government has taken the plea that since the Punjab Government has terminated the River Waters Sharing Agreement in 2004, the previous agreement relating to the Ranjit Sagar dam and Shahpur Kandi dam between Punjab and Jammu and Kashmir too have become defunct.

Jammu and Kashmir has suffered losses due to the Indus Water Treaty (TWT) with Pakistan and should be compensated by the Centre, Chief Minister Mehbooba Mufti said today, two days after India decided to "exploit to the maximum" the water of Pak-controlled rivers.

"Today, many things are being talked about. There is a talk of IWT... We are facing losses on account of IWT. We should get compensation and we cannot ask Pakistan for that but our own country. Whatever we get, be it our power projects or anything, we should get," she said at a function here.

Under the Treaty, which was

Release 6k cusec water to TN: SC orders K'taka

Centre To Call CMs Of Both States For Meet

New Delhi: The Supreme Court sternly ordered Karnataka on Tuesday to release 6,000 cusec of Cauvery water daily to Tamil Nadu till Friday. The ruling came after it appeared that an Assembly resolution backing Siddaramaiah government's dogged defiance of the court's earlier order to release the water seemed to have dented SC's dignity, endangered rule of law and hurt federalism.

"We are sure Karnataka shall obey the order without any kind of impediment, obstruction or any other attitude till we take up the matter on September 30," a bench of Justices Dipak Misra and UU

Lalit said. "Karnataka shall follow the order passed by us. We ingeminate (reiterate) and repeat that the direction for release of water has been passed for the coming three days despite the (Assembly) resolution," the bench said, brushing aside Karnataka's unwavering stand that it would be difficult to release water in the face of the As-

Finding itself in a spot over the vexed water dispute, the bench looked to attorney general Mukul Rohatgi for a resolution. It clutched to the AG's suggestion that the Centre would attempt a resolution of the thorny issue by facilitating a meeting of the chief ministers of the two states engaged in a water war. With both states willing, the AG said the Centre would convene a meeting between J Jayalalithaa and Siddarama-

iah in the next two days. The court will hear the issue on September 30.

Appearing for Karnataka, senior advocate Fali Nariman said the Assembly resolution stood in the way of the government in releasing any water to Tamil Nadu as the state faces acute shortage of drinking water. "Assembly's direction could not be defied as it was also a Constitutional authority like the Supreme Court," he said. Karnataka admitted there was 42,000 cusecs deficit in release of Cauvery waters to TN.

Hoping the situation will ease by Friday, the bench made it known to the states that it was adjourning the hearing till September 30 by accepting the AG's suggestion and not because it found it difficult to deal with the situation arising out of Karnataka's defiance to release water to TN.

No decision yet to suspend Indus panel

NEW DELHI: India has not yet taken a decision to suspend but was in the process of "reviewing" its decision to stay on in the Indus Commission, according to water resources secretary Shashi Shekhar, who was part of the team that briefed Prime Minister Narendra Modi on Monday on India's continued ticipation in the Indus Water Treaty.

India's Indus Commissioner P.K. Saxena is in Washington to discuss with World Bank officials India's position on the Kishenganga hydropower project, an older dispute going on with Pakistan over building a run-of-theriver project that proposes to divert water from the Kishenganga river to the Jhelum river basin.

"There is no decision yet to

suspend the [Indus] Commission and we are reviewing our participation," Mr. Shekhar told The Hindu.

'Mission mode'

He, however, emphasised that India would pursue in "mission mode" its plans to ramp up hydroelectric power

projects and utilise "to the fullest" what was due to it under the water-sharing agreements under the pact. This would mean commissioning or completing hydro-power projects and expanding irrigation in Jammu and Kashmir by about 50 per cent.

"Expanding irrigation ca-

pacity won't be a huge cost. At an average of Rs. 5 crore per megawatt, Rs 50,000 crore could be invested in hydro-projects there. It will greatly benefit Jammu and Kashmir," he added. However there was no final decision yet on budgetary allocation.

Declaring that "blood and water cannot flow together", Prime Minister Modi on Monday held a meeting of senior officials from the Water Resources and External Affairs Ministries and the PMO to discuss the government's options on the treaty.

While the meeting decided to suspend further water talks and increase the utilisation of rivers flowing through Jammu and Kashmir to maximise India's share, there was no decision on either reviewing or abrogating the treaty, official sources said.

NEW DELHI: Enforcing its authority as the final arbiter of inter-State river water disputes, the Supreme Court on the ignored Tuesday legislature's Karnataka resolution to not share Cauvery water and directed the State to release 6,000 cusecs of water to neighbouring Tamil Nadu for the next three days.

"We direct the State of Karnataka to release 6,000 water from cusecs September 28, 2016. We are sure that the State of Karnataka shall obey the order without any kind of impediment, obstruction or any other attitude till we take up the matter on September 30, 2016," the Bench of Justices Dipak Misra and U.U. Lalit said.

To be adjusted later

It said this release of water would be adjusted in the eventual adjudication of the inter-State dispute.

The court entrusted Attorney-General Mukul Rohatgi to meanwhile facilitate talks between the "Executive Heads" of the two States in an effort to melt hostilities.

Former SC judges say resolution is ill-advised

NEW DELHE Former Supreme Court judges have termed the resolution passed by the two Houses of Karnataka on September 23, to deny Tamil Nadu Cauvery water, an ill-advised misadventure. They say the resolution is no match for the constitutional might of the Supreme Court as the final arbiter of inter-State water

disputes. Former Supreme Court judge K.T. Thomas said the resolution "is only fit to be kept in the records of the Karnataka legislature and has no

authority". "At best, the resolution can be treated as an expression of opinion or a criticism of the Supreme Court's order. Everyone has the right to criticise a court order. But the Supreme Court is the final authority in resolving inter-State water disputes," he said on Tuesday.

Govt to construct 'mini dams' for irrigation

To exploit waters of the western rivers of the Indus, Jhelum and Chenab for irrigation as permitted under the Indus Waters Treaty, the Jammu and Kashmir Government is mulling construction of "mini dams" on their tributaries to double crop production in Kashmir.

Officials said the govern-

ment would take the help of international experts for the construction of water storage facilities on the tributaries to increase agricultural productivity in kandi areas and on plateaus.

"We are within the rights under the Indus Waters Treaty to construct mini dams for storage of water on tributaries of the western rivers for agricultural purposes," a senior government official told The Tri-

bune. However, he said the dams had to be built keeping in view that Jammu and Kashmir was in seismic zones IV and V.

The treaty, which was

signed by Prime Minister Jawaharlal Nehru and Pakistani President Ayub Khan in September, 1960, is a water-sharing mechanism to regulate the flow of the

trans-boundary Indus river and its five tributaries — Jhelum, Chenab, Ravi Beas and Sutlej — betweer India and Pakistan.

Under the treaty, India received exclusive rights of use of waters of eastward flowing Ravi, Beas and Sutlej before they crossed the border while Pakistan had rights to three large western rivers first flowing through J&K — the Indus Jhelum and Chenab.


Storage in Cauvery reservoirs up

BENGALURU: Storage in Karnataka's Cauvery basin reservoirs seems to have improved considerably in comparison with the situation a few days ago, when the State legislature passed a resolution and the government defied the Supreme Court order to release water to Tamil Nadu.

On September 20, when the State stopped releasing water to Tamil Nadu, the combined storage in four dams (Harangi, Hemavati, Krishnaraja Sagar and Kabini) was 26.21 tmcft. This was termed "alarming" as it was less than the 27 tmcft required for providing drinking water till the end of May next.

On Wednesday, however, the cumulative storage had risen to 31.29 tmcft. This is



The KRS, from where the water is released, has seen its storage increase by 2.02 tmcft, the highest since Sept. 14.

owing to rainfall in the catchment areas, coupled with no outflow from the reservoirs. The KRS, which was the point of release, has seen its storage increase by 2.02 tmcft. This is the highest since September 14. The cumulative volume of water discharged from the

reservoir over the past eight days has been around 0.2 tm-cft, while the volume of water reaching it has been 2.45 tm-cft. The storage levels, however, still remain a concern for officials as they are nearly a third lower than the levels in the same period last year.

Karnataka defers Cauvery water decision till today

BENGALURU: Awaiting the outcome of a meeting convened by the Centre, Karnataka decided on Wednesday to defer the release of 6,000 cusecs of Cauvery water to Tamil Nadu till Thursday as per the Supreme Court direction.

"We have deferred decision on release till tomorrow... We will see the outcome (of the meeting) and then decide on the next step," said Karnataka chief minister Siddaramaiah.

On Tuesday, the SC had asked Karnataka to release Cauvery water in the next three days despite the unanimous assembly resolution to use the water only for drinking. The SC had also called for a political solution to the "impasse" by convening a meeting of CMs of both states and the Centre. Union water resources minister Uma Bharti has also called for a meeting.

Before the cabinet meet, Siddaramaiah convened an all-party meeting to discuss the SC direction. The meeting was attended by the two main Opposition parties — the BJP and the JD(S).

In the meeting, both the parties are said to have advised the government against releasing water to Tamil Nadu and to stick to the unanimous resolution passed by the Karnataka legislature in the

special session held last week.

In an unprecedented move in the more than century-long Cauvery dispute with the neighbouring state, both the legislative assembly and the council adopted the resolution not to provide water for any other purpose except to meet drinking needs on September 23 citing "acute distress" and "alarmingly low levels" in dams in Karnataka.

"We have no intention to disobey the Supreme Court order," Siddaramaiah said, pointing out that the assembly had clearly mandated that the water was required for drinking purpose.

Meanwhile, prohibitory orders have been extended till September 30 in Bengaluru considering the law and order situation following protests in the state over the Cauvery water dispute.

The city police has deployed 15,000 police personnel. However, no univard incidents have been reported in the city.

India's Indus threat sends Pak scurrying to World Bank to

Worried, Islamabad Moves ICJ Too

slamabad has approached the World Bank as well as the International Court of Justice (ICJ) amid reports that India may use the Indus Water Treaty (IWT) to hit back at Pakistan over the persistent terror attacks launched from its soil.

The World Bank had helped broker the pact, which outlines how the waters of six rivers (Beas, Ravi, Sutlej, Indus, Chenab and Jhelum) are to be shared between the two countries, in 1960. While details of the ICJ appeal were not available, according to Pakistan TV channel Geo News, a government delegation led by Pakistan's attorney general Ashtar Ausaf Ali met senior officials of the World Bank in Washington DC.

The meeting pertained to the dispute over India's construction of Kishenganga and Ratle hydroelectric pla-nts on Jhelum and Chenab, respectively. The treaty provides specific design criteria for any hy-

del plant to be built by India. Pakistan says the Kishenganga and Ratle pla- nts violate the laid-down parameters.

In August, Pakistan had formally requested India for a settlement of the dispute. Under the treaty, the World Bank has an important role in the establishment of a court of arbitration. Pakis-

tan has reportedly asked the World Bank for early empanelment of the court. "The World Bank will be deciding the issue in the next few days," the Pakistan government said in a statement.

The World Bank, however, said on Wednesday it was approached by India as well, and would respond to the neigh-

bours' requests "in its limited, procedural role".

Meanwhile, Pakistan PM Nawaz Sharif said on Wednesday that the country was fully capable of meeting any internal or external security threat, and added that "no one country can unilaterally separate itself from the IWT". AGENCIES

Water warning to Bangalore

New Delhi, Sept. 27: The Supreme Court today directed Karnataka to release 6,000 cusecs of Cauvery water to Tamil Nadu every day for the next three days starting tomorrow, warning the upper riparian state to "better cooperate" till it heard the matter again on Friday.

The directive came despite a Karnataka Assembly resolution that had opposed the court's September 20 order to the state to release 6,000 cusecs (cubic feet per second) a day till September 27.

The bench of Justices Dipak Misra and U.U. Lalit adjourned the matter till 2pm on Friday after attorney general Mukul Rohatgi, who was asked to assist the court, sought two days to arrange a meeting between the chief ministers of the two states.

Tamil Nadu's counsel Shekhar Naphade had repeatedly dwelt on Karnataka's defiance but the court refused to get into that "facet today", saying the issue was linked to "federalism".

The bench, however, made it clear that if necessary it might crack the whip to uphold the "majesty" and "dignity" of judicial orders.

Justice Misra, who was heading the bench, said: "...we direct the State of Karnataka

to release 6,000 cusecs of water from tomorrow, i.e. September 28, 2016. We are sure that the State of Karnataka shall obey the order without any kind of impediment, obstruction or any other attitude till we take up the matter on September 30, 2016.

"Needless to say, the water that has been released will be adjusted in the eventual adjudication," the judge said, adding the "water shall be released despite the (Assembly) resolution".

"You better cooperate, Mr (Fali S.) Nariman," the judge told Karnataka's counsel.

The resolution, passed by the Karnataka legislature on September 23, had asked the state government to use the Cauvery reservoirs only to supply drinking water to the state's people.

The implication was no water should be released to Tamil Nadu despite the top court's September 20 order that had asked Karnataka to release 6,000 cusecs to Tamil Nadu from September 21 to 27.

In the court today, Naphade said Tamil Nadu was fed up with Karnataka's "obstinacy" and "obstructionist" approach. "Karnataka should not be heard until they implement the directions. They are not releasing the water. They are defying the orders of this court," the senior advocate said.

Senior counsel Fali Nari-

man, who represented Karnataka, said the state was willing to implement the order around November when it gets sufficient waters from the northeast monsoon. "I am not saying I will not comply with the order," Nariman said.

Justice Misra said: "The point of Tamil Nadu is you are not entitled to be heard. We have passed an order. If the order is not implemented, the dignity of the court is affected (and) that can't be tolerated."

Nariman said the Karnataka legislature was "also a constitutional authority". The bench then asked whether it should go into the validity of the resolution in relation to the powers of the court.

Karnataka Oppn parties stand against release of Cauvery waters STATESMAN NEWS SERVICE

Bengaluru, 28 September

The Opposition parties in Karnataka today unanimously expressed themselves against honouring the Supreme Court's order on the release of Cauvery waters to Tamil Nadu. Arguing that the stand should be in line with the resolution passed by the assembly and the legislative council five days ago, the parties told the Siddaramiah government that it was more important to meet the drinking water needs of the IT capital and the Cauvery basin.

The meeting followed the apex court's direction yesterday under which Karnataka is required to release 6,000 cusecs of water daily from today to its lower riparian neighbour till this Friday. The order came despite the repeated pleas of the Karnataka government which

claimed that the water in its reservoirs was at a new low and was barely enough to meet its drinking water needs.

The leaders of the Opposition parties including Mr Y Dutta, JDS, and Mr Jagdish Shettar, BJP, told newsmen in separate meetings "we have told chief minister Mr Siddaramiah that he should not release any water to Tamil Nadu today. We also reiterated that the resolution passed to this effect by the state's legislature on 23 September was more important."

Earlier, Mr Jayachandra, state law minister, on his part, admitted that the Opposition parties had advised the chief minister against the release of Cauvery waters. He, however, refused to go into details other than stating that the Opposition also wanted the government to convey its

decision on the issue tomorrow to the Union government.

He added that the ball was now in the court of the state cabinet which would be meeting soon to take a call on the controversial issue while keeping in mind the resolution passed by the two houses.

Today's meeting was attended by the floor leaders of the two houses in addition to members of Parliament and law makers, not to mention district in-charge ministers hailing from the Cauvery basin. A section of the farmers' organisation attended the meet as well.

Mr Datta added that the water availability in Tamil Nadu was comparatively better and the ground water level too was encouraging. He said it was time to take a political decision over the contentious decision based on the will of the people.

Karnataka defers decision on & \rightarrow releasing Cauvery water to TNO

EXPRESS NEWS SERVICE BENGALURU, SEPTEMBER 28

THE KARNATAKA government on Wednesday failed to arrive at a decision on releasing 6,000 cusecs of water from the Cauvery river to Tamil Nadu for three days as directed by the Supreme Court on September 27.

The government, instead, seemed inclined to take a decision after a meeting of the executive heads of the Karnataka and Tamil Nadu governments, convened in New Delhi on Thursday by the Centre on the directions of the Supreme Court.

The Congress government headed by Chief Minister Siddaramaiah held separate meetings with Opposition leaders and members of the state cabinet on Wednesday, as part of an

exercise to generate consensus on the course of action with respect to the Supreme Court order of September 27 to release water to Tamil Nadu till September 30.

The government concluded that water could not be released immediately in the light of a resolution passed by the Assembly on September 23. The resolution stating that no water could be released to Tamil Nadu until there is an improvement in the storage of drinking water in the Cauvery basin in Karnataka.

Wednesday's meetings saw mixed responses, with some leaders suggesting that it would be good for Karnataka to release water ahead of the meeting convened by the Centre and others suggesting that it would be better to "wait and watch".

"I will be going to Delhi tomorrow to participate in the meeting convened by Water Resources Minister Uma Bharati. I will present the ground realities of the water position in Karnataka. Depending on what transpires at the meeting, we will take a decision on the Cauvery issue," said Chief Minister Siddaramaiah after the cabinet meeting.

"We have utmost respect for the Supreme Court, but this decision has been compelled by the fact that there is no water to release to Tamil Nadu. The water that is there is needed to meet the drinking water requirements in Karnataka," said Siddaramaiah.

"We have taken a decision not to release water for any purpose except drinking water... As per this resolution, and the advice received at the all-party meeting, we have postponed the release of water," he said.
