- No registration, transfer, road tax etc. in respect of the vehicles shall be payable by the Department.
 The undersigned will not entertain any claim for damage done by way of theft, pilferage, fire or any other unforeseen calamity after realising full payment against the sale of auctioned vehicle.
- The delivery of the auctioned Truck is to be taken within 10 days on the issue of letter of offer on making full payment thereof. Otherwise the earnest money deposited will stand forfeited.
