I am directed to refer to your letter No. उ.गं.बे.स. /लख/एफ.आर.56(J)/2019-20/2882 dated 06.08.2019 on the subject mentioned above and to say that as per CWC's letter No. A-4312/02/2015-Estt.XII/1175-1240 (E) dated 27th September, 2018 (copy enclosed), Superintending Engineer/Director of the concerned Circle is the "appointing and Disciplinary Authority" in respect of Work Charged Staff.

2. Hence as far as Work Charged Staff is concerned, an appropriate "Review Committee" under the Chairmanship of a senior Executive Engineer/Deputy Director level officer may be constituted for reviewing their performance under FR 56 (J) & Rule 48 of CCS (Pension) Rules 1972 which will submit its recommendation to Superintending Engineer/Director of the concerned circle as appointing authority for final decision. 
