The Government of India has received a credit (No. 5150-IN) from the International Development Association (the World Bank) towards the cost of implementation of the "ICDS Systems Strengthening and Nutrition Improvement Project (ISSNIP)". The Ministry of Women and Child Development is responsible for implementation of the project. The Central Project Management Unit (CPMU) established within the MWCD has the overall responsibility for providing project planning and management support as well as technical guidance to the eight project States and selected districts on various project activities, coordinating with the State Project Management Units (SPMUs), the World Bank, Deptt. of Economic Affairs and CAA& A, and also conduct independent monitoring and evaluation of the project implementation to ensure that the project objectives are fully achieved. 2. It is proposed to fill up two positions of the Project Managers in the CPMU by transfer on deputation basis from among the Officers of Central Group 'A' Services. 
