- 3. The quotation should be addressed to the Executive Engineer, Middle Ganga Division -3, Central Water Commission, Akashdeep Building, 2nd Floor, Pannalal Park, Varanasi-221002, Uttar Pradesh.
- 4. All duties, taxes, transportation and other levies payable by the supplier/contractor under the contract shall be included in the total price.
- 5. The sealed cover containing the quotation should be superscripted with the words "Quotations for supplying of computer equipments, under MGD-3, CWC Varanasi due date on 25th November, 2021 at 16:30 Hours".
- Only those firms who are using good quality of materials of reputed make need to quote their rates immediately.

If any inspected material/items, fail to conform to the specifications, the Engineer-in-charge may reject the material/items and the Agency shall replace the rejected material/items at its own Cost. If the Agency fails to deliver/replace material/items within stipulated time limit mentioned in supply order, supply order will be cancelled, and Agency may be blacklisted in this regard decision of Engineer-in-charge is last and binding.
- 8. All the corrections/ over writing should be duly attested. Else it will make the quotation disqualify.
- All the materials should have a guarantee in all respect for a period of minimum one year from the date of supply.
- 10. Bidders must have PAN and Goods & service Tax Number, Photocopy of the same should be enclosed/uploaded.
- 11. Indicated quantities may increase or decrease at the time of supply order as per our requirement.
