
**OFFICE ORDER**


2. The terms and conditions for assigning the additional charge may be as under:

- Pay and allowances including special duty allowance for serving in the North-East Region etc, of all the CWES officers mentioned above, will be paid by the CWC;






- b) There will not be any change in the Disciplinary Authority of these officers. However, temporary administrative control will remain with the Reporting Officers of Brahmaputra Board, in so far as work pertaining to the Board. However, APAR/ACR of the officers will be written/reviewed by the prescribed officers of CWC;
- c) These CWES officers shall not be deemed to be regular members of the staff borne on the establishment of the Brahmaputra Board;
- d) The expenditure in connection with TA/DA of these officers, while the tour is purely for the official work of Brahmaputra Board, shall be paid by the Brahmaputra Board.
- e) No additional remuneration shall be paid to any of the officers mentioned above, for the additional charge arrangement in the Brahmaputra Board.
