- The time allowed for carrying out the work will be 30(thirty) days from the seventh day after the date of 3. written orders to commence the work or from the first day of handing over of the site, whichever is later, in accordance with the phasing if any, indicated in the tender documents.

The site for the work shall be made available in parts as specified below:-

Tender documents consisting of plans, specifications, the schedule of quantities of the various classes of work to be done and the set of terms & conditions of contract to be complied with by the contractor whose tender may be accepted and other necessary documents can be seen in the office of the Executive Engineer, Middle Brahmaputra Division, Central Water commission, Guwahati-781014 between hours of 11.00 A.M. & 04.00 P.M. every day except on Sundays and Public Holidays. Tender documents, excluding standard form, will be issued from his office, during the hours specified above, on payment of Rs.500/- by Demand Draft only. In case tender form is downloaded, DD of Rs.500/- should be attached with the tender document, else the tender will not be accepted

The tenderer must produce an Income-Tax clearance certificate in the revised form as modified under Ministry of Finance O.M.No.67/30/69/ITAL dated 02.07.1970 as amended from time to time and other relevant documents before tender papers can be sold to him.

Tenders, which should always be placed in sealed envelope, with the name of work and due date written on the envelopes, will be received by this office up to 04:00 P.M. on 26.12.17 and will be opened by him

or his authorized representative in his office on 27.12.17 at 11:00 hrs.

The tender shall be accompanied by earnest money (unless exempted) of Rs. 3,200/- Treasury Challan/ Deposit at Call receipt of a Scheduled Bank/Fixed Deposit Receipt of a Scheduled Bank/ Demand Draft of a Scheduled Bank issued in favour of Executive Engineer, Middle Brahmaputra Division, Central Water commission or as per provision of CPWD manual. The fixed Deposit Receipt shall be accepted only if it is valid for six months or more after the last date If receipt of tenders and is pledged in favour of Executive Engineer, Middle Brahmaputra Division, Central Water commission. A contractor exempted from depositing earnest money in individual cases, shall enclose with the tender an attested copy of the letter exempting him and shall produce the original when called upon to do so.

The tender and the earnest money shall be placed in separate sealed envelopes each marked "Tender" and "Earnest Money" respectively. Both the envelopes shall be submitted together in another sealed envelope. The envelope mark "Tender" of only those tenderers shall be opened, whose earnest money

placed in the other envelope is found to be in order.

Copies of other drawings and documents pertaining to the works will be open for inspection by the

tenderers at the office of the above mentioned officer.

Tenderers are advised to inspect and examine the site and its surroundings and satisfy themselves before submitting their tenders as to the nature of the ground and sub-soil (so far as is practicable), the form and nature of the site, the means of access to the site, the accommodation they may require and in general shall themselves obtain all necessary information as to risks, contingencies and other circumstances which may influence or affected their tender. A tenderer shall be deemed to have full knowledge of the site whether he inspects it or not and no extra charges consequent on any misunderstanding or otherwise shall be allowed. The tenderer shall be responsible for arranging and maintaining at own cost all materials, tools & plants, water, electricity access, facilities for workers and all other services required for executing the work unless otherwise specifically provided for in the contract documents. Submission of a tender by a tenderer implies that he has read this notice and all other contact documents and has made himself aware of the scope and specifications of the work to be done and of conditions and rates at which stores, tools and plant, etc. will be issued to him by the Government and local conditions and other factors having a bearing on the execution of the work.

The competent authority on behalf of President of India does not bind himself to accept the lowest or any other tender, and reserves to himself the authority to reject any or all of the tenders received without the Assignment of a reason. All tenders, in which any of the prescribed conditions is not fulfilled or any condition including that of conditional rebate is put forth by the tenderer, shall be summarily rejected.

Canvassing whether directly or indirectly, in connection with tenders is strictly prohibited and the tenders

submitted by the contractors who resort to canvassing will be liable to rejection.

12. The competent authority on behalf of President of India reserves to himself the right of accepting the whole or any part of the tender and the tenderer shall be bound to perform the same at the rate quoted.

The contractor shall not be permitted to tender for works in the CPWD Circle (responsible for award and execution of contracts) in which his near relative is posted as Divisional Accountant or as an officer in any capacity between the grades of Superintending Engineer and Assistant Engineer (both inclusive). He shall also intimate the names of persons who are working with him in any capacity or are subsequently employed by him and who are near relatives to any gazette officer in the Central Public Works Department or in the Ministry of Urban Development. Any breach of this condition by the contractor would render him liable to be removed from the approved list of contractors of this Department.

14. No Engineer of Gazetted rank or other Gazetted officer employed in Engineering or Administrative duties in an Engineering Department of the Government of India is allowed to work as a contractor for a period of two years after his retirement from Government service, without the previous permission of the Government of India in writing. This contract is liable to be cancelled if either the contractor or any of his employees is found any time to be such a person who had not obtained the permission of the Government of India as aforesaid before submission of the tender or engagement in the contractor's

If any tenderer withdraws his tender before said period or makes any modifications in the terms and conditions of the tender which are not acceptable to the department, then the Government shall, without prejudice to any other right or remedy, be at liberty to forfeit 50% of the said earnest money as aforesaid.
