OFFICE ORDER

In terms of Rule 50 & 51 of the Central Civil Service (Leave) Rules, 1972, Shri Dhirendra Kumar, Assistant Director Grade –II of the Central Water Engineering (Group B) Service, working as AD Gr.II in External Assistance Directorate, CWC, New Delhi is hereby granted Study leave for 24 months from 31.7.2021 to 30.7.2023 for pursuing M.Tech Course on "Water Resources Development" from Department of WRD&M, IIT, Roorkee for the academic year 2021-22.

2. On completion of the study, Shri Dhirendra Kumar, Assistant Director Grade –II, CWC will submit to the Central Water Commission, the certificate of completion of course of study undertaken indicating the date of commencement and termination of the study with remarks, if any, of the authority in charge of the course of study. Shri Dhirendra Kumar shall submit to the Government of India, on his return, a complete report on the course of study undertaken by him during his study leave.

3. If, Shri Dhirendra Kumar resigns from Government Service or otherwise quit service without returning to duty after the period of study leave or within a period of three years after such return to duty or fails to complete the course of study for which the study leave has been sanctioned and is thus, unable to furnish the certificate as required under sub-rule (5) of Rule 53, he shall be required to refund, as provided under Rule 63(1) of CCS (Leave) Rules, 1972:

I. The actual amount of leave salary, study allowance, travelling and other expenses, if any, incurred by the Government of India; and

II. The actual amount, if any, of the cost incurred by other agencies such as foreign Governments, Foundations and Trusts in connection with course of study, together with interest thereon at the rates applicable for the time being in force on Government loans, from the date of demand before his resignation is accepted or permission to retire is granted or his quitting service otherwise.

4. Shri Dhirendra Kumar is entitled to draw leave salary during the period of study leave in accordance with Rule 56(1) of the CCS(Leave) Rules, 1972.

5. He has executed bond, Form-7 For Rs. 18,74,500/- (Rupees Eighteen Lakhs Seventy Four Thousand Five Hundred only) and as prescribed vide DoPT OM No.13026/4/2021-Estt(L) dated 18.2.2014 and same has been accepted by the Competent Authority in Central Water Commission.

6. The study leave will not be debited against the leave account of Shri Dhirendra Kumar , AD GR.II, CWC.

7. Shri Dharendra Kumar, AD Gr.II, External Assistance Directorate , CWC, New Delhi is also governed by the terms & conditions as enumerated in Training Directorate, CWC, New Delhi's Office Order No.A-33025/9/2021-TRNG dated 04.6.2021.
