OFFICE ORDER

- I. The actual amount of leave salary, study allowance, travelling and other expenses, if any, incurred by the Government of India; and
- II. The actual amount, if any, of the cost incurred by other agencies such as foreign Governments, Foundations and Trusts in connection with course of study, together with interest thereon at the rates applicable for the time being in force on Government loans, from the date of demand before his resignation is accepted or permission to retire is granted or his quitting service otherwise.
- 4. Shri Dhirendra Kumar is entitled to draw leave salary during the period of study leave in accordance with Rule 56(1) of the CCS(Leave) Rules, 1972.
- 5. He has executed bond, Form-7 For Rs. 18,74,500/- (Rupees Eighteen Lakhs Seventy Four Thousand Five Hundred only) and as prescribed vide DoPT OM No.13026/4/2021-Estt(L) dated 18.2.2014 and same has been accepted by the Competent Authority in Central Water Commission.
- 6. The study leave will not be debited against the leave account of Shri Dhirendra Kumar , AD GR.II, CWC.
