Sub: - Strengthening of Cybersecurity apparatus in all regional offices of CWC-reg.

This is with reference to the earlier communication (letter no. M-75075/9/2024-SM Dte/I/205268/2025 dated 14.05.2025) vide which all regional offices were requested to furnish certain details related to cybersecurity apparatus in their offices (antivirus, firewall etc.).

In continuation of the above, Software Management Directorate (SM Dte), CWC(HQ) has procured cloud based Endpoint Security Antivirus solution for implementation at Headquarters and now intends to extend its deployment across all field offices. This initiative is being undertaken in light of the growing cybersecurity threats and the urgent need to standardize and enhance the organizations' overall cyber defense posture.

Implementing a standardized cloud based antivirus solution across all field offices will ensure uniformity in the cybersecurity apparatus. Furthermore, it will enable centralized monitoring and management of all endpoints through a unified console. This central console will facilitate efficient monitoring of suspicious cyber events and enable swift remedial action, thereby strengthening the capacity to prevent and respond to potential cyber threats.

All field organisations are therefore requested to coordinate with the SM Dte to initiate the installation process of the above mentioned antivirus in all desktops of various offices falling under them at the earliest. The concerned Superintending Engineer (Coordination) may nominate a suitable officer to coordinate with SM Dte on behalf of all offices under the concerned organisation and convey the same through email.

This matter may be accorded **utmost priority**.
