

(a) amendment to the Lokpal & Lokayuktas (Removal of Difficulties) Order, 2014, for the purpose of extending the time limit for carrying out necessary changes in the relevant rules relating to different services from "two hundred and seventy days" to "three hundred and sixty days", from the date on which the Act came into force, i.e., 16<sup>th</sup> January, 2014; and

(b) the Public Servants (Furnishing of Information and Annual Return of Assets and Liabilities and the Limits for Exemption of Assets in Filing Returns) Amendment Rules, 2014, extending the time limit for filing of revised returns by all public servants from 15<sup>th</sup> September, 2014 to 31<sup>st</sup> December, 2014.

In this regard, the undersigned is directed to convey that the last date for filing of revised returns by public servants under the rules indicated in para 1 (b) above has been extended by a period of four months, i.e., from 31<sup>st</sup> December, 2014 to 30<sup>th</sup> April, 2015. 


