



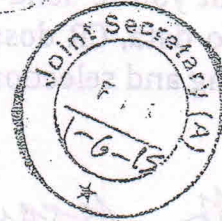

Dear Mr. Bhatnagar,



The R&AW has some vacancies in the rank of Deputy Secretary and Under Secretary to be filled on priority by inducting suitable officers on deputation basis from All India and other organized Central Group 'A' Services.

2. Since we are keen to consider officers available for deputation against the existing vacancies in deputation quota, it is requested that nominations, along with CR Dossiers and Cadre/Vigilance clearance of suitable officers of 2003 batch onwards, may please be forwarded to us at an early date.

3. Officers in the grade pay of ₹7600/- will be eligible for deputation in the grade of Deputy Secretary and those in grade pay of ₹6600/- as Under Secretary. Officers having a keen interest in security issues and international affairs would be particularly suitable to be considered for induction on deputation.

4. While inviting nominations of officers, it can be briefly mentioned that initial tenure of deputation in R&AW would be for a period of four years extendable on case to case basis for a further period of eight years in two spells of four years each. The officers on deputation to R&AW and belonging to All India Services/ Central Group 'A' Services, selected through Combined Civil Services Examination conducted by the UPSC shall also be eligible to be considered for Permanent Secondment, if willing and adjudged suitable. Under the scheme of Permanent Secondment, an officer can continue on deputation without any limit on the term of deputation and will also be considered for promotions/ in-situ upgradation to the rank of Director and above.


5. Officers inducted on deputation are liable to serve within India and abroad and their pay and allowances shall be governed by the terms and conditions of deputation in accordance with the rules/ guidelines of DoP&T.

6. Residential accommodation at Hqrs., New Delhi would be either from General Pool Accommodation (or R&AW Special Pool Accommodation

depending on availability). Officers not allotted Govt. accommodation are eligible for HRA as per general rules applicable to Central Govt. officers. In the case of officers posted outside Hqrs. within the country, office-cum-residence is available at majority of the stations.

7. I would like to request you to send nominations of willing and suitable officers along with their Bio-data, CR dossiers and Vigilance clearance at the earliest for further processing and selection for induction on deputation to this department.
