OFFICE MEMORANDUM

Sub:- Posting of Union Functionaries.

The staff side in the Departmental Council of the Ministry of Personnel, Public Grievances and Pensions have requested that with a view to enable the Union Functionaries to follow up staff matters effectively, they should not be posted outside the main office of the Cadre/Ministry/Department. The matter has been considered and it is suggested that except for special reasons, Union Functionaries should not be shifted from main administrative office to subordinate office (including other offices or buildings). "Union Functionaries" for this purpose would be the President and General Secretary of the Branch Unit of the recognised Union/Association who are members of the staff Council.

2. All Ministries/Department may kindly keep these guidelines in-view while dealing with the cases of Central Secretariat Union Functionaries of the Department Council (JCM) of Ministry of Personnel, Public Grievances and Pensions.
