4. As per rule 20 of CCS (Conduct) Rules, no Government servant shall bring or attempt to bring any political or other outside influence to bear upon any superior authority to further his interests in respect of matters pertaining to his service under Government. If anyone through himself/herself or through their relatives/friends brings political pressure for change of place of posting, disciplinary action will be initiated against him/her without any further notice/communication.
