Subject: Filling up of two posts of Deputy Director (Hydrometrology), Central Water Commission by deputation - regarding

I am directed to say that a proposal for filling up the post of Deputy Director (HM) by deputation including short term contract basis was sent to DoWR, Rd & GR for advertising and calling for the application to fill the post of DD (HM) in CWC, being a Group A' post. DoWR, RD & GR had advertised the post several times but could not get any application against the advertisement. The method of recruitment prescribed in the existing RRs for the post of DD (HM) is 100% by promotion failing which by deputation including short term contract basis. Two post of DD (HM) are presently filled up. No eligible officers in the grade of Assistant Director (HM) are presently available for promotion as DD(HM); hence, two posts are unfilled and need to be filled by deputation including short term contract basis. Neither the DoWR nor CWC is in a position to get these two post of DD (HM) filled as no officer in the grade of AD (HM) is eligible for promotion for a long time. The possibilities to fill these post are being explored and DoWR, RD & GR has advised CWC to explore the possibility of appropriate revisions of eligibility conditions prescribed in the Recruitment Rules for filling up the post of Deputy Director (HM) by deputation including short term contract.

2. In view of above, all the officers who are related with HM cadre and all the officers of the hydromet cadre are requested to provide inputs as to how the eligibility conditions prescribed in the Recruitment Rules may be revised so that the post of DD (HM) can be filled up timely.

3. The reply / input, if any, in the matter may, please, be furnished to Estt.XI Section, CWC, by e-mail at estt11@nic.in or otherwise latest by 07.09.2021. RRs for the post of DD(HM) can be seen on CWC website please.
