## **NOTICE INVITING TENDER**

- 2. Estimated Cost: Rs. 1,37,500/- (Rupees One Lakh Thirty Seven Thousand Five Hundred only)
- 3. Earnest Money: Rs. 2,750/- (Rupees Two Thousand Seven Hundred Fifty Only)
- 4. Performance Guarantee: 5% of tendered value of work.
- 5. Security Deposit: 2.5% of Bill Amount of work.
- 6. Cost of Tender Document: Rs 500/-
- 7. Period of Completion: 45 Days

- The tender must be delivered in the office of the Executive Engineer, Southern Rivers Division, CWC, Coimbatore on or before 15.00 hours of 20.04.2019. The Earnest money should be deposited along with the tender documents in the form of Demand Draft /Banker's Cheque

issued by a scheduled bank in favour of Executive Engineer, SRD, Central Water Commission payable at Coimbatore.

- 3. Tender received after the last date and time shall not be entertained. The tenders can be withdrawn before the close of sale of tenders by sending a request. The withdrawn tenders can be collected personally from the Executive Engineer.
- 4. Tenders, which should be placed in a sealed envelope, with the name of work and due date written on the envelope will be received by the Executive Engineer, SRD, CWC, Coimbatore up to 15.00 hours on 20.04.2019 and will be opened by him or his authorized representative in his office on the same day at 15.30 hrs. In case holiday is declared on the opening day, the tenders will be opened on the next working day.

 Sealed tenders are invited on behalf of the President of India from approved and eligible contractors of CPWD, Railways, MES, P&T (Civil) and State PWD/Govt. undertakings / Local Bodies for work of Fabrication and supply of RCC gauge post for the sites under SRD, CWC, Coimbatore.



The enlistment of the contractors should be valid on the last date of sale of tenders.

In case only the last date of sale of tenders extended, the enlistment of contractor should be valid on the original date of sale of tenders.

In case both the last date of receipt of application and sale of tenders are extended, the enlistment of contractor should be valid on either of the two dates i.e. original of tender or on the extended of sale of tenders.

- The work estimated to cost of Rs.1,37,500/- (Rupees One Lakh Thirty Seven Thousand Five Hundred only) This estimate, however, is given merely as a rough guide.
- Agreement shall be drawn with the successful tenderer on the prescribed Form No.7/8 of CPWD, which is available at Government of India Publication. Tenderer shall quote his rates as per various terms and conditions of the said form, which will form part of the agreement.
- 4. The time allowed for carrying out the work will be from the date of written order to commence the work.
- 5. Tender documents consisting of plans, specifications, the schedule of quantities of various classes of work to be done and set of terms & conditions of contract to be complied with the contractors whose tender may be accepted and other necessary documents can be seen in the office of the Executive Engineer, Southern Rivers Division, C.W.C, Coimbatore. Tender forms along with terms and conditions can be downloaded from the website "http://cwc.nic.in".The tender payment of non refundable fee of Rupees 500/- by Demand Draft /Banker's Cheque in favour of the "Executive Engineer, Southern Rivers Division, CWC, Coimbatore" payable at Coimbatore.
- 6. The tenders, which should always be placed in sealed envelope, with the name of work and due date written on the envelopes, will be received by the Executive Engineer, Southern Rivers Division, C.W.C, Coimbatore up to 15.00 hrs on 20.04.2019 and will be opened by him on the same day at 15.30 hrs. In case closure of the Office on the opening date of tender on any account, the tender

will be opened on the next working day at the same time and venue. The tender submitted in any other paper than this format as attached in the tender document will not be accepted and shall be rejected outright at the time of opening of tender.

- 7. The tender should accompany Earnest Money of Rs. 2,750/- (Rupees Two Thousand Seven Hundred Fifty Only) in one of the following forms:
  - Banker's Cheque/ Demand Draft in favour of the Executive Engineer, Southern Rivers Division, Central Water Commission Payable at Coimbatore.
  - ii) Tenderer exempted from depositing earnest money and shall attach with the tender a signed copy of the letter exempting him from depositing earnest money and shall produce the original when called upon to do so.
    - No interest will be paid for E.M.D, at the time of release. Request for adjustment or part deposit of Earnest Money will not be entertained. Tenders without Earnest Money in full will be rejected outright at the time of opening of the tender.
- 8. The tender received late will be returned un-opened to the contractor. The undersigned will not be responsible for the postal delay, if any, in non-receipt of the tender in time.
- 9. No tender may be modified after the deadline for submission of tenders.
- 10. Validity of the tender should be for 90 days, from the date of opening of the tender. The tender valid for a shorter period shall be rejected.
- 11. Telegraphic / Telephonic tenders will not be entertained.
- 12. The description of the work is as follows:

## Fabrication and supply of RCC gauge post for the sites under SRD, CWC, Coimbatore.

Copies of other drawings and documents pertaining to the works shall be obtained for Inspection by the tenderers at the office of the above-mentioned officer.

Tenderers are advised to inspect and examine the site and its surroundings and satisfy themselves before submitting their tenders as to the nature of the ground and sub-soil (so far is practicable), the form and nature of the site, the means to access to the site etc. A tenderer shall be deemed to have full knowledge of the site whether he inspects it or not. No extra charges consequent on any misunderstanding or otherwise shall be allowed. The tenderer shall be responsible for arranging and maintaining at his own cost all materials, tools & plants, water facilities for the workers and all services required for executing the work. Submission of a tender by attendee implies that he has read this notice and all other contract documents and has made himself aware of the scope and specifications of the work to be done and local conditions and other factors having a bearing on the execution of work

- 13. The tenderer shall include the following information and documents
  - (i) Copies of original documents defining the constitution or legal status, and principal place of business, written power of attorney of signature of the bid, if any.

- 14. Bid from joint ventures are not acceptable.
- 15. The Bidder shall fill in rates and prices of all the items of works in the bill of quantities Items, for which, no rate or price is entered by the Bidder will not be paid when executed and shall be deemed covered by the other rates and prices in the bill of quantities.
- 16. The rates and prices quoted by the bidder shall be final for the duration of contract and shall not be subject to adjustment on any account.
- 17. The Bid security of unsuccessful bidders shall be returned within the end of the bid validity period of 90 Days.
- 18. When there is discrepancy between the rates in figures and words, the rate in words will prevail.
- 19. When there is discrepancy between the unit rate and the total amount resulting from multiplying the unit rate by the quantity, the unit rate as quoted will govern.
- 20. The competent authority on behalf of President of India does not bind himself to accept the lowest or any other tender, and reserves to himself the authority to reject any or all of the tenders received without the assigning any reason. All tenders in which any of the prescribed conditions are not fulfilled or are incomplete in any respect are liable to be rejected.
- 21. The contractor whose tender is accepted will be required to furnish performance guarantee of 5% (Five Percent) of the tendered amount within the period specified in Schedule F. This guarantee shall be in the form of National Saving Certificate/ Government Securities / Fixed Deposit Receipts from any scheduled bank in favour of Executive Engineer, Southern Rivers Division, Central Water Commission payable at COIMBATORE. In case the contractor fails to deposit the said performance guarantee within the period as indicated in Schedule 'F' including the extended period if any, the Earnest Money deposited by the contractor shall be forfeited automatically without any notice to the contractor.
- 22. Canvassing whether directly or indirectly, in connection with tenders is strictly prohibited and tenders submitted by the contractors who resort to canvassing will be liable for rejection.
- 23. The competent authority on behalf of President of India reserves to himself the right of accepting the whole or any part of the tender and the tenderer shall be bound to perform the same at the rate quoted.
- 24. The contractor shall not be permitted to tender for works in the Division Office (responsible for award and execution of contracts) in which his near relative is posted as Divisional Accountant or as an officer in any capacity between the grades of Superintending Engineer and Assistant Engineer (both inclusive). He shall also intimate the name of the persons who are working with him in any capacity or are subsequently employed by him and who are near relatives to any gazetted officer in the Central Water Commission or in the Ministry of Water Resources, RD & GR, Government Of India. Any breach of this condition by the contractor would render him liable to be removed from the approved list of contractors of this department.
- 25. 2.5% of the gross amount every running bill as well as final bill less the

EMD amount shall be deducted, as security deposit. Security Deposit will be refunded after six (6) months from the date of issue of completion certificate of work.

- 26. No Engineer of Gazetted rank or other Gazetted Officer employed in Engineering or Administrative duties in an Engineering Department of the Government Of India is allowed to work as a contractor for a period of two years after his retirement from the Government Service, without the previous permission of the Government Of India in writing. This contract is liable to be cancelled if either the contractor or any of his employees is found any time to be such a person who had not obtained the permission of the Government Of India as aforesaid before submission of the tender or engagement in the contractors service
- 27. The tender for the works shall remain open for acceptance for a period of Ninety days from the date of opening of the tenders. If any tenderer withdraws his tender before the said period or makes any modifications in terms and conditions of the tender which are not acceptable to the department, then the Government shall, without prejudice to any right or remedy, be at liberty to forfeit the bid security as aforesaid.
- 28. This Notice Inviting Tender shall form a part of the contract document. The successful tenderer / Contractor, on acceptance of his tender by the Accepting Authority shall, within 7 days from the stipulated date of start of the work sign the contract consisting of:
  - a) The notice inviting tender, all the documents including additional conditions, specifications and drawings, if any, forming the tender as issued at the time of invitation of tender any acceptance thereof together with any correspondence leading thereto.
  - b) Standard C.P.W.D Form 7/8 If the tenderer fails to sign the agreement form within the stipulated period the bid security will be forfeite

Further, if I/we fail to commence work as specified, I/we agree that President of India or his successors in office shall without prejudice to any other right or remedy available in law, be at liberty to forfeit the said earnest money and the performance quarantee absolutely, otherwise the said earnest money shall be retained by him towards security deposit to execute all the works referred to in the tender documents upon the terms and conditions contained or referred to therein and to carry out such deviations as may be ordered, upto maximum of the percentage mentioned in Schedule 'F' and those in excess of that limit at the rates to be determined in accordance with the provision contained in Clause 12.2 and 12.3 of the tender form. Further, I/We agree that in case of forfeiture of earnest money or both Earnest Money & Performance Guarantee as aforesaid, I/We shall be debarred for participation in the retendering process of the work.

# PERFORMANCE GUARANTEE (CLAUSE - 1)

- (I) The contractor shall submit irrevocable PERFORMANCE GUARANTEE of (Five percent) of the tendered amount in addition to other deposits 5% mentioned elsewhere in the contract for his proper performance of the contract agreement, (notwithstanding and/or without prejudice to any other provisions in the contract) within 7 days of issue of letter of acceptance. This period can be further extended by the Engineer-in-charge upto a maximum period of 5 days on written request of the contractor stating the reason for delays in procuring the Performance Guarantee. This guarantee shall be in the form of National Saving Certificate/ Government Securities / Fixed Deposit Receipts from any scheduled bank in favour of Executive Engineer, Southern Rivers Division, Central Water Commission payable at COIMBATORE. In case a fixed deposit receipt of only Bank is furnished by the contractor to the Government as part of the performance guarantee and the Bank is unable to make payment against the said fixed deposit receipt, the loss caused thereby shall fall on the contractor and the contractor shall forthwith on demand furnish additional security to the Government to make good the deficit.
- (II) A letter of acceptance shall be issued in the first instance informing the successful tendered of the decision of the competent authority to accept his tender and the award letter shall be issued only after the Performance Guarantee in any of the prescribed form is received. In case of failure by the contractor to furnish the performance guarantee within the specified period, Government shall without prejudice to only other right or remedy available in law, be at liberty to forfeit the earnest money absolutely.
- (III) The Performance Guarantee shall be initially valid up to the stipulated date of completion plus 60 days beyond that. In case the time for completion of work gets enlarged, the contractor shall get the validity of Performance Guarantee extended to cover such enlarged time for completion of work. After recording of the completion certificate for the work by the competent authority, the performance guarantee shall be returned to the contractor, without any interest.
- (IV) The Engineer- in-charge shall not make a claim under the performance guarantee except for amounts to which the President of India is entitled under the contract (notwithstanding and / or without prejudice to only other provisions in the contract agreement) in the event of:-
- (a) Failure by the contractor to extend the validity of the Performance Guarantee as described herein above, in which event the Engineer-in-charge may claim the full amount of the Performance Guarantee.
- (b) Failure by the contractor to pay President of India any amount due, either as agreed by the contractor or determined under any of the Clauses /Conditions of the Agreement, within 30 days of the service of notice to this effect by Engineerin- char
- (V) In the event of the contract being determined or rescinded provisions of any of the clause / condition of the agreement, the Performance Guarantee shall stand forfeited in full and shall be absolutely at the disposal of the President of India.

#### RECOVERY OF SECURITY DEPOSIT (CLAUSE 1A)

The person/persons whose tender(s) may be accepted (hereinafter called the contractor) shall permit Government of the time of making any payment to him for work done under the contract to deduct 2.5% of the total bill amount less than the EMD amount as security deposit for a period of 6 months as defect liability. Such deductions will be made and held by Government by way of Security Deposit unless he/they has/have deposited the amount of Security at the rate mentioned above in cash or in the form of in the form of National Saving Certificate/ Government Securities / Fixed Deposit Receipts from any scheduled bank is furnished by the contractor to the Government as part of the security deposit and the Bank is unable to make payment against the said fixed deposit receipt, the loss caused thereby shall fall on the contractor and the contractor shall forthwith on demand furnish additional security to the Government to make good the deficit. All compensations or the other sums of money payable by the contractor under the terms of this contract may be deducted from, or paid by the sale of a sufficient part of his security deposit or from the interest arising there from, or from any sums which may be due to or may become due to the contractor by Government on any account whatsoever and in the event of his Security Deposit being reduced by reason of any such deductions or sale as aforesaid, the contractor shall within 10 days make good in cash or fixed deposit receipt tendered by the State Bank of India or by Scheduled Banks or Government Securities (if deposited for more than 12 months) endorsed in favour of the Engineer-in-charge, any sum or sums which may have been deducted from, or raised by sale of his security deposit or any part thereof. The security deposit shall be collected from the final bill of the contractor at the rates mentioned above and the Earnest Money if deposited at the time of tenders will be treated a part of the Security Deposit.

**NOTE 1:** Government papers tendered as security will be taken at 2.5% below its market price or at its face value, whichever is less. The market price of Government paper would be ascertained by the Divisional Officer at the time of collection of interest and the amount of interest to the extent of deficiency in value of the Government paper will be withheld if necessary.

**NOTE 2:** Government Securities will include all forms of Securities mentioned in rule No. 274 of the G.F. Rules except fidelity bond. This will be subject to the observance of the condition mentioned under the rule against each form of security.

NOTE 3: Note 1 & 2 above shall be applicable for both Clause 1 & 1A

# SPECIAL CONDITIONS FOR CONTRACT

- The contractor shall make his own arrangements for obtaining electricity if required and make necessary payments directly to the department concerned.
- Some restrictions may be imposed for the movement of labour, materials etc., the contractor shall be bound to follow all such restrictions/instructions and nothing extra shall be payable on this account.
- The work will be carried out as per instructions of the Engineer-in-charge at the site and nothing extra will be paid on this account.
- 4. The work will be carried out in the manner complying in all respects with the requirements of relevant by-laws of the local under the jurisdiction of which the work is to be executed or as directed by the Engineer-in-charge and nothing extra will be paid on this account.
- 5. Testing of Materials Samples of various materials required for testing shall be provided free of charge by the contractor. Testing charges, if any, unless otherwise provided, shall be borne by the Department. All other expenditure required to be incurred for taking the samples, conveyance, packing etc. shall be borne by the contractor himself.
- The contractor shall bear all incidental charges for cartage, storage, and safe custody of the materials.
- For the purpose of recording measurements and preparing running account bills, the abbreviated nomenclature indicated in the publications Abbreviated nomenclature of item of DSR 1985 (building) shall be accepted.
- 8. In the case of items for which abbreviated nomenclature is not available in the above cited publication and also in case of extra and substituted items of works for which abbreviate nomenclature is not provided in the agreement the full nomenclature of items shall be reproduced in the measurement books and bill forms for running account bill. The full nomenclature of the items shall be adopted in preparing abstract of final bill from in the measurement book and also in the bill form for final bill.
- The work shall be executed and measured as per metric dimensions given in the schedule of quantities, drawings etc.
- Copy of PAN Card should be enclosed along with the tender. Non-Submission of these would result in rejection of Tender.
- 11. Time completion for the work is allowed for 45 Days from the date of the written order to commence the work. No rate Escalation is applicable in this contract.
- 12. Whenever any reference to any Indian Standard specification occurs in the documents relating to this contract the same shall be inclusive of all amendments issued thereto or revisions thereof, if any, up to the date of receipt of tenders.

- 13. Unless otherwise specified in the schedule of quantities the rates for all items of the work shall be considered as inclusive of pumping out or bailing out-water if required for which no extra payment will be made. This will include water encountered from any source such as rains, floods, sub-soil water table being high due to any other cause whatsoever.
- 14. The Contractor will have to work according to the program of work decided by the Engineer-in-charge.
- 15. The contractor shall take instructions from the Engineer-in-charge for stacking of materials any place. No excavated earth or building materials shall be stacked on areas where other buildings, roads, services of compound walls are to be constructed.
- 16. Any disputes arising on the contract will be referred to SE, C&SRC, CWC, Bengaluru and the decision of SE, C&SRC, CWC, Bengaluru will be final and binding to the bidder.
- 17. The payment will be made on the basis of actual measurement.
- 18. GST or any other tax leviable on materials in respect of this Contract shall be payable by the contractor. The department will not entertain any claim what so ever this respect. However Income tax / educational cess shall be deducted from the bill amount as per prevailing Government of India rules and regulations.
- 19. The work is to be carried out in a workman like manner and in accordance with the plan supplied. However, the contractor shall carry out the deviation over the plan supplied if desired by the Engineer in charge.
- 20. The Department shall not provide any store accommodation for the stores brought by the contractor or issued by the Department.
- 21. Executive Engineer, SRD,CWC, Coimbatore reserves the right of deciding any matter arising during the tenure of the contract, but not covered specifically by the conditions mentioned in the tender and that decision of the corporation in this regard shall be final and binding on the contractor.
- 22. Damage to the building during execution of work shall be made good by the contractor matching with the surrounding surface, otherwise the same shall be got done at the cost of working contractor.
- 23. Without prejudice to any of the rights or remedies under this contract if the Contractor dies, the Executive Engineer on behalf of the President of India shall have the option of terminating the contract without compensation to the Contractor.
- 24. The undersigned reserves the right to accept/reject all or any of the tender without assigning any reasons.
- 25. Tender Document with each page duly signed by the Bidder as token of acceptance of terms and conditions shall be enclosed along with tender.

26. Tender should be submitted in a sealed cover superscribed as "Fabrication of RCC gauge post for the sites under SRD, CWC, Coimbatore" with "Tender Number" and "due date of opening" etc.


