ORDER

In supersession of this Department's order No A-36016/1/2014-Admn dated 29th June, 2018, sanction of the competent authority is hereby conveyed in terms of Rule 13 & Rule 21 of Delegation of Financial Power Rules (DFPR) 1978, (as amended from time to time), for delegation of financial powers in respect of the items indicated in the Annexure of this order, for exercise of such powers by Chairman, CWC, in respect of the schemes, subject to the quantum of delegation and conditions indicated in respect of each item as shown in the annexure.

2. Chairman, CWC will exercise financial powers in accordance with this Order, subject to limits contained herein and procedure laid down in GFR 2017, Manual for procurement and other instructions issued by the Ministry of Finance, from time to time on the subject of Contract/Procurement etc.
3. The delegation of powers prescribed in this orders will supersede all previous orders in the matter.
4. Consequently, the other officers of CWC shall exercise the financial powers delegated to them vide this Department's order no A-36013/3/2017-E.I dated 12.02.20218 only in respect of the Schemes.
5. Chairman, CWC will exercise the financial powers in consultation with Director (Finance), CWC or Financial Adviser of the Department, as the case may be.
6. The financial powers delegated to the CWC field set-ups vide this Department's order no A-36013/3/2017-E.I dated 12.02.20218 will henceforth be

exercised in consultation with Director (Finance), CWC or any other officer authorized by him instead of the designated Finance Officers.

7. This issues with the concurrence of Integrated Finance Division of this Department vide their Dy. Number 81/IFD/2021-22, dated 06.05.2021 and approval of Secretary, DoWR.
