I am directed to say that you have been allocated Central Water Engineering (Group-A) Service (CWES) on the basis of result of the Engineering Services Examination, 2023 held by Union Public Service Commission. You are hereby offered appointment in the grade of Assistant Director/Assistant Executive Engineer in the Junior Time Scale of Central Water Engineering (Group-A) Service on the following term and conditions:-

- i. This offer of appointment is **PROVISIONAL** and subjected to Character & Antecedents/Police Verification.
- ii. Your pay will be fixed according to rules, in the level 10 of Pay matrix (Rs. 56100-177500/-) per month and you will also be entitled to draw such allowances as admissible to the Central Government Offices of your grade from time to time.
- iii. The appointment is temporary but likely to continue.
- iv. You will be on probation for a period of two years from the date of your assumption of charge of the post in the JTS grade, which may be extended, if necessary.
- v. The appointment can be terminated in accordance with provisions contained in the Central Civil Services (Temporary Services) Rules, 1965, as amended from time to time.
- vi. The appointment carries with it the liability to serve anywhere in India or outside and in any Defence Service, or post connected with the defence of India, for a period of not less than four years including the period spent on training provided that:
 - (a) You shall not be required to serve as aforesaid after the expiry of ten years from the date of your appointment in the Central Water Engineering (Gr. A) Service.
 - (b) You shall not ordinarily be required to serve as aforesaid after attaining the age of forty years.

- vii. You will be required to subscribe to the Defined Contribution Pension Scheme introduced vide Government of India, Ministry of Finance, Department of Economic Affairs Notification dated 22.12.2003, as amended from time to time.
- viii. You will be eligible for the benefits admissible under the Central Government Employees Group Insurance Scheme, 1980 on the terms and conditions contained therein.
- ix. Other conditions of the Service will be governed by the Central Water Engineering (Gr. A) Service Rules, 2013 as amended from time to time and other relevant rules and orders applicable to Central Government servants from time to time.
- 2. The appointment will further be subjected to the following conditions:
 - i. A person shall not be eligible for appointment if he has entered into or contracted a marriage with a person having a spouse living, or if he having a spouse living has entered into, or contracted a marriage with any person provided that the Central Government may if satisfied that such marriage is permissible under the personal law applicable to you and the other party to the marriage and that there are other grounds for so doing grant exemption from the operation of this rule.
 - ii. You will have to take an oath of allegiance/faithfulness to the constitution of India or make solemn affirmation to that effect, if not already done.
 - iii. The appointment is provisional subject to the caste/tribe certificates being verified through the proper channels and if the verification reveals that claim to belong to Scheduled Castes/Schedules Tribes/OBC, as the case may be, is false, the services will be terminated forthwith without prejudice to such further action as may be taken under the provisions of the Indian penal Code for production of false certificate.
