- 2.3 The sealed Master Envelope containing the Envelope-A & B, shall also be super-scribed with the name of Quotation with due date of submission and bearing name & address of the Bidders, to enable the bid to be returned unopened in case it is declared as 'late receipt' or 'rejected'.
- 2.4 The quotations shall either be sent by registered/speed post/courier or delivered in-person. The responsibility for ensuring that the Quotations are delivered in time, would vest with the Bidder. The Quotations to be delivered in person, shall drop the sealed Quotation into the Tender Box provided in the office of EE, SID, CWC, Gangtok on or before the due date of its submission. The SID, CWC, Gangtok shall not be responsible if the bids are delivered somewhere else instead of above specified location.

#### Terms & Conditions:-

- 1. The quoted rates shall be valid for acceptance for a period of 30 days from the date of opening of Technical Bid. If any bidder withdraws his / her bid before the said period, this office shall without prejudice to any other right or remedy, be at liberty to forfeit the Bid Security absolutely.
- 2. If the Highest rates quoted by two parties are the same, the Bid shall be cancelled.
- 3. The intending bidders are requested to visit the CPP portal (<a href="https://eprocure.gov.in/epublish/app">https://eprocure.gov.in/epublish/app</a>) or CWC website (<a href="https://cwc.gov.in/">https://cwc.gov.in/</a>) mentioned above to download the Notice Inviting Quotation copy. EMD of the unsuccessful bidders will be returned to them at the earliest after expiry of the final bid validity and latest on or before the 30th day after the award of the contract. The EMD will be forfeited if the bidder withdraws or amends impairs or derogates from the tender in any respect within the validity period of their tender.

- 9. SID, CWC, Gangtok will not be liable whatsoever for the safe custody, protection, or preservation after a sale has been confirmed. Any claim for damage done by the way of theft, fire or any other unforeseen calamity after realizing full payment against the Unserviceable Material/items will not be entertained in toto.
- 10. The Unserviceable Material/ items is to be lifted up within 10 days on the issue of Release Order on making full payment (The successful bidder will have to deposit the remaining amount of bid within 3(Three) days of the receipt of notice of the acceptance of the bid) in the form of an Account Payee Demand Draft (DD) or through RTGS/ NEFT payment in favour of Executive Engineer, SID, Central Water Commission, Gangtok. Otherwise, the EMD money deposited will stand forfeited and the offer shall be awarded to the next eligible bidder.
- 11. The successful bidder must lift all the Unserviceable Material/items at his own cost. Any use of additional services required for removal of the materials being sold on receipt of Sale Order will be borne by the bidder. If the goods are not removed within 30 days of having paid the amount, SID, CWC, Gangtok will have the right to dispose of such goods in any manner they like and the buyer will have no right to any compensation. The money paid by the successful Tenderer will not be refundable for un-cleared goods.
- 12. In case the buyer wishes to take Delivery of the Materials purchased, through a Representative, he must authorize the letter clearly by Name, by a letter of authority, with duly attested specimen signature to the Representative. SID, CWC, Gangtok, however, does not undertake any responsibility for the identity of the Representative and for wrong delivery.
- 13. The lifting of items must be done during working office house between 10 AM to 4 PM.
- 14. No selection or sorting whatsoever of the goods will be allowed. The entire lot should be
- 15. Any un-cleared or un-noticed materials left over by the successful bidder within the premises cannot be claimed later.
- 16.
