I am directed to refer to the Commission's letter of even number dated 16th March, 2021 wherein it was stated that the provisions of the Model Code of Conduct have come into force with immediate effect in the district(s) in which the whole or any part of the Parliamentary/Assembly Constituency going for bye-election is comprised. In the case of bye-elections the Model Code of Conduct remains in force till formal declaration of the result of the bye-election by the Returning Officer concerned.

In view of the rising number of COVID cases in recent weeks, various State Governments are 2. making references to the Commission seeking approval for holding meetings in this regard. Taking the above request in consideration, the Commission has decided to permit COVID related meetings and tours in Andhra Pradesh, Mizoram, Gujarat, Nagaland, Jharkhand, Odisha, Karnataka, Rajasthan, Madhya Pradesh, Telangana, Maharashtra, Uttarakhand, where polling is already over, subject to the

usual Model Code of Conduct conditions.
