### CIRCULAR

Sub: Inter-Ministry Carrom Tournament 2022-23.

On the occasion of 75 years of independence of India, Government of India is celebrating Azadi ka Amrit Mahostav. The objective of the Mahostav is to enhance interaction and promote mutual understanding between people of different States and Union Territories by conducting activities in the field of language and culture.

- 2. To commemorate the glorious history of Indian people and culture, Central Civil Services Cultural and Sports Board (CCSCSB) is organizing Inter-Ministry Carrom Tournament 2022-23 from 30<sup>th</sup> August 2022 to 7<sup>th</sup> September 2022 (except Sunday i.e. 4<sup>th</sup> September 2022) at Grih Kalyan Kendra, Raja Bazar Community Centre, Gole Market, New Delhi. The Ministry/ Department desirous to participate in the tournament may send their entries in the prescribed proforma along with the entry fee. The entry fee for the events is ₹75/- for Individual and₹150/- each for Doubles and Team Championship. Last date for submission of entries in the Office of Secretary, Central Civil Services Cultural & Sports Board, Room No 361, 'B' Wing, 3<sup>rd</sup> Floor, Lok Nayak Bhavan, Khan Market, New Delhi 110003 is 25<sup>th</sup> August, 2022.
- 3. Kindly note that there will be only one team from each Ministry. The Ministry may include in their team persons working in the attached and subordinate offices located at Delhi/ New Delhi. All teams/ Individuals would be represented as a part of Ministry's Team only. Central government autonomous organization like UPSC, Election Commission, C&AG's Office, Lok Sabha Secretariat, Rajya Sabha Secretariat, Cabinet Secretariat, PMO etc. can sent independent teams. The entries are to be sent through the Welfare Offices of the Ministry concerned.
- 4. The following categories of employees are not eligible for participation in this competition:-

- (a) Uniformed personnel in Defence Services/Para Military Organisations/Central Police Organisation/Police/RPF/CISF/BSF/ITBP/NSG etc.
- (b) Employees of Autonomous bodies/Undertakings/Public Sector Banks/Corporations even though administratively controlled by the Central Ministries.
- (c) Casual/Daily wages workers.
- (d) Employees attached to offices on temporary duty.

In case, at any time, it is found that a player included in the team is not eligible, the team would stand automatically disqualified from the tournament.

5. No entry will be accepted unless accompanied with fee. The entry should be sent in the prescribed proforma (Annexure I) duly signed by the Welfare Officer concerned and should reach on or before the last date mentioned above. The entry fee should be deposited in CCSCSB account as per details given below:-

- 6. The competition will be held in the following events:-
  - (i) Men's Team Championship (06 players + 01 Manager). Winners and runners-up of team championship will also be awarded cash prize of \$10,000/\$ and \$7000/\$ respectively.
  - (ii) Men's Singles
  - (iii) Men's Doubles
  - (iv) Women's Singles
  - (v) Women's Doubles
  - (vi) Men's Veteran Singles

- 7. The draw will be held at 11 AM on 26<sup>th</sup> August, 2022 at Grih Kalyan Kendra, Raja Bazar Community Centre, Gole Market, New Delhi. The detailed programme along with copy of Draw/ time Schedule will be given to the Managers/ Captains of the teams at the venue of the Tournament.
- 8. The rules and regulations governing the eligibility conditions for participation, etc. in the Inter-Ministry Tournament are available on the website of the Department of Personnel & Training (<a href="https://dopt.gov.in/about-us/wings-or-division-in-dopt/welfare-divisons">https://dopt.gov.in/about-us/wings-or-division-in-dopt/welfare-divisons</a>).
- 9. Referees'/Umpires' decision shall be final and binding on the competing teams/players.
- 10. Any information regarding change in dates/venue/cancellation etc. about the Tournament will be available on our website i.e. <a href="www.dopt.gov.in">www.dopt.gov.in</a>. All participants teams are, therefore, requested to check the details of the tournament about any possible change.
- 11. The general instructions/guidelines of COVID-19 issued by Central/State Govt. from time to time are to be strictly followed by all players and supporting staff during the competition. If it is found that Covid appropriate behaviour is not followed by any player/official in the tournament he/she shall be liable to be debarred from the tournament.

#### **OFFICE MEMORANDUM**

Subject: Procedure to be followed by employees of Central Water Commission while participating in various sports activities conducted by Central Civil Services Cultural & Sports Board (CCSCSB) under DOP&T.

In the recent past, it has come to notice that an employee of Central Water Commission, who had already been deployed for Election Duty had applied for Special Casual Leave for participating in sports activities during that period, which has resulted in an embarrassing situation. To avoid any such untoward eventuality and that the important duties such as Electon Duty, CBI duty or any other important items of work allotted by Controlling officer are not adversely affected, the following procedure is to be adhered to while the concerned employee ,who has been nominated by CCSCSB or any other body under DOP&T or otherwise to participate in any sports activity, cultural activity etc:-

- i. "No Objection Certificate" from his controlling officer in which he is performing his duty. In that No Objection, it should be clearly indicated by the controlling officer that he has not been nominated for any mandatory duties like Election Duty, CBI duty or otherwise and the work of that concerned section/directorate is not being hampered if the said employee remains absent during the period in which he is participating in any sports related activities;
- ii. After the concerned controlling officer forwards the application, it will be routed to Sports Secretary, CWC who will ensure that the concerned official/officers (players) will maintain the discipline and punctuality of players by taking regular attendance from the Coach/Training/Practice Camp. Erring employees will be debarred from representing Central Water Commission, if it is found that the player remains absent from training/office without intimating Central Water Commission or giving valid reason to in-charge/Manager/Captain/Sports Secretary, his practice orders will be cancelled immediately and appropriate disciplinary action will be taken against him. Therefore, Sports Secretary, CWC should give an Undertaking in this regard to CWC before the concerned player/official proceeds for participating in any sports activity.
- (iii) Further reasonable time should be given to Estt-IX Section of CWC for issuing office order etc. after adhering to the procedure as indicated in

points (i) and (ii) above.
