- 3. Quotations shall be submitted in prescribed pro-forma (Annexure-I) enclosed with this NIQ in letter pad of the Agency through post or directly in the Tender Box of office of the Executive Engineer.
- 4. On behalf of President of India, the undersigned reserves the right to reject any or all the quotations without assigning any reasons thereof.
- 5. Rates quoted shall be valid for period up to **60 days** from the date of opening of quotation for acceptance.

- 7. All cuttings / Over writing should be countersigned /initialed.
- 8. Taxes as applicable will be deducted at the source from the bill at the time of payment.
- 9. The rates quoted should indicate all taxes including GST (18%) and no claim are accepted for

these charges/taxes separately in other forms.

- Canvassing in any form whether directly or indirectly is strictly prohibited. 10.
- The rate & amount shall be quoted in figure as well as in words.
