#### **OFFICE MEMORANDUM**

Subject: Procedure to be followed by employees of Central Water Commission while participating in various sports activities conducted by Central Civil Services Cultural & Sports Board (CCSCSB) under DOP&T.

In the recent past, it has come to notice that an employee of Central Water Commission, who had already been deployed for Election Duty had applied for Special Casual Leave for participating in sports activities during that period, which has resulted in an embarrassing situation. To avoid any such untoward eventuality and that the important duties such as Electon Duty, CBI duty or any other important items of work allotted by Controlling officer are not adversely affected, the following procedure is to be adhered to while the concerned employee ,who has been nominated by CCSCSB or any other body under DOP&T or otherwise to participate in any sports activity, cultural activity etc:-

- i. "No Objection Certificate" from his controlling officer in which he is performing his duty. In that No Objection, it should be clearly indicated by the controlling officer that he has not been nominated for any mandatory duties like Election Duty, CBI duty or otherwise and the work of that concerned section/directorate is not being hampered if the said employee remains absent during the period in which he is participating in any sports related activities;
- ii. After the concerned controlling officer forwards the application, it will be routed to Sports Secretary, CWC who will ensure that the concerned official/officers (players) will maintain the discipline and punctuality of players by taking regular attendance from the Coach/Training/Practice Camp. Erring employees will be debarred from representing Central Water Commission, if it is found that the player remains absent from training/office without intimating Central Water Commission or giving valid reason to in-charge/Manager/Captain/Sports Secretary, his practice orders will be cancelled immediately and appropriate disciplinary action will be taken against him. Therefore, Sports Secretary, CWC should give an Undertaking in this regard to CWC before the concerned player/official proceeds for participating in any sports activity.
- (iii) Further reasonable time should be given to Estt-IX Section of CWC for issuing office order etc. after adhering to the procedure as indicated in

points (i) and (ii) above.

#### CIRCULAR

The objective of the Mahotsav is to enhance interaction and promote mutual understanding between people of different States and Union Territories by conducting activities in the field of language and culture.

- 2. To commemorate the glorious history of Indian people and culture, Central Civil Services Cultural and Sports Board (CCSCSB) is organizing 1<sup>st</sup>Inter-Ministry (Men and Women) Yogasana Competition 2022-23 on 29.3.2023 at CSOI Auditorium, Chankya Puri, New Delhi from 10 AM onwards. The objective of the Competition is to encourage the practice of Yogasana and help to promote physical and mental well being of Central Government employees. As the Competition is being held for the first time, no age category is specified and only traditional and simple Asanas are included which are easy to perform.
- 3. Minimum 10 entries in Men and Women categories are required to conduct the tournament.
- 4. The participants desirous to participate in the Competition may send their entries in the prescribed proforma along with the entry fee of Rs. 100/-. Last date for submission of entries in the Central Civil Services Cultural & Sports Board office Room No 361, 'B' Wing, Lok Nayak Bhavan, Khan Market, New Delhi 110003 is 28.3.2023.
- 5. The guidelines for organization of 1<sup>st</sup> Inter-Ministry Yogasana Competition is attached at **Annexure-I**
- 6. Central government autonomous organizations like UPSC, Election Commission, C&AG's Office, Lok Sabha Secretariat, Rajya Sabha Secretariat, Cabinet Secretariat, PMO etc. may send independent entries. The entries are to be sent through the Welfare Officer of the Ministry concerned.
- 7. The following categories of employees are not eligible for participation in this competition:-
  - (a) Uniformed personnel in Defence Services/Para Military Organisations/Central Police Organisations/Police/RPF/CISF/BSF/ITBP/NSG etc.

- (b) Employees of Autonomous bodies/Undertakings/Public Sector Banks/ Corporations even though administratively controlled by the Central Ministries.
- (c) Casual/Daily wages workers.
- (d) Employees attached to offices on temporary duty.

In case, at any time, it is found that a player is not eligible, he/she will stand automatically disqualified from the Competition.

8. No entry will be accepted unless accompanied with fee. The entry should be sent in the prescribed proforma (Annexure II) duly signed by the Welfare Officer concerned and should reach on or before the last date 28.3.2023, The entry fee should be deposited in CCSCSB account as per details given below:-






