

**OFFICE ORDER**

In compliance to DoPT's Order No. 9/2/2003-CS.II dated 20.04.2005, DoWR, RD&GR, Mo Jal Shakti vide their order No. 6/4/2005-Admn. dated 12.7.2019 has revised the sanctioned strength of *Junior Secretariat Assistant (JSA)* post of CSCS cadre in Central Water Commission to 16. Accordingly, the sanctioned strength of *Junior Secretariat Assistants (JSA)* of CSCS Cadre in this Commission has been redistributed as follows :


\*- At present, there is one incumbent, in the grade of JSA, posted at M&A Dte, CWC, Ranchi. However, with the relieving/transfer of this incumbent (presently posted at M&A Dte, CWC, Ranchi), the JSA post at M&A Dte, CWC will automatically shift to HRM Wing of CWC since DoWR, RD&GR, Mo Jal Shakti vide their letter no. A-22014/1/2015-Admn. dated 11.7.2017 had stated that, as per the policy of DoPT, all posts belonging to CSS/CSCS/CSSS cadre are located at Delhi only, unless such posts are otherwise notified by the DoPT themselves and this Ministry including CWC has no competence for posting of a CSS/CSSS/CSCS officer earmarked for Delhi, to any other places, without approval of the DoPT.


