Applicant is requested to specify the same. The information asked for w.r.t. **Point no. 7 i.e. Minutes of meeting with WAPCOS on dated 24.10.2017** is not available in WP&P Wing of CWC.

It is further inform that the information in hard copy w.r.t. point no 2, 3 & 6 is available in WP&P Wing of CWC having 22 pages, can be made available after payment of relevant fee as prescribed under RTI Act, 2005 i.e Rs 44/- for Xeroxing charges (Rs forty four only). Amount shall be payable in the name of Pay and Accounts Office, CWC, New Delhi by postal order.

The applicant is also hereby informed that if he is willing to avail the facility for inspection of records, he may avail the facility giving prior intimation for inspection of related records available under WP&P Wing of CWC as far as CPIO WP&P Wing is concerned.

Fee for providing information under sub-section (4) of Section 4 and sub-sections (I) and (5) of Section 7 of the Act shall be charged, no fee for inspection of records for the first hour of inspection and a fee of rupees 5 for each subsequent hour or fraction thereof. On selection of information, information will be provided by charging fee as prescribed under RTI Act.
