

**Minutes of Meeting for finalization of proposed EFC of DWRIS scheme for the period 2021-26 in light of comments of Niti Aayog and Department of Expenditure**

A meeting/presentation on the proposed EFC (2021-26) under DWRIS scheme was held on 16.07.2021 at 11:00 Hrs under the chairmanship of Chairman, CWC in the Committee Room, Second Floor, Sewa Bhawan, R K Puram, New Delhi. The list of participants is at Annxure-1.

At the outset Chairman, CWC welcome all the participant and briefed about the background. Thereafter, Director, RDC-1 made the presentation on the EFC. During the presentation discussion took place regarding component wise requirement projected in the proposed EFC and its justification vis to vis expenditure made during past years. The summary record of the discussion is given below:

1. For continuing components/items the provision in the proposed EFC may be kept as per DoE norms i.e. 5.5 times of expenditure of 2019-20 in that components/items.
2. Provision for new components/items may be kept as separate so that proper justification can be given.
3. Since the case for approval of IWRM studies is pending in the Ministry and no firm reply has been received from Ministry. Therefore, the provision for the IWRM study may be kept as it is.
4. With regard to provisions of other components, there is more or less agreement on the reduction proposed by the Director, RDC-1. However, the same will be communicated by Director, RDC-1 to respective nodal directorate of various components and respective nodal directorate will finalized the same item wise within two days.
5. With regard to Integrated Reservoir Operation component, it was decided by Chairman, CWC that nodal unit for the same will be Reservoir Operation Directorate. It was also decided that a separate meeting in this regard may be called by Reservoir Operation Directorate within a week time to finalize the various time line and other modalities for taking up this work immediately.
6. It was decided that now onward, the record of component wise expenditure may be kept by RMCD Dte.
7. Director, Training informed the various work undertaken to modernize the library system including implementation of e-Granthalaya. Chairman, CWC decided that all old DPR, TAC notes etc. may be digitized immediately and same may be brought under e-Granthalaya.

Meeting ended with thanks to chair.
