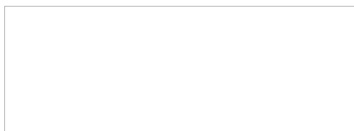
2. It is requested to furnish the following information for onward submission to DoLA :-

Background of LIMBS Ver.2

LIMBS ver. 1.0 is being used by 56 ministries of Government of India, was developed on .NET platform and SQL Server which are proprietary product. With the advancement in technology, a need is felt to upgrade the application with better features, enhanced speed, more security features and latest technology. Accordingly, as per directions of the Cabinet Secretariat, NIC is developing a modified version of LIMBS i.e., LIMBS Ver.2. This version will be overhauled with the use of Open Source technologies using Coordinator framework of PHP to enhance the security of the system, improve the efficiency of the system.

Additional Features of LIMBS Ver.2-

1. It will be more user-friendly and will be on an open platform. *Centralized by Deptt?*
2. It will have robust and flexible platform. *To be migrated data to new version.*
3. Since it will be more scalable, thus more features/modules can be added in future. *— D Hand to get in touch with NIC, DoLA*
4. Dashboard- User-friendly dashboard which will ease user in visualizing complete court case details at single place.
5. Integration of data with all the Courts.
6. Integration with other court websites through APIs and inclusion of CNR no fields for the High Courts in the new version of LIMBS.
7. In Ver.2, advocates/counsels will register their claims with unique computer generated number, which alone to be processed by all the ministries for settling their claims.

(ii). If this exercise has not been initiated then tentative date may be indicated by which, it shall be completed.

2. The SWC utility has been developed in LIMBS to monitor delay in timelines of filing of SLPs/Appeal. This utility has been developed to bring all the stake holders viz., Ministries, DoLA & CAS on single platform. It is requested to direct the concerned officers to initiate SLPs/Appeals through LIMBS platform only, as DoLA will not accept any physical file for advice of SLP/Appeal for SC unless the details are entered in SWC.
3. Rechecking/Verification of data by all ministries/departments after complete migration to Ver.2.
4. In Ver.2, advocates/counsels will register their claims with unique computer generated number, which alone should be processed by all the ministries for settling their claims.


